The Fife Council in exercise of the powers conferred on them under section 84(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with section 124 of and Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Strathkinness High Road, St Andrews - 40mph Speed Limit) Order 2026" and shall come into operation on the _____ day of _____.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. Drawing number TRO26_27 showing the length of road affected by this Order delineated in red is annexed and signed as relative hereto.
