FVAWP Training Framework



Introduction

Covid-19 impacted on all our lives, none more so than women and children living with domestic abuse, other forms of violence against women and those recovering from trauma. Training has never been more important to ensure staff are equipped to support women and children impacted by forms of violence against women. Fife Violence Against Women Partnership (FVAWP) has developed this framework to address this. It brings together all the current training co-ordinated or recommended by FVAWP and some areas of work that FVAWP hopes to develop in the future.

There are a range of learning opportunities, delivered through a combination of reading materials, e-learning and webinars. The courses are relevant for a range of staff across statutory and third sectors, building knowledge, confidence and skills to respond appropriately to individuals affected by gender-based violence.

The framework will be adapted to meet service needs and as training courses are developed. FVAWP Training Framework is based on Welsh model¹.

Most of the training is free, some are run by FVAWP staff and others by partners from both voluntary and statutory sectors.

Training Levels

There are 4 levels identified. Some training has prerequisite conditions and seminars will assume this knowledge. For example, to participate in Domestic Abuse and the Protection of Children you MUST have previously completed Domestic Abuse Awareness Raising Tool (DAART).

Context

Violence against women and girls, in any form, has no place in our vision for a safe, strong, successful Scotland. It damages health and wellbeing, limits freedom and potential, and is a violation of the most fundamental human rights.

Equally Safe

Violence against women continues to cause harm and indignity to significant numbers of women and children living in Fife including emotional, psychological, sexual & physical abuse, coercion and constraint. Fife Violence Against Women Partnership is the local mechanism to co-ordinate activity to contribute to ending violence against women and its detrimental impact.

Violence Against Women Definition

Fife adopts the definition used in *Equally Safe - Scotland's strategy for preventing and eradicating violence against women and girls* as encompassing (but not limited to):²

- physical, sexual and psychological violence occurring in the family (including children and young people), within the general community or in institutions, including domestic abuse, rape, and incest;
- sexual harassment, bullying and intimidation in any public or private space, including work;
- commercial sexual exploitation, including prostitution, lap dancing, stripping, pornography and trafficking;
- child sexual abuse, including familial sexual abuse, child sexual exploitation and online abuse;
- so called 'honour based' violence, including dowry related violence, female genital mutilation, forced and child marriages, and 'honour' crimes.

Women and girls are at increased risk of violence and abuse because they are female. Our shared understanding recognises that violence against women has a significant impact on children and young people's lives. This includes children and young people

who are directly or indirectly harmed through domestic abuse of their mother, and there is evidence of links between domestic abuse and emotional, physical and sexual abuse of children. The safety of children is closely linked to the safety of the adult victim.

To participate the Domestic Abuse focussed Level 2 training courses candidates must have completed basic Domestic Abuse Awareness Raising Tool training within the last 18-24 months.
