# **Civic Business Bulletin**

## Former Councillor David Arnott

Former councillor David Arnott sadly passed away recently at the age of 81. David moved to Fife to work for Dunfermline District Council where he was Deputy Director of Sports & Leisure Services before later taking up the role of Director.

He retired around 1996 and was elected as Labour councillor for the Dalgety Bay and Hillend ward in 1999 and again in 2003. His particular interest was anything that came under leisure and recreation and one of his key contributions in Dunfermline was the half marathon. He retired as a councillor in 2007.

## Chartered Institute of Housing Team of the Year

At the Scottish Housing Awards (2023) run by Chartered Institute of Housing at the Radison Blu hotel in Glasgow, the Housing Team of the Year title went to Fife Council's 'Housing Access Team'.

The team were recognised for their contribution to organising and coordinating the Normalisation project, in collaboration with partners from other services within Fife Council and Fife Housing Register Partners. The Project was created following a Sheriff Court Judgement which meant that 636 statutory temporary tenancies were legally secure tenancies leaving the local authority with no temporary accommodation and at risk of significantly breaching statutory duty. The team created and implemented a 12 month people-led plan, to 'normalise' tenancies and rebuild temporary accommodation, completing this in August 2023.

## Equally Safe at Work Accreditation

Fife Council has successfully achieved bronze accreditation on the Equally Safe at Work employer programme.

Close the Gap have recognised the Council's commitment to women's labour market equality as a sector leader on gender equality in local government.

Close the Gap, Scotland's expert policy advocacy organisation working on women's labour market participation, developed Equally Safe at Work as an innovative employer accreditation programme designed to support employers in the public and third sector to prevent violence against women (VAW) and advance gender equality at work.

## Swimming Provider of the Year

Fife Sports and Leisure Trust won Swimming Provider of the Year for Learn to Swim scheme at the recent Scottish Swimming Awards Ceremony.

## **COSLA Excellence Awards**

Building Skills Together, which is a new Scots Refugee Integration Delivery project led by Dundee City Council in conjunction with Fife and Clackmannanshire Councils and WEA Scotland, won a COSLA Excellence Award at the recent ceremony as part of the COSLA conference.

## Paths for All Volunteer Awards - Bums Off Seats

Claire Henderson won the Health Walk Volunteer of the Year Award 2023 at these recent awards for her volunteering in supporting physical activity through walking.

## **Communities and Neighbourhoods**

Communities and Neighbourhoods Service volunteering provision awarded the 'CLD Standards Council (Scotland) Standard Mark' in relation to volunteering provision.

## Showmen's Guild

Fife Council has been awarded a certificate of appreciation by the Showmen's Guild of Great Britian, Scottish Section. The award was presented at the Guild's annual luncheon in Glasgow in recognition of the Council's outstanding service to the members and their families.

In expressing his appreciation, the Chairman stated that the support given by Fife Council over a period of many years is a leading example of the kind of relationship that they hope to build with other Scottish local authorities.

## **Civic Events**

On 23rd November we held a small ceremony to award the British Empire Medal to Dick Campbell for services to football and his community. The medal was presented by Robert Balfour, Lord-Lieutenant of Fife, with Deputy Lieutenant Jim Leggatt, the Provost and members of Dick's family in attendance.

On 1st December we hosted a concert at the Carnegie Hall as part of the Poppyscotland Band Tour. The Band of the Royal Regiment of Scotland is working together with Poppyscotland to perform in venues across Scotland to raise funds and awareness of the work they do to support our Armed Forces communities. We provided a civic reception prior to the concert.

Dunfermline has been selected to host the Scottish Carol Concert this year which is linked to the annual carol concert hosted by HRH Princess of Wales at Westminster Abbey. It is very much about the community of Fife and it is fitting that our City was selected at this time. The concert will be held on Friday 8th December in Dunfermline Abbey and is a ticketed event.

## 97. NOTICE OF MOTIONS

The Council considered a report by the Head of Legal and Democratic Services requiring the Council to consider motions submitted in terms of Standing Order No. 10.

#### Motion 1

Councillor Boubaker-Calder, seconded by Councillor Calder, moved as follows:-

**School Crossing Patrol Officers** 

"Council notes:

- (1) The importance of school crossing patrol officers (Lollipop people) in ensuring the safety of school pupils walking to school.
- (2) Council further notes the health and environmental benefits of active travel to schools and that school crossing patrol guards can help with encouraging this.
- (3) The number of school crossing patrol guards in Fife has reduced from 76 in the 2015-16 session to 56 in 2022-23.

## Council requests:

A member-led task and finish group be set up by the appropriate scrutiny committee to investigate the reasons for the long-term reduction in school crossing patrol guards, what work is being done to recruit them and what is being done to mitigate the effect of the reduction, in particular with ensuring the safety of pupils using active travel to travel to schools and to seek best practice from elsewhere."

## **Decision**

The Council agreed the motion unanimously.

## Motion 2

Councillor Vettraino, seconded by Councillor Wilson, moved as follows:-

"Council notes:

- that Network Rail, while redeveloping the Thornton to Leven rail-link, and with insufficient consultation with local communities, has already closed or intends to close the crossing routes known as Doubledykes, Waulksmill and Tullybreck;
- the Right of Way at Doubledykes was extinguished by the British Railways Order Confirmation Act of 1984, although the public has subsequently enjoyed free and unrestricted access along its route since then and the local community believes that the Right of Way has consequently been reestablished. This is a view that is shared by Scotways, the independent charity that upholds and promotes public access rights in Scotland;
- that the Leven Railway Act of 1852 requires public crossings to be maintained across the railway, but that it isn't clear to which crossings that Act refers;
- that ScotWays has confirmed that all three routes over the level crossings at Doubledykes, Waukmill and Tullybreck are recorded in the National Catalogue of Rights of Way as Rights of Way and has expressed the view that the Council should have promoted Stopping Up Orders prior to Network Rail closing these Rights of Way and
- that Scotways has also said that formally closed Rights of Way could be re-gained by positive prescription and, in the case of Doubledykes, is of the view that there has been sufficient public use over the necessary prescription period for a public right to have been re-acquired and that it remains recorded as a Right of Way. In support of this position affidavits have been submitted to Network Rail and made available to the Council, which affirm that the crossing at Doubledykes has been used with free and unrestricted access since it was extinguished as a Right of Way by the British Railways Order Confirmation Act of 1984.

Council therefore agrees:

Based on the importance of the issue to the local community, that Counsel's Opinion be sought as to whether the Right of Way has been re-established and, if not, if there is a legal process by which it can be so; and

that Officers investigate if the crossings at Waulksmill and Tullybreck, which have been closed by Network Rail, are Rights of Way and, in particular, if they constitute "roads in the Parish of Markinch", to which reference is made in Section XXVII of the Leven Railway Act 1852 and, if not, which are the roads to which reference is made therein."

## Amendment

Councillor Craik, seconded by Councillor Noble, moved as follows:-

"That Council agrees that there has been insufficient consultation, by Network Rail and Transport Scotland, with local communities in the delivery of the Levenmouth Rail link.

Notes that the 1852 Act relates to public crossings which were in place 170 years ago. Notes that attempts to map these crossings would indicate that obligations

in the 1852 Act have been, and are being, fully complied with. Notes that any pre-existing access rights at Doubledykes were extinguished 130 years after the 1852 Act by the 1984 Act.

Agrees that the Council has an important role in relation to rights of way but that the Council's clear internal legal advice is that there is no right of way along the Doubledykes route.

Agrees that the much welcomed Levenmouth investment will develop the opportunity for increased economic and social benefit for the local community.

Encourages the Council to continue to actively work with partners to meet the aspirations for Doubledykes and active travel around the rail link with the further meetings are planned."

How is glyphosate used by the council in Fife given its perceived dangers to humans and biodiversity?

## <u>Answer</u>

Scottish Government information shows that nearly every Council uses Glyphosate as a herbicide to control weeds and protect infrastructure. The public sector has a limited choice of active substances which are approved in amenity settings. Unlike many other herbicides, glyphosate is systemic and broad-spectrum, effectively controlling both grasses and broadleaved weeds, making it one of the most widely used, cost-effective tools for weed management. Glyphosate has been approved for use in both agricultural and amenity environments for over 40 years.

Whilst there has been some controversy about glyphosate use, this active substance is currently approved for use in both the European Union and Great Britain. Assessments by the European Food Safety Authority (EFSA) and the European Chemicals Agency (ECHA) concluded that glyphosate met approval conditions for use and did not pose an unacceptable risk to human or environmental health. The current Great Britain glyphosate approval expires in December 2025 and the Health and Safety Executive (HSE), will be robustly assessing all regulatory evidence.

The Council recognises the environmental harm that glyphosate can cause to biodiversity and ecosystems. To minimise this damage, the Grounds Maintenance Service has developed an integrated weed management programme that reduces the need for herbicide use. Two annual herbicide applications are made to hard surfaces and all soft surface treatments have stopped. The hard surface treatments are applied to road channels, pavements, kerbs, footpaths, playgrounds and car parks.

There are no other non-chemical alternatives as effective as Glyphosate herbicide, which has a longer lasting effect and is significantly cheaper than other weedkilling applications. The Council will continue to consult with other Councils on industry developments and trial alternative products. The ultimate objective is not to use glyphosate herbicide but without an effective alternative, there is a significant risk of weed growth damaging hard surfacing and drainage systems.

## Supplementary Question

Can we consider excluding playgrounds from the list of areas treated with glyphosate?

## <u>Answer</u>

This question specifically addresses planning controls over short-term let premises. The Head of Housing Services, Head of Legal and Democratic Services, and Head of Protective Services were remitted by Cabinet Committee at its meeting on 9 March 2023 to report back to that Committee with an update on licensing following implementation of the licensing arrangements. Cabinet Committee also asked for a detailed timeline with regard to short-term let control areas, particularly within the East Neuk area, as soon as practicably available. A report is scheduled for Cabinet Committee in November.

The Planning (Scotland) Act 2019 includes provision for the establishment of short-term let control areas (STLCAs). This is distinct from the licensing requirements introduced by the Civic Government (Scotland) Act 1982 (Licensing of Short-term Lets) Order 2022 which came into effect on 1 March 2022 and requires Local Authorities to develop a licensing scheme for short-term lets.

The purpose of a STLCA may be to meet one or more of the following policy objectives:

- to help manage high concentrations of secondary letting (where it affects the availability of residential housing or the character of a neighbourhood);
- to restrict or prevent short-term lets in places or types of building where it is not appropriate; or
- to help ensure that homes are used to best effect in their areas.

Within a STLCA, a change of use to a short-term let will always require planning permission. It is not a ban on short-term lets but will allow planning policies to be used by local planning authorities to assess applications for such a change of use and allow communities and individuals the right to make representations through the planning application process.

A Short Term Let Working Group has been established involving representatives from Housing Services, Protective Services, Planning Services, Business & Employability Services, and Democratic and Legal Services. The Working Group focuses on monitoring the implementation and operation of the new licensing scheme and assessing the evidence to inform whether there is a case for one or more STLCA in Fife. To date, an information audit has been carried out to assess the case for one or more STLCA in Fife. The question refers to East Neuk & St Andrews; no one area in Fife is being given more attention than another although the officer group is aware that St Andrews has the largest percentage of STL applications by far – approximately 35% to date – and the East Neuk residential stock is affected by second homes.

Work is ongoing to identify information gaps and to carry out an assessment, including business impact and the effect on resident communities. The licensing scheme will provide evidence of the scale and distribution of STLs across Fife. The biggest and most critical information gap to date is understanding the total number of applications the Council may receive. The rate of applications has been accelerating in recent weeks and it is anticipated that this trend will continue until the licence application deadline (30 September 2023), but most operators may still have to apply before the deadline.

Fife Planning and Housing officers invited representatives of the Association of Scottish Self Caterers to discuss their views on potential STLCAs and held that meeting in September.

A legal challenge has been raised against City of Edinburgh Council on its planning policy on STLs which will be heard at a hearing scheduled for November. In addition the Association of Scotland's Self-Caterers has written to Perth & Kinross Council to seek a delay to the consultation on the designation of a Short-Term Let Control Area on the grounds that the data and evidence-base presented by Perth and Kinross Council is not fit for purpose. Highland Council has also had to suspend the designation of its Planning Control Area in Badenoch & Strathspey on the basis that the policy may be unlawful. To avoid similar challenges, officers are conscious of the need to use robust and credible data when preparing our own evidence base. The outcome of the Edinburgh legal challenge will provide clarity on how the control scheme will be interpreted by the courts and allow us to mitigate litigation risk.

Notwithstanding the need to consider the legal issues before the courts, Planning Services will report on the available evidence and whether there is a case for one or more STLCA in Fife as part of the Local Development Plan Evidence Report currently being prepared. A detailed timeline would not be available until it is determined that there is a case for a STLCA. The Evidence Report will be reported to Cabinet Committee early in 2024 and is programmed for submission to the Fife Council meeting on 21 March 2024.

## Supplementary Question

Can the administration guarantee there won't be another 7 year delay in implementing?

## <u>Answer</u>

Given the recent legal challenge we need to ensure the correct process is followed. A timeline for this will be submitted to Cabinet Committee.

## Answers

Q4 - In February 2020, the School Estate was specifically reviewed for RAAC and it was not identified. Likewise, it has not been identified in the wider estate. In light of recent media interest, we have initiated further precautionary reviews across all our buildings. This includes double-checking the School Estate as well as the remainder of the Council's public buildings including those used by the Trusts and Cireco. These checks extend to all buildings that the Council owns, manages, leases or leases to third parties. A precautionary review of council houses has also been initiated. Although at an early stage, it is not anticipated that the review will identify any significant challenges with RAAC in the Council's housing stock.

Q5 - As RAAC has not been identified in the Council's estate, no inspections have been carried out. However, the reviews of the estate are carried out by an appropriately qualified chartered civil/structural engineer.

Q6 - As RAAC has not been identified in the Council's estate, there is no planned inspection regime. In the event that RAAC were identified, inspections would be carried out at a frequency dictated by the identified level of risk.

# Fife Council Leader's Report Thursday 7<sup>th</sup> December 2023

# 1. Pay

Following a revised pay offer from COSLA, fully backdated to April, Unison recommended acceptance of the offer and this was agreed by its members through a ballot. The offer had therefore been accepted by all three SJC trade unions. This will avoid further industrial action on this pay claim.

The Council is making arrangements to pay this backdated pay offer and the uprating of the living wage before Christmas.

## 2. ScotRail Timetable for Levenmouth Rail Link

ScotRail undertook consultation on proposed timetable changes including an interim timetable to operate on the opening of the new Levenmouth Rail Link. This would see either two trains an hour routed round the Fife Circle to Edinburgh via Dunfermline or one train an hour to Edinburgh via Kirkcaldy, rather than the promised two trains an hour with one via Dunfermline and one via Kirkcaldy.

I met with ScotRail to express concerns that these proposals would not meet the desired level of service in terms of frequency or journey times between Leven and Edinburgh and would negatively impact on travel to and from destinations within Fife, all of which would diminish the attractiveness of the new line at the point of opening which is important to its success.

The need for this reduced interim timetable is due to a lack of rolling stock within Fife. I have asked ScotRail to re-examine their proposals with a view to introducing the originally intended timetable and have suggested they seek to source additional rolling stock from elsewhere for the opening of the new link as I believe was done for the opening of the Borders line. I have also communicated these concerns to the Cabinet Secretary for Transport, Net Zero and Just Transition.

# 3. The Verity House Agreement and the Proposed Council Tax Freeze

The First Minister announced a proposal to freeze council tax for the coming year. This announcement was made without discussion with COSLA as was the expectation under the recently signed Verity House Agreement between Scottish and Local Governments.

An urgent meeting was held between the First Minister, the COSLA Presidential Team and COSLA political group leaders at which COSLA expressed its disappointment that this announcement had been made without prior discussion and contrary to the Verity House Agreement, and stressed local government's long held principle that it should be for individual local authorities to determine their own level of council tax dependent on local circumstances and in response to local consultation.

The First Minister regretted the way the announcement had been made with no prior discussion but maintained that he felt the decision was the right one. He gave the assurance that this council tax freeze would be for one year only and that it would be 'fully funded'.

Discussions have been taking place between Scottish Government and COSLA prior to the Scottish Budget announcement on 19<sup>th</sup> December but as yet there is no clarity on the what 'fully funded' means in practice.

## 4. Education Regional Improvement Collaboratives

The Cabinet Secretary for Education and Skills announced recently that she planned to taper down the funding for Regional Improvement Collaboratives and to redirect funding to establish a Centre for Teaching Excellence.

Again this was done without prior discussion with local government as should have happened under the Verity House Agreement.

This was raised directly with the Cabinet Secretary by COSLA, and Council Leaders subsequently agreed to ask for the full publication of the current review of RICs before any decisions on the tapering off of funding are taken, that current levels of funding for RICs are maintained for the coming year to allow evidence based consideration of their future role, and that full details of costs and remit of the proposed CTE should be made available so that an evidence based decision can be made on the need for and role of the CTE. Further, Leaders wanted to re-emphasize that should the decision be made to establish this body then its scope should be broadened to include support not only for teachers but the broader staff cohorts supporting Learning including early years officers and pupil support assistants.

## 5. Common School Week and Learning Hours

Raising attainment and achievement is one of the key aims of the Education Improvement Plan. As part of assisting with this, discussions have been taking place in Education with head teachers regarding moving to a consistent 27.5 hour secondary school week and the possibility of adopting a common asymmetric week across secondary schools. This mirrors discussion at a national level through the Scottish Government.

The adoption of a common week could benefit pupils, allowing them a greater choice of opportunities across schools, and could also facilitate the scheduling of collaborative professional learning and development for staff.

A number of secondary schools currently operate a 27.5 hour week and others are already planning to move to this. It is recognised that not all secondary school would be able or would wish to move to this immediately so such a move is likely to be phased over at least 3 years. This would also allow lessons to be learned from the experience of those schools operating or moving to these arrangements.

Schools and the Education Service have a degree of autonomy over such arrangements, but any necessary reports would be brought to Committee in due course.

## 6. Behaviour in Schools

The Education Service continues to work with schools to address the issue of behaviour in schools impacting on both pupils and staff.

I met with the National Official (Scotland) from the NAS/UWT to discuss the results of a national survey of the union's members they had carried out on this subject. There had been a much higher completion rate from staff from Fife than for other areas,

partly because of the attention the Council has been giving to the issue and the efforts we have been making to facilitate the reporting of incidents by staff.

Whilst we are taking this issue very seriously in Fife, it is recognised that it is a Scotland and UK wide issue, not something that only affects Fife. I was heartened to hear from the Union that Fife is already taking most of the actions the Union is recommending and is seen in some respects as a model of good practice.

Across our schools a huge amount of work is underway to tackle violence and bullying affecting both pupils and staff. Working with partners including Police, NHS Fife and the Health and Social Care Partnership, the Council is putting a number of different programmes, practices and actions in place.

Some of our schools are facing specific challenges and the Education Service is giving targeted support to schools where and when it's needed.

The Council is piloting a model of having a social worker based in four of our secondary schools to work with young people where attendance at school is low. Our staff across our schools are also engaging in professional development around trauma informed practice and de-escalation intervention.

It is recognised that this work will take time to have the full desired impact but the safety and wellbeing of all children and staff in every Fife school is a priority and the Council will continue to work with all our school communities to make sure our staff and young people have a positive experience at school.

## 7. Climate Change

I hosted a roundtable discussion on future climate change strategy with local environmental groups from across Fife in October. Cllr Jan Wincott, Spokesperson for Environment and Climate Change also attended the Fife COP 2023 event organised by the Fife Environmental Partnership in November.

The Cabinet Committee will consider the Council's Local Heat and Energy Efficiency Strategy at its meeting on 30<sup>th</sup> December. The LHEES is a fundamental part of the Council's Climate Change Strategy. The overarching Climate Change Delivery Plan is currently being finalised setting out key actions for the coming 4 years and this will be submitted to the Cabinet Committee in January.

## 8. 'No Wrong Door' and Senior Management Appointments

The Cabinet Committee will consider on 30<sup>th</sup> December, reports on the 'No Wrong Door' approach, which sets out proposals for the next phase of the Council's change programme and proposals to appoint a new Executive Director of Education and a new Chief Social Worker, and moving Children and Families and Criminal Justice to the Communities Directorate.

The 'No Wrong Door' approach is designed to build on some of the test of change work already underway within the Council and with partners, moving further towards a preventative, people centred model rather than the current transactional model which tends to deal with the presenting symptoms rather than root causes and too often at the point of crisis. All Members are encouraged to read the papers contained within the Cabinet Committee agenda.

## 9. Adam Smith Theatre Re-Opening

The Grand Re-Opening of the Adam Smith Theatre in Kirkcaldy was held on 23<sup>rd</sup> September following the major refurbishment of the building. The event showcased a wide range of Fife's performing arts groups and was a great success.

The re-opening of the theatre will allow the Fife Cultural Trust to better estimate its operational costs and income following the refurbishment and the recovery from the pandemic. Discussions will be taking place with all the trusts regarding business planning and management fees in the run up to setting the Council's budget in February.

## 10. Fife Gingerbread

I recently visited Fife Gingerbread to hear about their involvement in the Intensive Family Support project funded through the employability strand of the Edinburgh and South East Scotland City Region Deal and the contribution they are making to the Fair Work pillar of Community Wealth Building.

## 11. Meals on Wheels

As part of the Council's efforts to support National Meals on Wheels Week I visited the kitchen at Ostlers House and joined one of the delivery drivers on his round, allowing me the opportunity to meet users of the service. The value of this service is obvious and it is well appreciated by those who receive it.

Arising from discussion about the operation of the service I have asked officers to give some initial consideration to how we might make better use of the Council's internal capacity for food production and preparation.

# Change to List of Committee Powers - Determination of National Planning Applications or Major Applications Significantly Contrary to the Development Plan

#### Purpose

This report proposes a minor amendment to the List of Committee Powers to remove the determination of national planning applications or major applications significantly contrary to the Development Plan from the functions reserved to Fife Council and to delegate this function to the Cabinet Committee.

#### Recommendation(s)

Council is invited to:

- (1) agree that Committee Powers be amended at set out at section 3.1.7 to remove the determination of national planning applications or major applications significantly contrary to the Development Plan from the functions reserved to Fife Council and delegate this power to the Cabinet Committee; and
- (2) delegate authority for any consequential amendment to Fife Council's governance documentation required by recommendation one to the Head of Legal & Democratic Services.

Section 27 of the Planning (Scotland) Act 2019 removed the requirement for certain prescribed classes of development (national planning applications or major applications significantly contrary to the development plan) which are subject to the pre-determination hearing procedures, to be ultimately determined by full Council in terms of section 56(6A) of the Local Government (Scotland) Act 1973 as amended, which provision is also repealed.

# 1.0 Background

- 1.1 Section 3.1 7 of The List of Committee Powers sets out Fife Council's reserved powers to determine national planning applications or major applications significantly contrary to the Development Plan.
- 1.2 Section 27 of the Planning (Scotland) Act 2019 removed the requirement for certain prescribed classes of development (national planning applications or major applications significantly contrary to the development plan) which are subject to the pre-determination hearing procedures, to be ultimately determined by full Council in terms of section 56(6A) of the Local Government (Scotland) Act 1973 as amended, which provision is also repealed.
- 1.3 There is an application currently progressing through the planning process and in consideration of the governance route for this application a change to Committee Powers is sought at this point, in advance of a full review of Committee Powers in the new year.
- 1.4 The current pre-determination process for these applications will continue, with a predetermination hearing followed by relevant planning committee consideration before any recommendations are made for final approval. Delegating final approval for these applications to Cabinet Committee will allow efficient decision making, given the more frequent meetings of the Cabinet Committee. The Cabinet Committee also has responsibility for developing and approving new policies consistent with the overall strategic approach of the Council so this delegation would align well to the existing remit.

# 2.0 Conclusion

2.1 It is for the Council to consider how it wishes to deal with the decision-making process following on the pre-determination hearing which hearing remains a statutory requirement in relation to the classes of development as detailed at section 1.2 of the report. Given the change introduced by the 2019 Act it is recommended that the Cabinet Committee is a more appropriate forum to consider these applications.

# 1.0 Background

## St Andrews Links Trust Management Committee – Non-Elected Member Representation

- 1.1 The St. Andrews Links Trust Management Committee consists of eight members, four of which are appointed by Fife Council and appointments are made for a four year period.
- 1.2. In accordance with the Protocol Agreement which exists between the Council and the St. Andrews Links Trust, the local golf clubs are invited to take up two of the Council places on the Management Committee. The St. Andrews Links Order 1974 also states that persons appointed to the Management Committee shall have close connections with the town of St. Andrews and its golfing community.
- 1.3 The term of appointment of Tom Gallacher, a representative of the local golf clubs (nominated by the Inter-Club Liaison Committee (ICLC)), is due to expire on 31 December 2023. Members nominated by the ICLC to the Links Management Committee are restricted to two terms of appointment.
- 1.4 The Council's other representatives on the Management Committee are Councillors Lesley Backhouse and Allan Knox and Jim Lindsay, a representative from the local golf clubs.
- 1.5 The ICLC have recommended that Tom Gallacher be appointed for a second term.

## St Andrews Links Trust – Non-Elected Member Representation

- 1.6 The St. Andrews Links Trust consists of eight members who are Trustees of the Links Trust, three of whom are appointed by Fife Council and appointments to the Links Trust are for a 3 year period.
- 1.7 In accordance with the Protocol Agreement which exists between the Council and the St. Andrews Links Trust, the local golf clubs are invited to take up one of the Council places on the Trust and nominations were sought.
- 1.8 The term of appointment of Sandra Tuddenham, a representative of the local golf clubs (nominated by the Inter-Club Liaison Committee (ICLC)), is due to expire on 31 December 2023. Members nominated by the ICLC to the Links Trust are restricted to two terms of appointment.
- 1.9 The Council's other representatives are Councillors Colin Davidson and Ann Verner.
- 1.10 The ICLC have recommended that Sandra Tuddenham be appointed for a second term.

1.11 It should be noted that members cannot be appointed to the St. Andrews Links Trust if they are already members of the St. Andrews Links Management Committee (or vice versa).
