(SALE OF SOLID FUEL) BYELAWS 1988 The Fife Regional Council hereby make the following byelaws under the provisions of Paragraph 9 in Part 1 of Schedule 5 to the Weights and Measures Act 1985 and declare that these shall be in force throughout the Fife Region:-

- (1) These byelaws may be cited as "The Fife Regional Council (Sale of Solid Fuel) Byelaws 1988".
- (2) Any person being the owner or occupier or being in charge of premises on or from which solid fuel available for purchase in a quantity of 224 pounds or less is sold or kept or exposed for sale shall display in a conspinus place on the premises a notice on which shall be and legibly marked in figures of at least three inches in height and of proportionate breadth the price at which the solid fuel is kept or exposed for sale.
- (3) No person shall alter, deface or remove any such notice except for the purpose of showing a change in price; and any such alteration for that purpose shall not be made except at the commencement of business at the premises upon any day on which solid fuel is to be available for sale.
- (4) No person being the owner or occupier or being in charge of premises on or from which solid fuel available for purchase in a quantity of 224 pounds or less is sold or kept or exposed for sale and on which premises is displayed a notice as specified in byelaw 2 above shall on a sale of any such fuel either by himself or his agent charge to the purchaser any price higher than that marked in relation to that fuel on the notice displayed at the time of sale.
- (5) With effect from the date of coming into operation of these bylaws, the following byelaws shall be revoked:-

Byelaws relating to the Sale of Coal for the County of Fife dated May 15th, 1937.

(6) Every person who contravenes or fails to observe any of the foregoing byelaws shall be guilty of an offence and liable on summary conviction to a penalty not exceeding £100 for each offence.
