Common Good Funds Update Report 2020-2021

Purpose

The purpose of this report is to advise members of the current status of the Common Good Funds in the area to assist with the decision-making process for new applications.

Recommendations

An EqIA has not been completed and is not necessary as the report does not propose a change or revision to existing policies and practices.

Consultation

Consultation has taken place with Asset, Transportation and Environment Services and Fife Cultural Trust.

1.0 Background

1.1 A number of towns in Fife have a Common Good Fund which can be used for the benefit of the inhabitants of that town. The Common Good Funds are administered by the Council and any grant in excess of £5,000 requires committee approval.

2.0 Common Good Fund - Current Position

2.1 Revenue Account

2.1.1 Projected Income

The projected cash income for the financial year is £192,617 and comprises mainly from rents, interest on investments and external interest

2.1.2 Projected Expenditure

The projected expenditure for the financial year to is £74,795 of which £11,558 relates to property costs and £3,773 other expenditure. To date 2020-21 grants allocations have been £6,062.

2.1.2 In year available Funds

£171,224 remains available for distribution for new applications dependent on the outcome of the application today this may reduce to £156,224.

3.0 Year End Balances

3.1 Revenue Balances

3.1.1 Prior Years Commitments

£22,581 of funding has been earmarked for grants that were approved in 15-20 but due to various circumstances have not been released prior to the financial year end. A commitment for these grants to be paid will remain in 2020-21 and should these not be expended the funds will return to the revenue balances.

3.1.2 Revenue Balances

£66,184 of funding is held in Revenue balances, this funding can be used for grant or property costs during the financial year. Revenue balances are invested on a 3-5year basis to increase the value of the Common Good.

The heritable property and investments represent the capital balances.

3.2 Capital Balances

3.2.1 Investments

West Fife Common Good currently hold investments to the value of £345,338. These investments are generating approximately £14,252 in interest annually.

3.2.2 Heritable Property

Heritable property held within West Fife Common Good has a current Value of £332,063.

4.0 Conclusions

4.1 This reports and its appendices are intended to give Members greater information on the current position of the Common Good Funds.

West Fife Area Common Good Fund - Application for Assistance : Dunfermline Heritage Partnership's Wellbeing through Heritage Project

Report by: Paul Vaughan, Head of Communities & Neighbourhoods

Wards Affected: 2, 3 and 4

Purpose

The purpose of this report is to seek a Sub-Committee decision on the award of funding from the West Fife Area Common Good Fund.

Recommendation(s)

It is recommended that the Sub-Committee consider and approve the application from the Dunfermline Heritage Partnership for £15,000 from the West Fife Area Common Good Fund. The funds will assist with the costs of organising and delivering walking groups in Dunfermline and West Fife over a 3-year period as part of their Wellbeing Through Heritage project; including staffing costs and delivering training and support for group leaders.

Resource Implications

A Finance Report (appendix 1) summarising and commenting on the current application along with the Financial Statement for the West Fife Area Common Good, being a separate item on the agenda.

Impact Assessment

An EqIA has not been completed and is not necessary as the report does not propose a change or revision to existing policies and practices.

Consultation

The Local Members of Wards 2, 3 and 4 along with the respective Community Councils have been consulted and have been supportive of this project.

1.0 Background

- 1.1 Applications to Common Good Funds should be able to demonstrate a benefit to the inhabitants of the former Burgh concerned.
- 1.2 Applications to the Common Good Fund in West Fife must be determined by the West Fife Area Common Good Sub-Committee.

2.0 Application Details

- 2.1. The Dunfermline Heritage Partnership is seeking £15,000 from the West Fife Common Good Fund to support the development and implementation of a programme of wellbeing activities over a three-year period, which will promote awareness of the built and natural heritage and greenspace areas across Dunfermline and West Fife. This is part of the Wellbeing through Heritage project (see appendix 2).
- 2.2. This application will form part of a package of funding amounting to £368,000 for the three-year period of which £245,000 is being sought from the Heritage Lottery Fund. A contribution of £15,000 per year for three years, totalling £45,000, is also being sought from the City of Dunfermline Area Committee on April 27th, 2021.
- 2.3. As the Dunfermline Heritage Partnership is not a constituted group, the Carnegie Development Trust is acting as the lead organisation on behalf of the group.
- 2.4. The COVID-19 pandemic has caused major disruption to the lives of everybody across the world. Even before the pandemic there was significant evidence that wellbeing, and particularly mental wellbeing, was a growing concern particularly amongst younger age groups. Glasgow University also reported that mental wellbeing was 40% narrower among people reporting good access to green and recreational areas compared to those with poor access. Dunfermline and West Fife is very fortunate to have significant heritage and greenspace areas that are accessible to all residents and visitors.
- 2.5. This project will deliver improved wellbeing through heritage and greenspace for residents and visitors to Dunfermline and West Fife. The approach will also promote the nationally recognised New Economics Foundation model of 5 ways to wellbeing. These include:

^{***}Connect: Talk & listen, Be there, Feel connected.

^{***}Be active: Do what you can, Enjoy what you do, Move your mood.

^{***}**Take notice:** Remember the simple things that give you joy.

*****Keep Learning:** Embrace new experiences, See opportunities, Surprise yourself.

***Give: Your time, Your words, Your presence.

- 2.6. The funds being sought from the West Fife Area Common Good Fund will contribute towards activities that support the 'Explore and Connect' element of the project (see appendix 2), which is about encouraging people to be more active and connected to their place and community.
- 2.7. The funds will specifically be used to support the organisation and running of several walking groups in Dunfermline and West Fife (see appendix 2, page 6). It will provide training and support for volunteer walk leaders in points of interest on established routes in these areas, including groups from Valleyfield and Oakley.
- 2.8. Partners such as the Fife Cultural Trust, Active Fife and the West Fife Heritage Network will provide training and co-lead the walks. The funds will cover costs associated with staffing, including the use of sessional workers as well as training costs for volunteer walk leaders.
- 2.9. The project compliments the aims contained within the Plan for Fife and will deliver against the a number of areas, including:

***Thriving places:

 Mental wellbeing programmes will being delivered in a natural environment through sessional workers thereby improving the health and resilience of different age groups.

***Opportunities for all:

- Educational opportunities provided across multiple ages in the wonder of nature.
- Traditional building skills courses being delivered to secondary pupils in Dunfermline and West Fife.
- Training in Lime skills through Lime Centre in Limekilns.

3.0 Conclusions

3.1 The application is considered to be eligible for Common Good funding.

Introduction & Rationale

Dunfermline Heritage Partnership is a non-constituted network of organisations which aims to catalyse heritage-led regeneration through the use of its built assets. The Partnership has an established track record working together to deliver strategic success for Dunfermline through supporting greater understanding of, connection with and use of our heritage. The partnership promotes learning from the past to secure investment in our future. This has never been more vital as we face the multiple economic and wellbeing challenges presented in a world post Covid19. We now propose to work together to deliver a programme that connects organisations with capability and capacity to organisations with client groups who would benefit using the New Economics Foundation "5 Ways to Wellbeing" as the common 'bridge' between organisations. The five focus points are Connect, Be Active, Take Notice, Keep Learning, and Give.

The Dunfermline Heritage Partnership has already undertaken the difficult ground work in identifying partners and enabling them to work together and to agree that a shared vision focussed on consumers is the most effective way to create change and deliver strategic programmes across Dunfermline that have maximum impact. Its current membership includes a diverse group of heritage organisations, some of whom maintain and manage built heritage in Dunfermline. The Dunfermline Heritage Partnership has developed a shared vision around delivery of a coherent consumer experience. Our community of interest includes: Fife Cultural Trust, Historic Environment Scotland, Carnegie Dunfermline Trust, Fife Cultural Trust, Church of Scotland Abbey, Fife Coast and Countryside Trust and Abbot House. The Partnership also includes, Visit, Scotland, Fife Tourism Partnership, Fife Council and Dunfermline Area Local Tourist Association.

In addition, Dunfermline Heritage Partnership activities form a key plank in Fife Council – Dunfermline Area Local Community Planning Partnership (LCPP) economic recovery plan as a tourist destination. The Dunfermline Poverty Alliance Group form a key plank of Dunfermline LCPP in addressing Health and Wellbeing activity post pandemic. Both partnerships have formed strong links through the LCPP and specifically the Dunfermline Advice Hub. The New Economics Foundation 5 Ways to Wellbeing provides a strong bridge between these two communities of interest.

To make the transition to our new signature project we envisage that our key partners are: Carnegie Dunfermline Trust - lead partner, Fife Council, Fife Cultural Trust, Fife Health & Social Care Partnership, Historic Environment Scotland, Fife Coast & Countryside Trust. The project will use local heritage to improve wellbeing for people in Dunfermline and West Fife. It will build a sense of connectedness and belonging in neighbourhoods, supporting individual confidence and self-esteem, providing opportunities for people to be active and to give back to their communities. Improving wellbeing is a key priority of the Scottish Government and the Fife Health & Social Care Partnership. In 2018, the Design Dunfermline charette also identified the potential of building on the town's heritage assets to promote wellbeing.

Working closely with communities of interest and local health and social care organisations, the project would support them to include heritage in their existing wellbeing activities, jointly developing and trialling a series of new programmes. Using New Economics Foundation "5 Ways to Wellbeing", as the bridge between organisations and consumers, the project will work with people experiencing low/poor wellbeing, where new activities, opportunities and connections are likely to have the biggest impact. The project would also align creativity, communications and

technology providing a digital boost to the programme to allow enhanced connections and access to wellbeing programmes in a context of continued social distancing as Coronavirus changes the way in which individuals and communities engage with each other. The 5 Ways to Wellbeing are outlined in the illustration below.
