Section 1 Introduction

- 1.1 Section 18(c) of the Representation of the People Act 1983, as amended, places a duty on local authorities to review the UK parliamentary polling districts, polling places and polling stations in their area on a regular basis. The Council's last full review of Polling Districts and Polling Places was completed in 2019.
- 1.2 The responsibility for reviewing UK parliamentary polling districts and polling places rests with the local authority and the responsibility for the allocation of polling stations rests with the Returning Officer. However, for the purpose of this review, all aspects of the review process will be undertaken jointly.
- 1.3 The scope of this review does not cover parliamentary constituency or local government ward boundaries as these are the responsibility of the Boundary Commission and Local Boundary Commission for Scotland respectively and therefore subject to separate review.
- 1.4 The 2023 Review of UK parliament constituencies was completed by the Boundary Commission for Scotland and their final recommendations submitted to Parliament in November 2023. Any implications arising from this review on current polling districts and polling places have been included as part of this review.
- 1.5 A review of Scottish Parliament constituency and region boundaries is currently underway and is due to be completed by 1 May 2025. A further review of polling districts may be undertaken considering final proposals, once published.

Definitions:

- 1.5 **"Parliamentary constituency"** the Parliamentary Constituencies Act 1986 states that "there shall for the purpose of parliamentary elections be the county and burgh constituencies each returning a single member, which are described in Orders in Council made under this Act. [...] In this Act and, except where the context otherwise requires, in any Act passed after the Representation of the People Act 1948, "constituency" means an area having separate representation in the House of Commons."

The subject of this review is the current division of the UK parliamentary constituencies within the Fife local government area into polling districts. The UK parliamentary constituency boundaries **cannot** be amended by this review.

- 1.6 **"Polling District"** is defined as the geographical area created by the sub-division of a constituency or ward into smaller parts. In Scotland, each electoral ward must be divided into two or more polling districts unless there are deemed to be special circumstances.
- 1.7 **"Polling Place"** is defined as the building or area in which polling stations will be designated by the Returning Officer. Polling places should be within the polling district unless special circumstances make it desirable to designate an area outside the polling district.
- 1.8 **"Polling Station"** is defined as the room or area within the polling place where voting actually takes place. These are designated by the Returning Officer for each election.

Section 2 Review Process

- 2.1 The aim of this review is to ensure that every elector in Fife has access to such reasonable facilities for voting as are practicable and as part of the review process the Council must seek to ensure that as far as is reasonable and practicable, polling places are accessible to those who are disabled.
- 2.2 The Council is required to publish notice of holding a review and this is available to view at Fife House, North Street, Glenrothes, KY7 5LT and the following public libraries during normal opening hours:

- 2.4 In addition, any elector for a UK Parliamentary constituency either wholly or partly within the Fife local government area may make representations to the Council on the current polling arrangements or draft proposals contained in this document. All representations received during the course of this review will be made available for public inspection.

Section 3 Accessibility Issues

- 3.1 The Scottish Government is committed to improving the accessibility of elections. In 2023, the Scottish government included accessibility questions in their consultation on Electoral Reform. They noted in their consultation document that there are one million disabled people in Scotland (19% of the population). The Scottish Government believes that fair, proportionate representation at both local and national levels is essential to achieving equality. It is important that those individuals and communities who are at greatest risk of lower representation are enabled to contribute to decision-making, to reach relevant solutions and build capacity and wellbeing.
- 3.2 The Elections Act 2022 amended the law to provide greater flexibility and choice in how disabled voters are supported at polling stations. With effect from May 2023, Returning Officers were required to take all reasonable steps to provide support for disabled voters at polling stations.
- 3.3 Local authorities must take proactive steps to ensure that polling stations do not disadvantage electors who are disabled and ensure that they give due regard to accessibility for disabled voters when designating polling places. They must also consider the different types of disability which may make voting in person more difficult.
- 3.4 In undertaking this review the Returning Officer has considered the following principles:
- There should be no barriers to voting for people with a disability.
 - Everyone should have the right to vote on their own and in secret.
 - Voting should be a good experience for everyone.
 - The Scottish Government's 20-minute neighbourhood concept which aims to provide access to most daily needs within a 20-minute walk, wheel, or cycle from home.
- 3.5 The Returning Officer and their team consistently work towards ensuring that polling places in Fife are accessible, as far as possible. As part of the work of the review, where an alternative polling place is being proposed, the Returning Officer has only supported changes to the polling scheme where the facilities **meet or exceed** the accessibility requirements in the current polling place.
- 3.6 The Returning Officer is consulting with several organisations who have experience in assessing the access requirements for persons with different types of disabilities.
- 3.7 Informal consultation was also undertaken with elected members in 2023, and their comments have been considered as part of this review process.
- 3.8 The Returning Officer has used the [review accessibility template](#) provided by the Electoral Commission to assess the suitability of all proposed new polling places.
- 3.9 In addition to the above, the Returning Officer has also considered the following before making recommendations:
- Location and size of venues.
 - Continued availability of venues for use as polling places.
 - Transport links.
 - Facilities for polling station staff.
 - Proposed areas of new developments; and
 - Expected population numbers.

- The revocation of the Fixed Term Parliament Act and the impact of unscheduled elections.
- The availability of polling station staff.
- The availability of venues for unscheduled elections/and the closure or sale of venues.

Section 4 Existing Polling Arrangements and Draft Proposals

4.1 Introduction

- 4.1.1 The current local government boundaries were introduced for the 2007 local government elections. There are twenty-two wards within the Fife local government area.
- 4.1.2 The Returning Officer has delegated authority to make changes to the polling scheme in the run up to any major statutory election, where scheme venues are unavailable for use.
- 4.1.3 The Returning Officer holds a portfolio of detailed accessibility checklists of many of the polling places. These hold comprehensive information including photographs of the polling places in use in Fife. The Returning Officer's team is currently working towards holding detailed checklists of all polling venues. Copies of the Returning Officer accessibility checklists are available for inspection on weekdays during office hours at Fife House, North Street, Glenrothes, Fife, KY7 5LT by appointment only.
- 4.1.4 As part of the on-going commitment to ensure that electors in Fife have such reasonable facilities for voting as are practicable and that polling places are accessible to electors who are disabled, the Returning Officer reviews the polling arrangements prior to every major election and requires Polling Station Inspectors to complete an accessibility assessment of polling places on polling day. The findings of these assessments are considered by the Returning Officer as part of the evaluation of each electoral event and where necessary changes are implemented to improve accessibility for future elections.

4.2 Polling Districts

- 4.2.1 A full review of polling district boundaries was undertaken at the last review in 2019.
- 4.2.2 There have been no major changes to polling district boundaries in the interim. The current polling district boundaries are generally representative of the needs of the communities they serve.
- 4.2.3 Due to the introduction of the Scottish Elections (Reduction of Voting Age) Act 2015, 16- & 17-year-olds now have the right to vote at Scottish local government elections and this has increased the electorate across all wards but has not significantly impacted on polling facilities.
- 4.2.4 Major residential development or the cumulative effect of smaller developments is normally the most significant factor affecting the size of the electorate in a particular area. What development there has been in recent years and the impact on polling districts has been considered as part of this review. The scale of projected new housing continues to be monitored by the Returning Officer.
- 4.2.5 Proposals are being made to combine polling districts where the ward boundary, UK Parliamentary boundary and Scottish Parliament boundaries are now co-terminous.

4.3 Polling Places

- 4.3.1 Ideally, electoral administrators would have the choice of a range of fully accessible buildings, conveniently located for electors in the area when designating polling places. However, in practice, it is recognised that this is often not the case, and, in some areas, there is very little choice of suitable venues. The choice of polling places will often be a careful balance of several factors including access, facilities, location etc.

- 4.3.2 There are currently 177 designated polling places in Fife. Polling places range from schools and leisure centres to local community and church halls and the facilities available within the venues vary. It should be noted that the number of available venues has reduced in recent years due to halls closing or being sold.
- 4.3.3 Part of the decision-making process involves assessing if the polling place can accommodate more than one polling station, together with the necessary staff and equipment, particularly in circumstances where the number of electors allocated to a polling place is high. For example, it is known that certain elections attract a higher turnout than others. Therefore, more polling stations will be required within the polling place and consideration needs to be given as to whether the venue can accommodate such arrangements. In addition, the Returning Officer may be directed to allocate a maximum number of electors to each polling place.
- 4.3.4 The location of the existing polling places already considers the settlement structure and population distribution of Fife towns, villages, and wider countryside areas. Within rural areas, the location of the polling place takes account of the dispersed nature of the housing distribution.
- 4.3.5 The Election team continuously monitor polling places and reviews any comments received after each election. They are also required to respond to instances where a polling place may become unavailable at short notice prior to an election.

4.4 Use of schools as Polling Places

- 4.4.1 The Representation of the People Act 1983, Schedule 1, Part III, Rule 22 sets out the use of schools and public rooms by the Returning Officer for the purposes of taking a poll.
- 4.4.2 It is recognised that the use of schools as polling places, with the consequent loss of a day's education for pupils, is far from ideal and where it has been possible, the Returning Officer has made every attempt to move polling places from schools. One of the main aims of this review has been to identify alternative locations for polling places which are currently in schools.
- 4.4.3 The Returning Officer has consulted with colleagues from Education to review the polling facilities currently in schools and identify potential suitable venues which would help to keep the disruption to pupils and staff to a minimum.
- 4.4.4 There are currently twenty-eight schools in use at elections. Several new venues have been identified as suitable alternatives and these are explored in more detail in Appendix 4. Where schools remain designated as polling places this is because there are currently no suitable alternative venues, or the Returning Officer has been unable to contact potential polling venues within the polling district.
- 4.4.5 The use of schools continues to be carefully monitored on an on-going basis by the Returning Officer and Education colleagues and as local halls and community facilities are developed, polling places will be relocated whenever possible.

4.5 Draft Proposals

- 4.5.1 Draft proposals for consideration are detailed in Appendix 3 and 4.

Section 5 How to comment on the Review

- 5.1 Any elector in the Fife local government area may make representations to the Council. Representations will also be considered from persons who have particular expertise in relation to access to premises and facilities for persons who have different forms of disability.
- 5.2 Any person or body making representations should, if possible, include proposals for venues that may be suitable for consideration as alternative polling places.
- 5.3 Any representations or comments on the Councils draft proposals must be received by **5pm on 14 February 2025**. Any representations received after this date will not be considered as part of this review.

Section 6 Completion of the Review

6.1 A report containing the findings of the review and any proposed changes to the current polling arrangements will be submitted to the meeting of Fife Council on 20 March 2025 for consideration.

6.2 The annual canvass to update the electoral register was completed on 30 November 2024 by the Electoral Registration Officer based on the existing polling scheme. The updated Electoral Register was published on 1 December 2024. With no major elections scheduled until 2026, any agreed amendments to polling districts agreed will be applied prior to the publication of the register on 1 December 2025.

6.3 On completion of the review the Council will publish the following: -

- All correspondence sent to the Returning Officer in connection with the review and all correspondence sent to any person who the Council thinks have particular expertise in relation to access to premises or facilities for persons who have different forms of disability.
- All representations made by any person in connection with the review.
- The minutes of any meetings held by the Council where details of the review have been considered.
- Details of the actual designations of polling districts and polling places agreed as a result of the review.
- Details of where the results of the review have been published.

Section 7 Appeals Process

7.1 Following the conclusion of the Council's review, certain persons have a right to make representations to the Electoral Commission. This section sets out the Appeals Process which requires to be followed.

7.2 Who is entitled to make a representation to the Commission?

- Thirty or more registered electors in each constituency (although electors registered anonymously cannot make a representation).
- A person (except the Returning Officer) who made representations to the local authority when the review was being undertaken.
- Any person who is not an elector in a constituency in the authority's area but who the Commission thinks has sufficient interest in the accessibility of disabled persons to polling places in the area or has particular expertise in relation to the access to premises or facilities of disabled persons.

7.2.1 In addition, the Returning Officer may make observations on any representations made to the Commission.

7.3 Format for all representations:

7.3.1 All representations made to the Commission must be made in writing either by post, e-mail, or fax. The representation must be as specific as possible and should clearly state the manner in which it is alleged that the Council has failed to properly conduct the review. There are only two grounds on which a representation may be made. These are:

- (a) The local authority has failed to meet the reasonable requirements of the electors in the constituency.
- (b) The local authority has failed to take sufficient account of accessibility to disabled persons of the polling station(s) within a polling place.

7.3.2 Representations based on any other premise will not be considered.

7.3.3 The representation should include the location and any other relevant information regarding the polling place at issue, stating specifically why it is inaccessible or does not meet the reasonable requirements of the electors.

7.3.4 A representation may also include for consideration specific proposals for changing the place that has been designated as the polling place.

7.4 Decision making process of the Commission

7.4.1 Upon receipt of a representation, the Commission will request all relevant documentation from the Council and will show the Council the representation.

7.4.2 The Returning Officer is entitled to make observations on the representation submitted to the Commission and should give a report on the probable polling stations which would likely be used should the representation be successful.

7.4.3 The documentation from the Council, the observations of the Returning Officer and any other relevant information will be taken into consideration, in conjunction with the representation.

- 7.4.4 The Commission may seek advice from persons with expertise on accessibility issues when making its decision.
- 7.4.5 The Commission will set out in writing its conclusions and reasons for its decision. The Commission's decision will be issued to the person(s) who made the representation, the Council, and the Returning Officer. The decision and related documents will also be published on the Commission's website and the [Fife Council website](#).
- 7.4.6 The Commission may direct the Council to consider any alterations to the polling places that it deems necessary under the review. After two months, if the Council has failed to make the alterations the Commission can itself make the alterations as if the Council had implemented them.

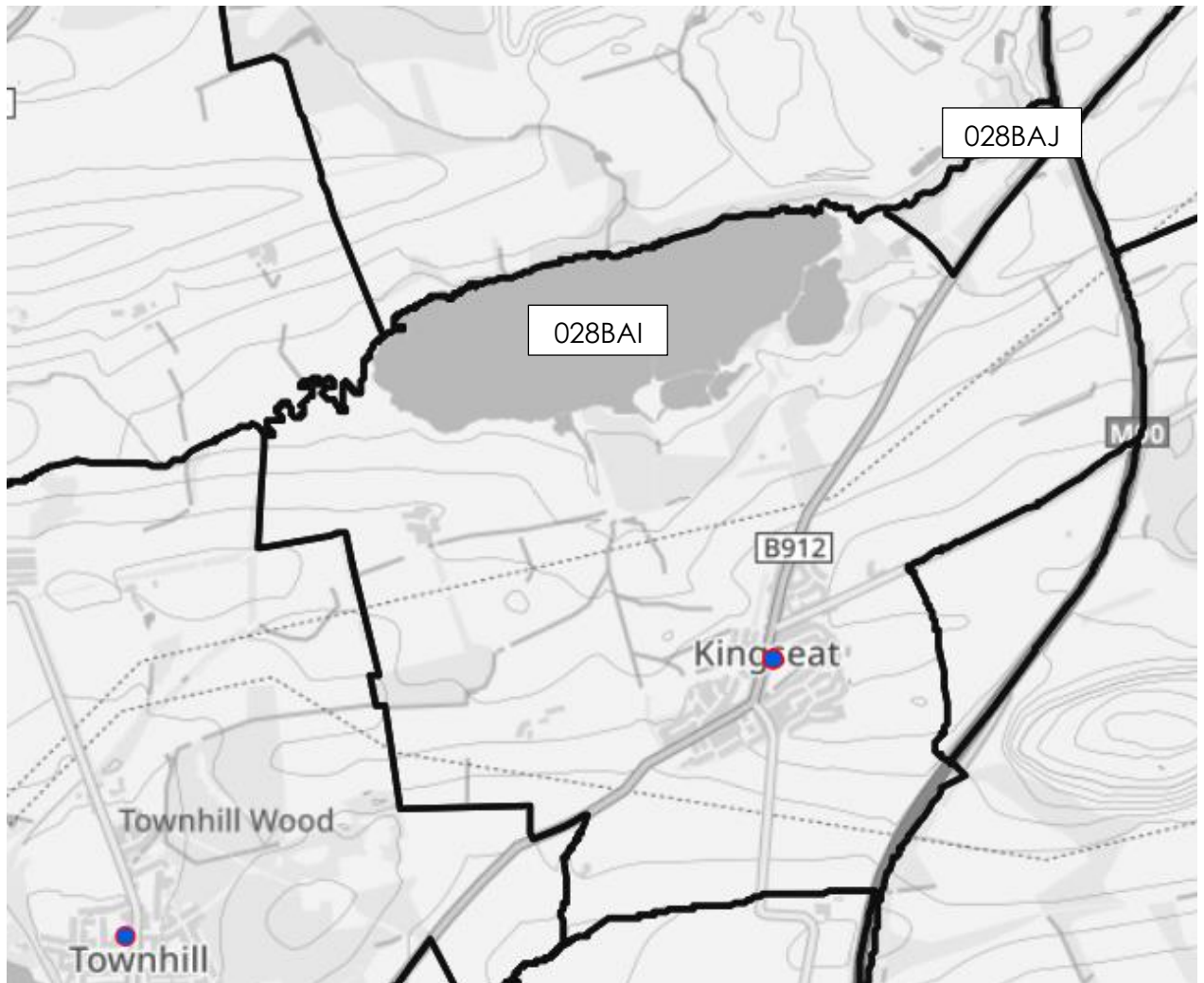

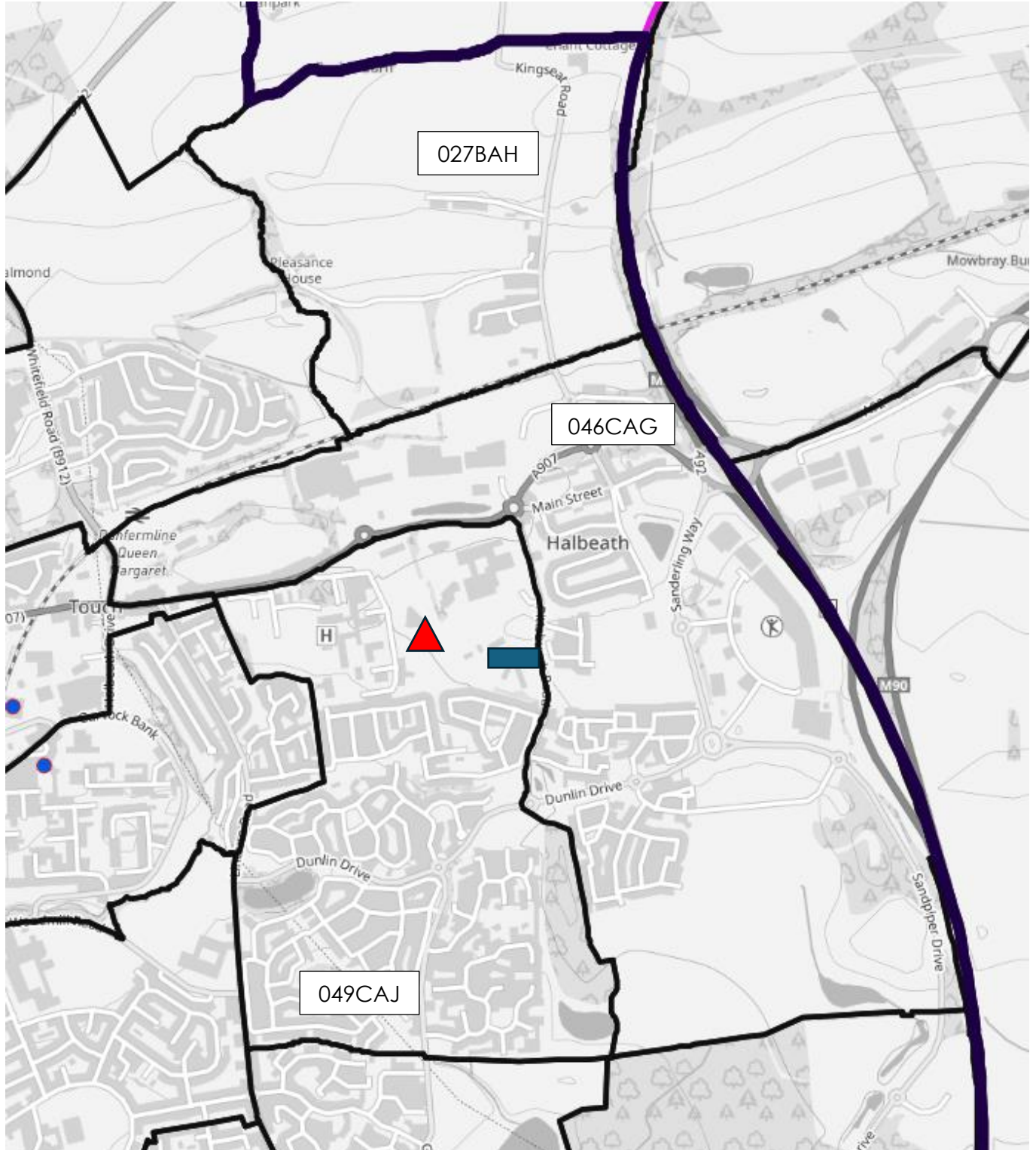

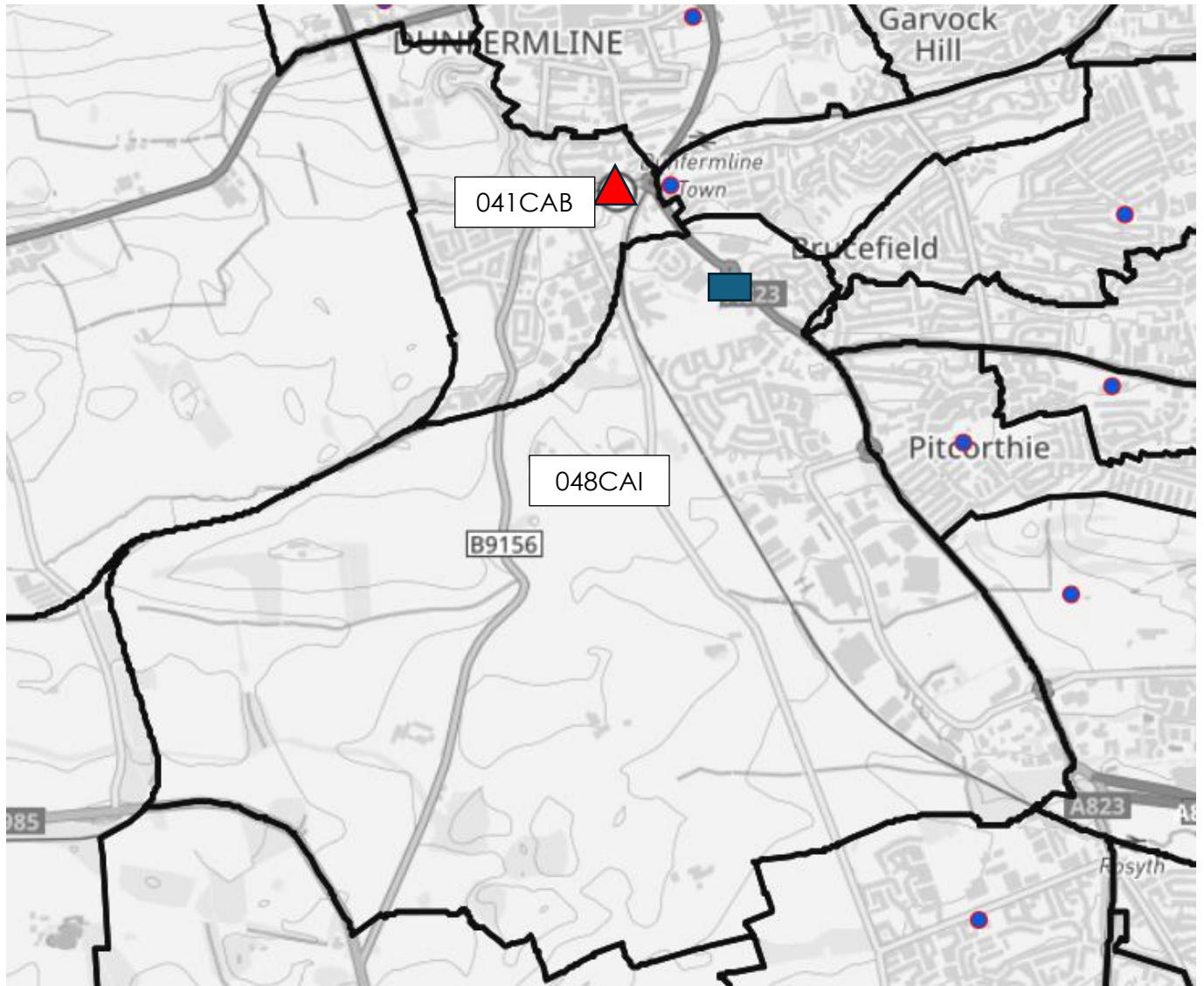

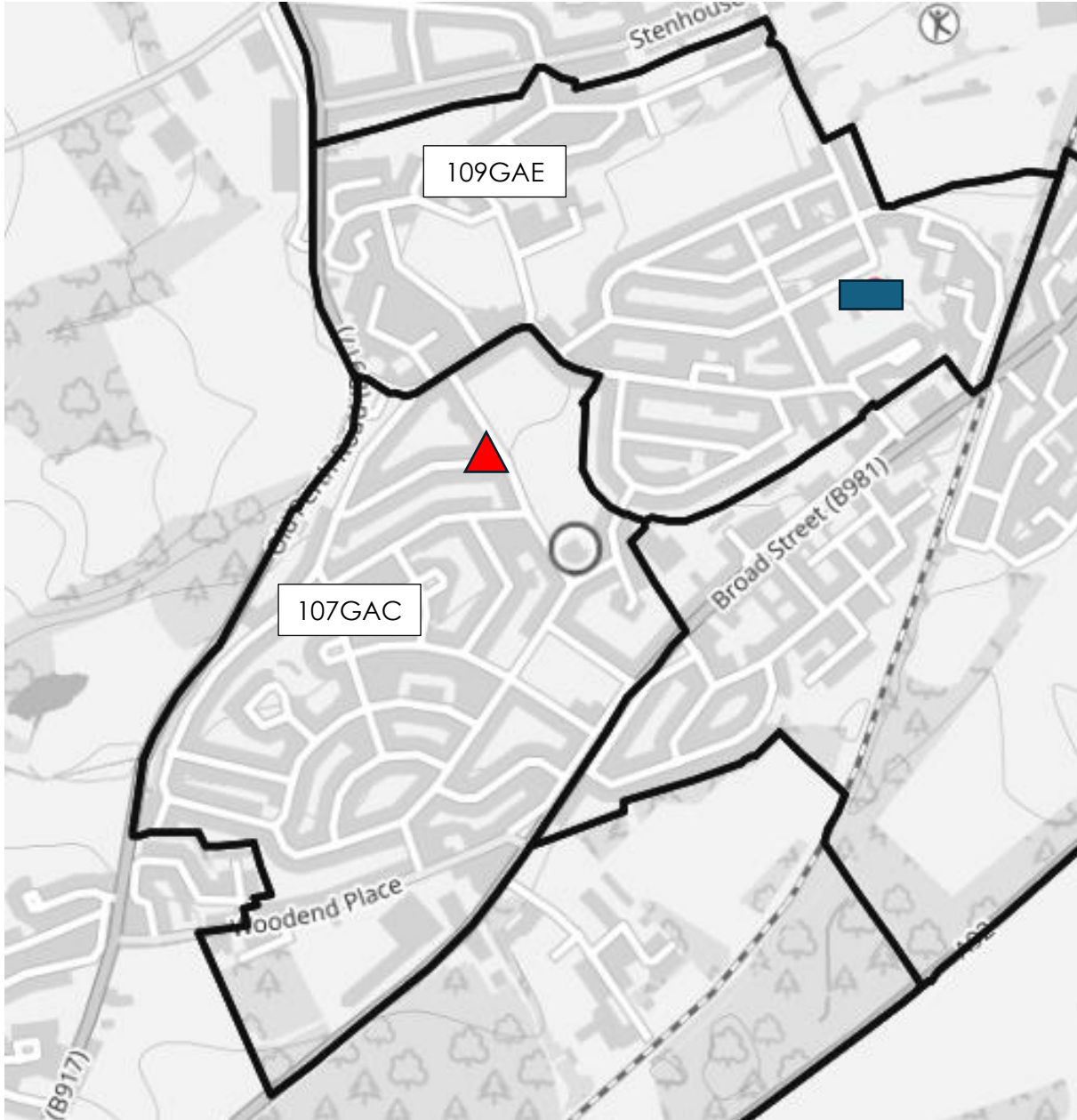

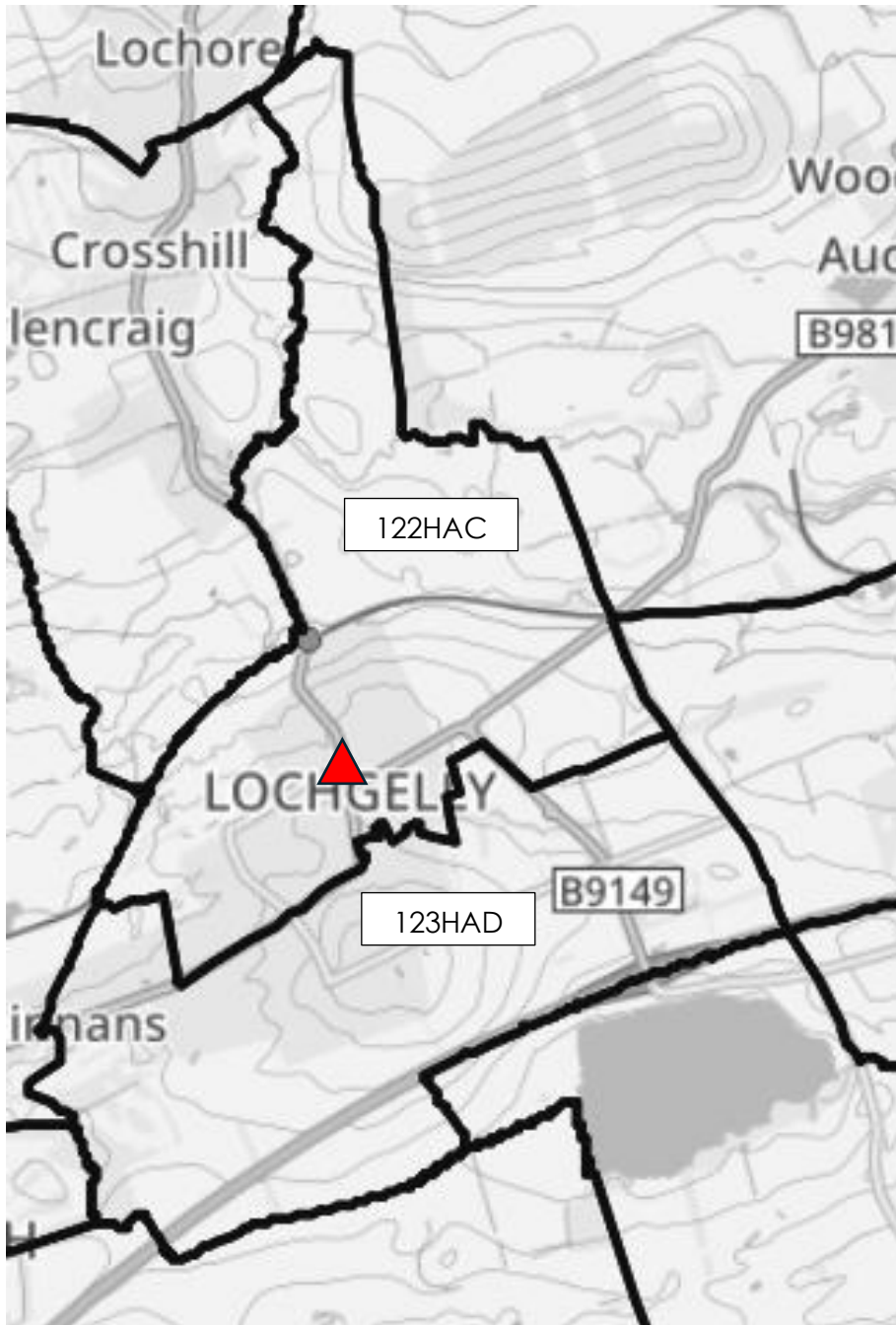

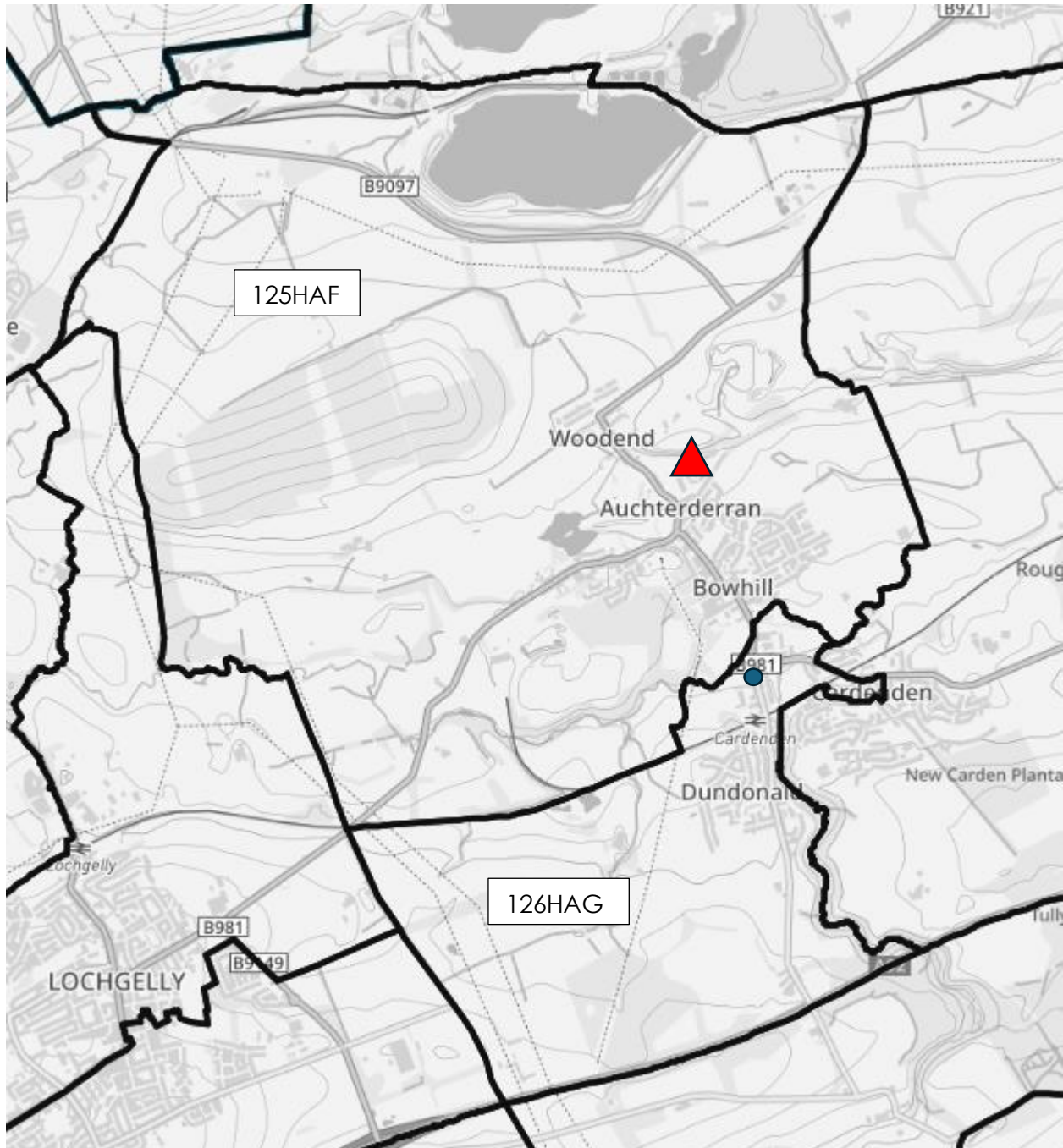

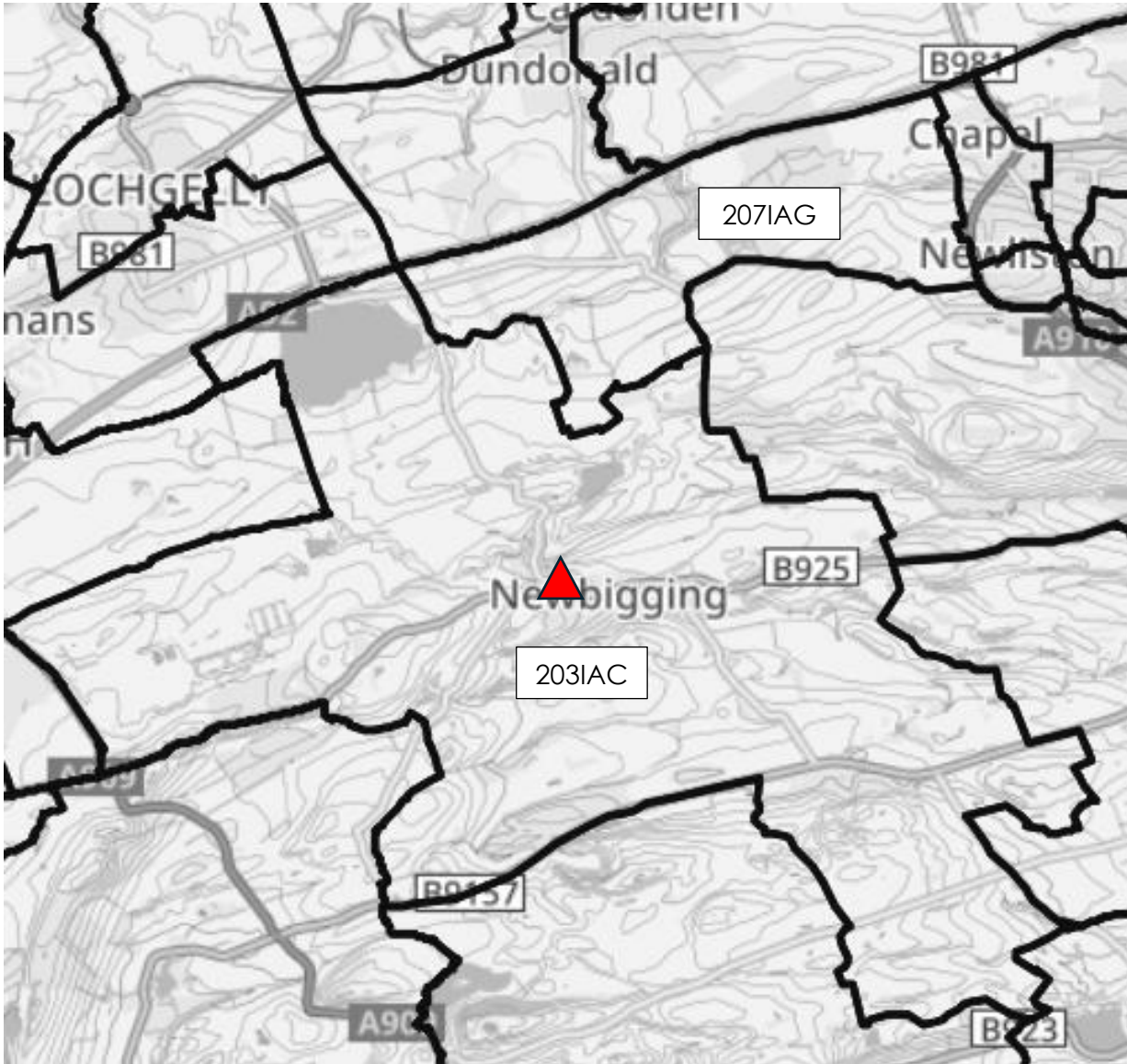

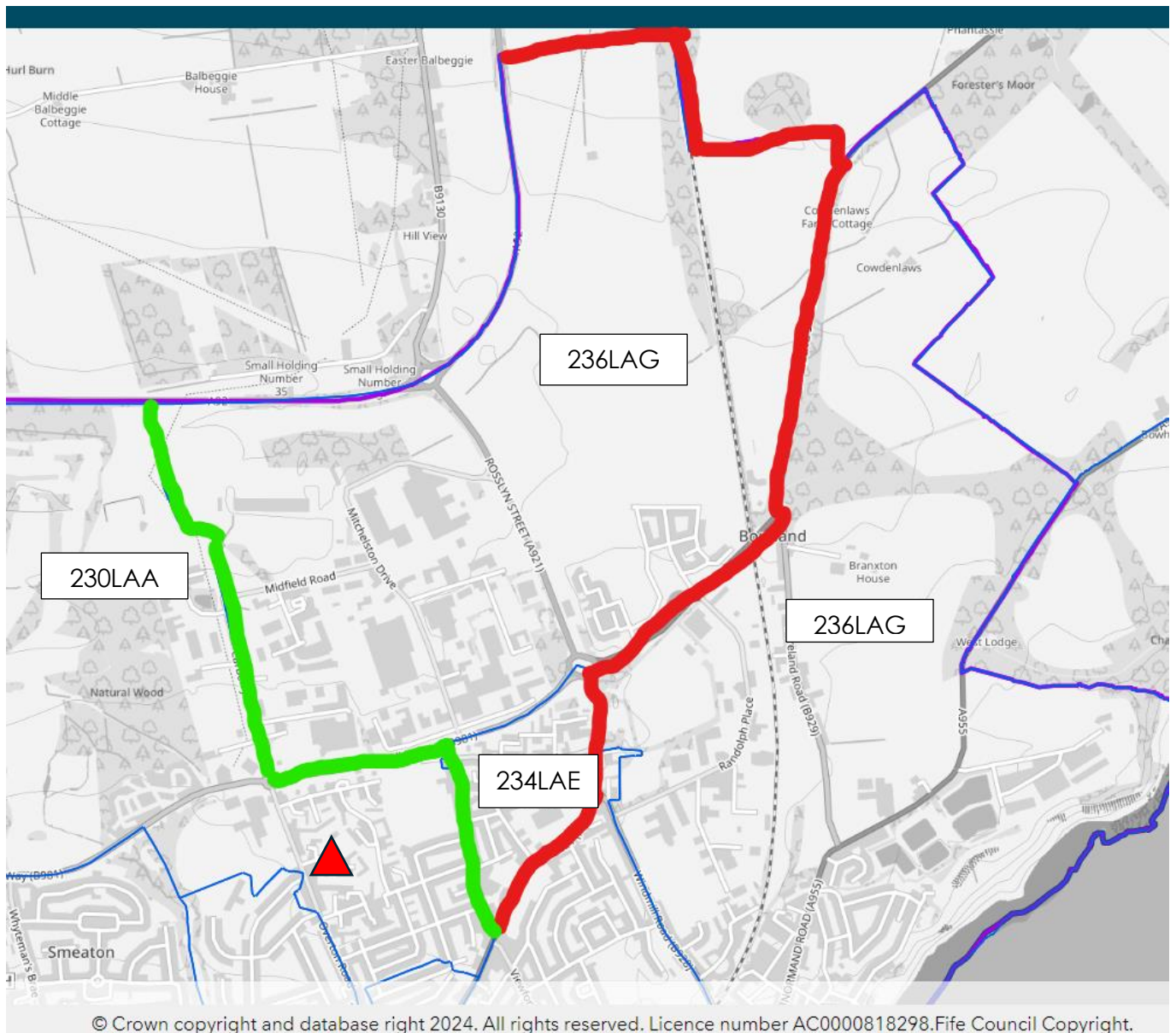
Map 8 – Amendments to polling district boundary for 230LAA

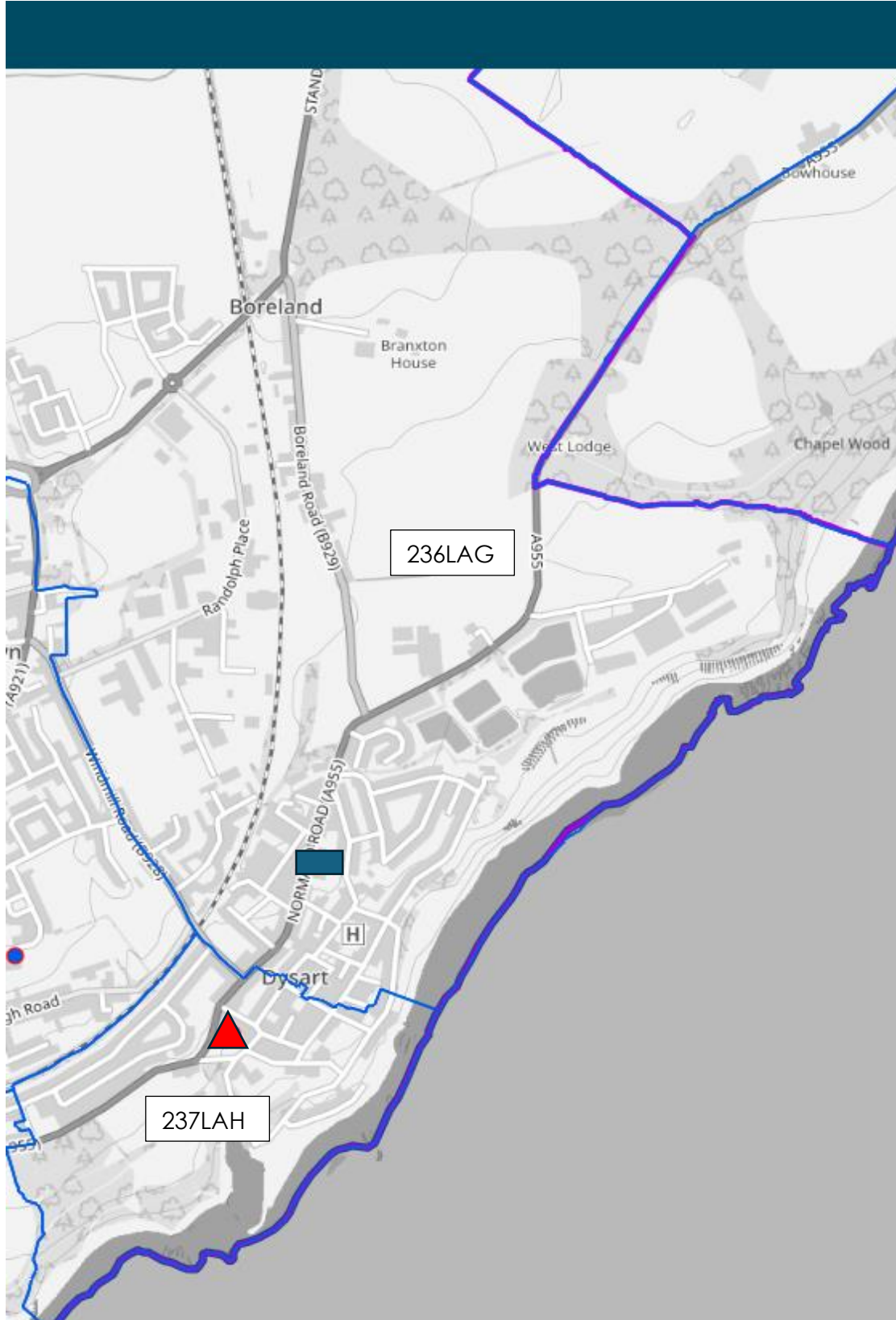

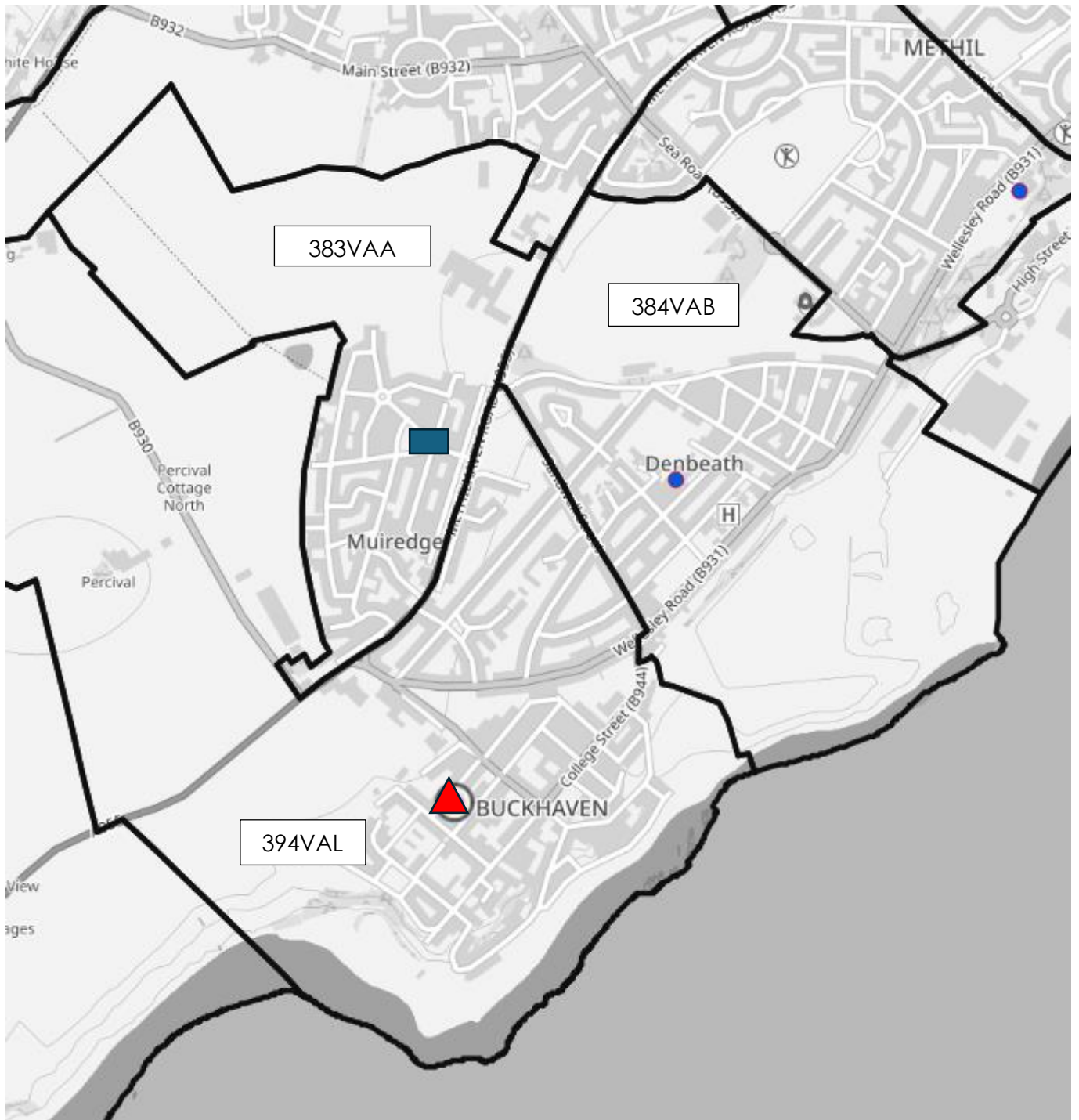

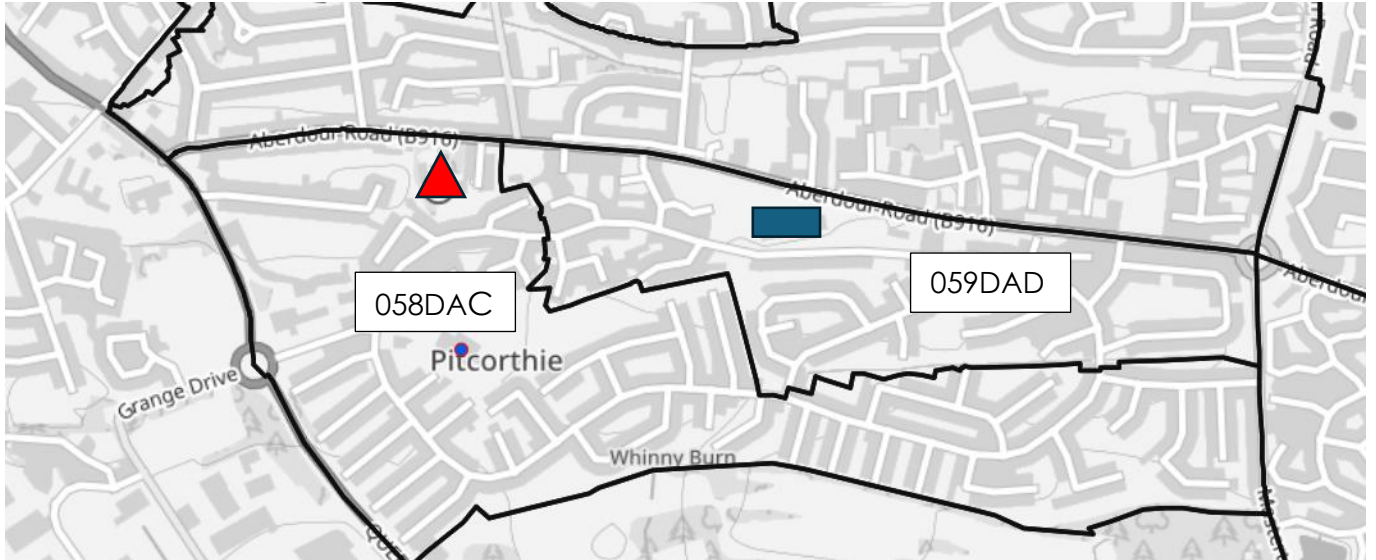

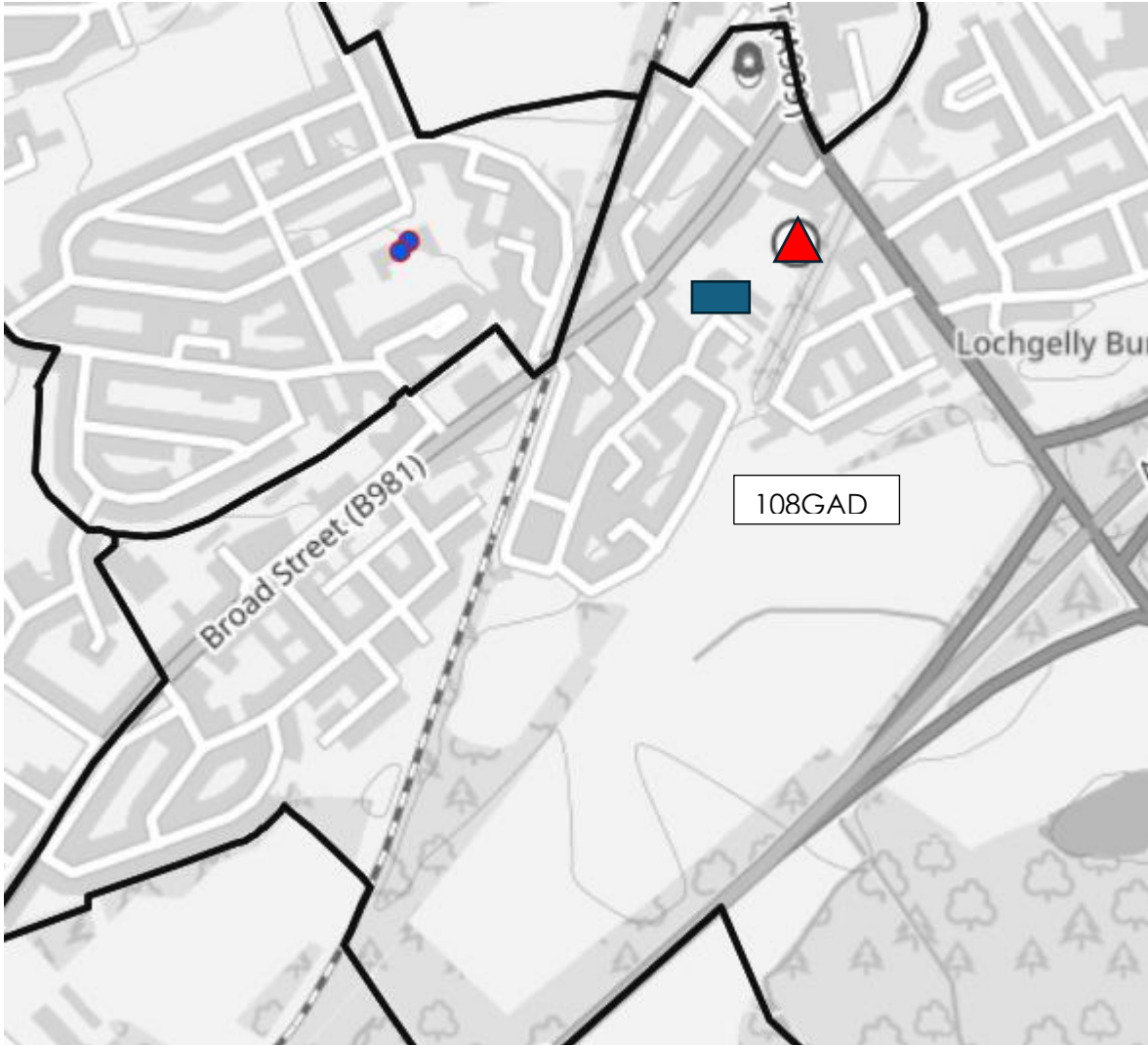

Map 11 – Polling District 108GAD

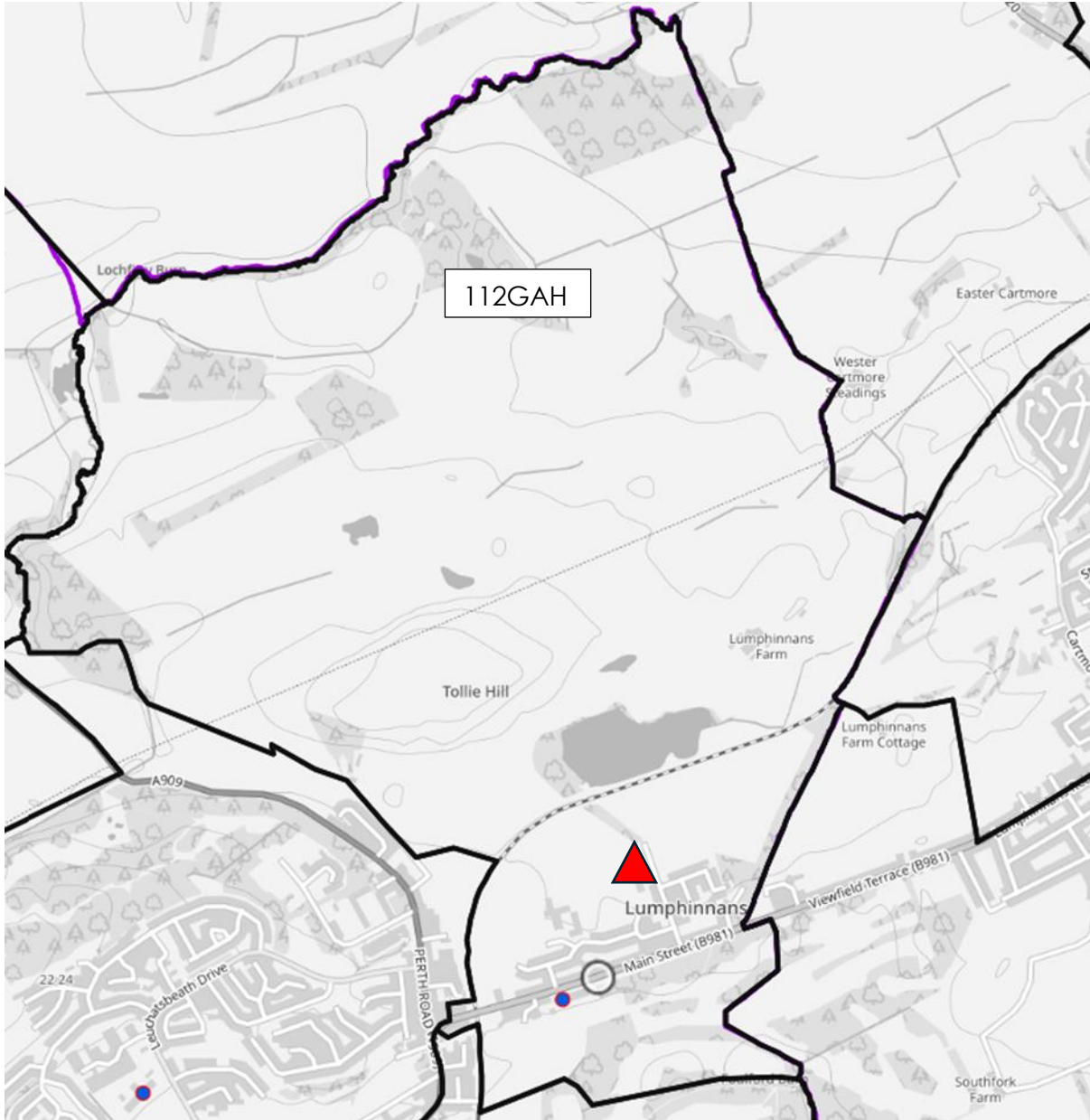

Map 12 – Polling District 112GAH

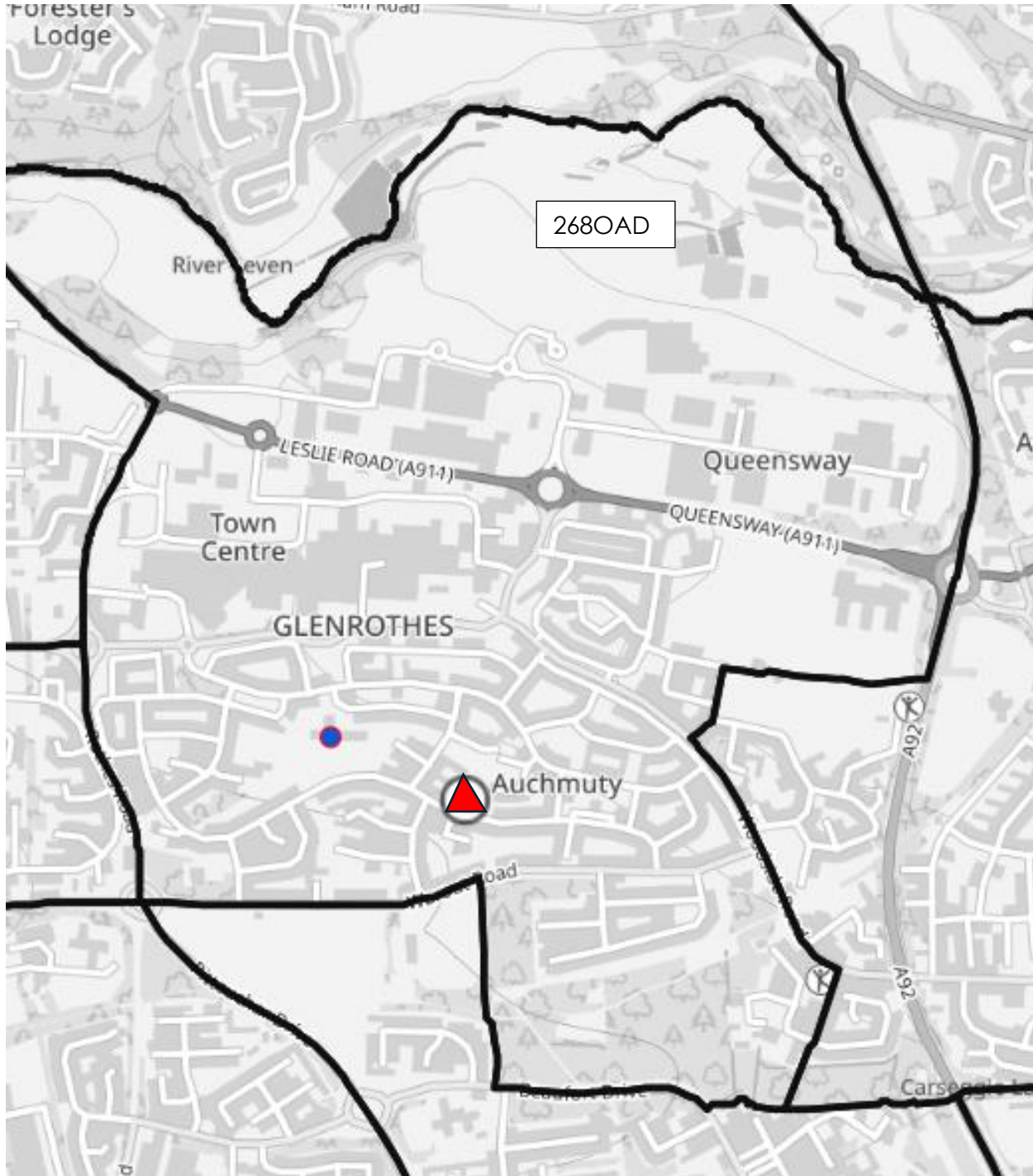

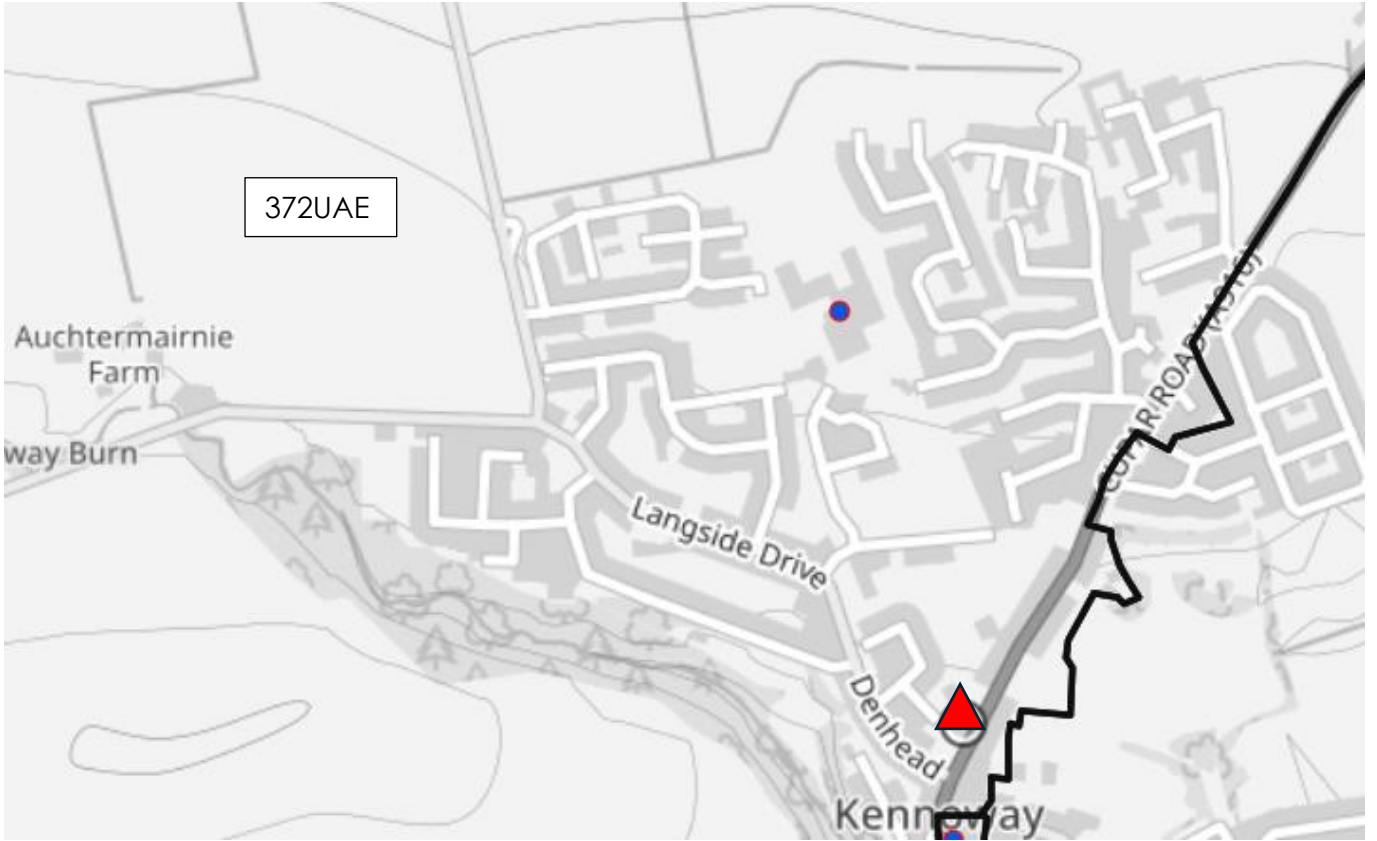
