# Annual Taxi/Private Hire Car Inspection Report for February, March, April and May, 2023 - West Fife Area

Report by: Billy Ferguson, Service Manager, Fleet Operations.

Wards Affected: 1, 2, 3, 4, 5, 6, 7, 8 and 9

#### **Purpose:**

To advise the Committee of the outcome of the Annual Taxi and Private Hire Car Inspection Tests for the West Fife Area.

# **Recommendation:**

It is recommended that:

- (1) random inspection tests, six months after the annual test dates, should be considered, where appropriate, to ensure public safety; and
- (2) the Committee takes any other steps it deems appropriate.

#### **Resource Implication:**

Arrangements may have to be made for eight random inspection tests.

# Legal & Risk Implications:

There is a possible public safety risk if no random inspections are carried out.

#### Policy & Impact Assessment:

## 1.0 Background

- 1.1 This report gives details of the results of the inspections carried out on vehicles operating in West Fife in February, March, April and May, 2023.
- 1.2 Of the 78 vehicles tested in West Fife, 70 passed first time which equated to 90%, 8 vehicles failed but passed on re-test which equated to 10%. The percentage pass rate in August, September & October 2022 was 90% and the percentage fail rate at that time was 10%.
- 1.3 Summaries of the results are attached in Appendix 1 to this report.

# 2.0 Issues and Options

- 2.1 As well as considering random testing of vehicles, the Committee, may deem it appropriate to:
  - invite those operators whose vehicles failed the test to a meeting with the Convener and Vice Convener of the Committee to discuss their maintenance procedures; or
  - consider whether or not to hold a Hearing under paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982 which relates to suspension of the licence.

# 3.0 Conclusions

3.1 The first-time pass rate has remained the same as the last set of tests but is lower than this time last year. The Operators should be reminded that their vehicles should be maintained to a very high standard, at all times.

# **Civic Government Licensing Enforcement Officer Report**

#### Purpose

The purpose of this report is to inform members of the Committee of the activities of the Civic Government Licensing Enforcement Officer from January 2023 – March 2023.

#### Recommendation(s)

The Committee is asked to note the contents of the report.

#### **Resource Implications**

The costs of the officer's activities are met from the existing budget.

#### Legal & Risk Implications

The activities of the Civic Government Licensing Enforcement Officer will ensure the Council are seen to be taking appropriate action to ensure those individuals and companies issued with licences by Fife Council are maintaining high standards and complying with the conditions of the licences issued.

#### Impact Assessment

The activities of the Civic Government Licensing Enforcement Officer will not impact on any one area of the community more than any other. There is therefore no requirement for an impact assessment.

#### Consultation

To ensure the activities of the Civic Government Licensing Enforcement Officer are focussed on areas of particular need, close consultation is held with members of the Civic Government Licensing Team, the Convener and Vice Convener of the Committee, other services within Fife Council and Police Scotland, Fife Division. Licence-holders and members of the public are consulted on a needs basis during enquiries into complaints or compliance checks.

# 1.0 Background

- 1.1 There is one Civic Government Licensing Enforcement Officer working 8am to 6pm Monday to Thursday, with flexibility for working outwith these hours/days. Currently, the officer is primarily working from home. The objectives of this post are to:
  - Make enquiry into complaints relating to the holders of licences under the Civic Government (Scotland) Act 1982
  - To undertake spot checks to ensure the conditions of licences are complied with
  - To take appropriate enforcement action where conditions of licences are not being complied with
  - To improve standards of licence holders
  - To undertake joint inspections with other agencies or services of Fife Council to determine compliance with licence conditions
  - To take action in relation to unlicensed activities and report where necessary to Police Scotland (Fife Division) for consideration of prosecution

# 2.0 Enquiry Activity

- 2.1 This report covers the period from 1 January 2023 31 March 2023.
- 2.2 The Enforcement Officer has undertaken 75 enquiries into complaints, suspected non-compliance with licence conditions, requests for assistance with applications and other licensing issues. Some of these complaints have been straightforward and were easily resolved, others however have been more complex and required extended enquiry and input from other services or agencies. These enquiries included the following licensed activities:

# 2.7 Facebook Update

The Facebook page continues to be a popular means to circulate information relevant to the taxi trade in Fife. Recent posts have included:

- Road Closures and diversions
- Changes to online applications and substitutions
- Information on the annual test schedules

# 2.8 Unmet Demand Monitoring

Regular checks at taxi ranks across Fife and discussion with taxi operators continued during the period covered by this report to assess levels of demand. During the period 16 ranks checks were carried out at various times of the day and night. These observations and consultations show there is no change to the level of demand for taxi services.

There is not therefore considered to be any significant unmet demand for taxi services in Fife. The 2014 Halcrow report on unmet demand remains relevant.

# 3.0 Conclusions

3.1 The work of the Enforcement Officer continues to focus on areas of particular need through the analysis of complaints and observations in the Licensing Unit and at Regulation and Licensing Committee.

Consultation with other services and joint working is continuing to ensure a coordinated approach to enforcement where that is appropriate. **Report Contact**

# Advice

Advice was given to:

- A number of Street Traders on the suitability of trading locations
- Taxi drivers from 2 competing firms regarding their conduct
- 3 taxi drivers in relation to medical issues, disputed fares and driving standards
- A major hotel regarding the use of vehicles for conveying guests
- A national tour company regarding the use of vehicles for conveying tourists

# **Applications refused**

An application for a Street Trader licence was refused after the applicant failed to comply with the requirements despite a lengthy dialogue between him and the Enforcement Officer.

## **Applications withdrawn**

3 Taxi Driver licence applications and a Street Trader licence application were withdrawn after consultation with the Enforcement Officer.

# **Licences Applied For**

24 licences were applied for after enquiries made by the Enforcement Officer into unlicensed trading or expired licences, including 4 second hand car dealers and 3 vehicle operators.

# Monitor

Monitoring is continuing into the activities of a street trader regarding the sounding of chimes and parking issues at taxi ranks.

# **Other Agency**

The police have been notified of a couple of incidents that fall within their remit to investigate

# **Reported to Committee**

One taxi driver has been reported to the Committee for consideration of suspension based on complaints received.

# Unfounded

12 complaints were considered unfounded after investigation; these related to a Public Entertainment Licence, 2 Second Hand dealers, a tattoo parlour, 3 Street Traders, 3 Taxi Drivers and 2 Vehicle Operators.

# Verbal Warning

2 verbal warnings were given for minor indiscretions; these related to a taxi operator and a taxi driver

# Written Warning

2 taxi drivers have received written warnings from the Enforcement Officer; 1 for parking a Fife taxi in a Dundee taxi rank and 1 for driving a taxi through a large puddle at speed causing a pedestrian on the footpath to be soaked.

Section 2.4-2.5 gives quantitative information relating to spot checks conducted by the Enforcement Officer.

This appendix gives detail in relation to some of the outcomes listed in that section.

# Checks were made on:

- 2 Second Hand Dealer licence holders
- 3 Street Traders selling food and drinks
- 8 taxi drivers in taxi ranks

One second hand car dealer was found to have not renewed their licence but applied the very same day, while the other was not displaying the licence on the premises.

There were no issues in relation to the checks carried out with the street trader licence holders and 4 taxi drivers. They were found to be complying with the conditions of their licences.

4 taxi drivers were found not to be displaying their ID badges while driving the taxis. 2 had them in the glovebox or boot, while the other two were sent off the rank to collect the badges from home.
