84. DECLARATIONS OF INTEREST

No declarations of interest were submitted in terms of Standing Order No. 22.1.

85. MINUTE

The committee considered the minute of meeting of the North East Fife Area Committee of 21 June 2023.

Decision

The committee agreed to approve the minute.

86. PRESENTATION - CUPAR NOW THIRD ANNUAL REPORT

In the absence of a representative from Destination Digital due to connection issues, this item was continued until alternative arrangements could be made.

87. OBJECTION TO PROPOSED PARKING RESTRICTION – ORCHARD FLAT, AUCHTERMUCHTY

The committee considered a report by the Head of Roads and Transportation Services relating to two objections to a proposal to introduce “No Waiting at Any Time” restrictions on Orchard Flat, Auchtermuchty.

Decision

The committee agreed to set aside the objections to the proposed Traffic Regulation Order (TRO) introducing the “No Waiting at Any Time” restrictions on Orchard Flat, Auchtermuchty as shown in drawing no. TRO/22/67 attached to the report - to allow the Order to be made and the restrictions put in place.

88. BALGOVE ROAD AND GUTCHARDS WAY, GAULDRY – 20MPH SPEED LIMIT

The committee considered a report by the Head of Roads and Transportation Services relating to proposals for an extension of the 20mph speed limit in Gauldry, to include the roads within the new residential development on the land south of Balgove Road.

Decision

The committee, in the interests of road safety:-

- (1) agreed to the promotion of a Traffic Regulation Order (TRO) to introduce the restrictions detailed in drawing no. TRO23_29 attached to the report with all ancillary procedures; and
- (2) authorised officers to confirm the Traffic Regulation Order within a reasonable period unless there were objections.

89. GRANGE ROAD, ST ANDREWS – 20MPH ZONE AND 30MPH EXTENSION

The committee considered a report by the Head of Roads and Transportation Services relating to proposals for the inclusion of a new residential development within an existing 20mph zone and the extension of a 30mph speed limit on Grange Road, St Andrews.

Decision

The committee, in the interests of road safety:-

- (1) agreed to include the new roads within the existing 20mph TRO and to extend the existing 30mph speed limit, both as shown in drawing TRO/23/31 attached to the report, with all ancillary procedures; and
- (2) authorised officers to confirm the Traffic Regulation Order within a reasonable period unless there were objections.

90. MANSE ROAD, SPRINGFIELD – 20MPH ZONE EXTENSION

The committee considered a report by the Head of Roads and Transportation Services relating to proposals for the inclusion of a new residential development within an existing 20mph zone to cover new development on land to the east of Manse Road, Springfield.

Decision

The committee, in the interests of road safety:-

- (1) agreed to include the new roads within the existing 20mph TRO zone as shown in drawing TRO/23/32 attached to the report, with all ancillary procedures; and
- (2) authorised officers to confirm the Traffic Regulation Order within a reasonable period unless there were objections.

91. PITLETHIE ROAD, LEUCHARS – 20MPH ZONE EXTENSION

The committee considered a report by the Head of Roads and Transportation Services relating to proposals for the inclusion of a new residential development within an existing 20mph zone to cover new development on land to the east of Pitlethie Road, Leuchars and Pitlethie Road north for 87m to the extent of the existing 30mph speed limit.

Decision

The committee, in the interests of road safety:-

- (1) agreed to include the new roads within the existing 20mph TRO as shown in drawing TRO/23/33 attached to the report with all ancillary procedures; and
- (2) authorised officers to confirm the Traffic Regulation Order within a reasonable period unless there were objections.

92. TAYPORT COASTLINE – SALT MARSH PLANTING

The committee considered a report by the Head of Roads and Transportation Services seeking approval to work in a formal partnership with the University of St Andrews to carry out salt marsh planting along the Tayport frontage to augment and extend previous salt marsh planting trials.

Decision

The committee:-

- (1) noted the potential coast protection and biodiversity benefits that were likely to result from this project; and
- (2) agreed that the Council enter into a formal partnership agreement with the University of St Andrews to deliver this project - to include an annual financial commitment of £10,000 per annum for three years or £15,000 per annum for two years, as required to suit the project funding mechanisms - from the existing coastal revenue budget to support the project.

Councillor Holt joined the meeting following consideration of the above item.

93. COMPLAINTS UPDATE

The committee considered a report by the Executive Director, Communities, providing an overview of complaints received relating to the North East Fife area for the year from 1 April 2022 to 31 March 2023.

Decision

The committee noted the report on complaints received, including the complaints responded to in target timescales and the proportionality of Service complaints.

94. SUSPENSION OF PARKING CHARGES, LAMMAS MARKET, ST ANDREWS

The committee considered a report by the Head of Roads and Transportation Services seeking approval to recover lost income due to the suspension of on- street parking charges during the Lammas Market in August 2023.

Decision

The committee agreed:-

- (1) to support the recovery of £7,400 in lost income due to suspended on- street parking charges during the Lammas Market from the budget allocated to North East Fife Area Committee for devolved parking initiatives; and
- (2) that a briefing note outlining the arrangements for recovery of lost income be circulated to members.

95. NORTH EAST FIFE AREA COMMITTEE FORWARD WORK PROGRAMME

The committee considered a report by the Executive Director, Finance and Corporate Services relating to the workplan for future meetings of the committee.

Decision

The committee:-

- (1) noted the North East Fife Area Committee Forward Work Programme; and
- (2) agreed to request that officers include the grassland strategy in the Grounds Maintenance Service, Domestic Waste and Street Cleansing Annual Review report scheduled for the meeting on 6 December 2023.

Councillor Ann Verner advised that this was the last meeting that Elizabeth Mair, Committee Officer, would be attending prior to her retirement and, on behalf of the committee, thanked Elizabeth for her work in supporting members over the years. East Neuk Skatepark – Stage 1 Appraisal

Wards Affected: 19

Purpose

To advise the committee of the outcome of the Council-led options appraisal carried out in relation to the East Neuk Skatepark.

Recommendations

It is recommended that committee:

- Review the Stage 1 Appraisal undertaken on the options for the East Neuk Skatepark
- Note the process to gather the views of the local identified stakeholders
- Note the additional views gathered from the stakeholder consultations
- Consider whether the additional evidence presented from the stage 1 appraisal with stakeholders on the three suggested site options is sufficient to allow a decision to be taken by committee on a suitable site to move to Stage 2.
- Consider if the resource allocation should be used towards Fife Council requesting technical appraisals at each of the sites to provide further consideration of the topography including soil depth and drainage. These are estimated at approximately £5,000 per site.

Resource Implications

The Area Committee previously approved the allocation of £20,000 from the Area Capital Budget 2021-23 towards the overall cost of the East Neuk Skatepark. This contribution is only part funding and further work is required to secure additional funding to deliver the full scope of the project. Project design and development will require resources from council teams and potentially external consultants.

Legal & Risk Implications

There are no significant legal or risk implications.

Impact Assessment

An impact assessment will be required during the design phase of the project.

The consultation reported was led by the Team Manager Community Development with support from community education workers in the team.

1.0 Background

- 1.1 On 16 March 2022, North East Fife Area Committee agreed to allocate £20k of funding from the Area Capital Budget 2021-23 towards the overall cost of the East Neuk Skatepark. This contribution was only part funding and further work to secure additional funding to deliver the full scope of the project. The committee also *“noted that further consultation would be carried out in relation to the options appraisal for the East Neuk Skatepark”*. (2022 NEFAC 213 – para 428).
- 1.2 A report on the community consultation was provided at the East area committee on the 26 April 2023 (2023 NEFAC: 65-86) which was considered by the members. An amendment to the motion was accepted (2023 NEFAC:71) requesting officers to undertake an options appraisal and project design for an East Neuk Skate Park, for further consideration by committee and that Bankie Park and other sites including Waid Academy should be appraised. The motion requested that officers work with the local community to develop the options appraisal and project design incorporating the wider greenspace impact and assessing other impacts for the project. Each option should be scored for its effect on community cohesion.

2.0 Options Appraisal

- 2.1 The Community Manager met with Cllr Corps, Cllr Dillon and Wille Rennie MSP at their request following the agreed motion and the following stages were agreed,
Stage 1 – Options Appraisal
 - Define what constitutes a successful skate park using evidence from national bodies, Police Scotland and discussions with community councils with skateparks with an update provided to members when this has been decided on.
 - Meetings with stakeholders (ASPG, KPBG/Residents, CC) to make judgement on community cohesion. This factor should not, however outweigh any other final decision.
 - Assess which site from Bankie Park, Waid Academy and Pittenweem meets the definition and carry out further options appraisal.
 - Put forward a recommendation for the site that best meets definition for NEFAC to take a judgement on**Stage 2 – Design**
 - Work with ASPG to produce a design for recommended site & carry out the necessary assessments around noise, greenspace etc.
 - Sessions with stakeholders to present design before final approval from NEFAC.
- 2.2 Skate park Scotland was contacted to provide a definition and were directed to the website <https://skateboardscotland.com/guidelines-for-building-a-community-skatepark/>
This was used as a basis for the previous community group consultation and the section on suitable location was taken into consideration for the reported process design of the stakeholder sessions.

- 2.3 Skatepark Scotland advised that designs for parks are unique to the different sites and consideration of the topography including soil depth and drainage are important factors that can change a design in terms of how deep a bowl is for example. Sites that allow for good and natural drainage should be considered. The advice on design in terms of obstacles, is to include a mix of ramp and street depending on available space and budget. Having a good mix of both appeals to beginners and more experienced users. Increasingly there is a demand for flatter areas for roller-skaters and very young kids and beginners too. This is something that has been missed on a lot of the older skateparks and this can prevent people confidently getting started.
- 2.4 The smaller skatepark in Portobello at a cost of £75,000 was suggested a good example of a collaboration with the council and addresses all these elements which cover street, transition, beginner space and more challenging space.
- 2.5 Skatepark Scotland advised that all professional skatepark contractors offer a design service and will work with the user group to work in any specific requests whilst using their experience to keep it practical and usable.
- 2.6 Police Scotland responded their community officers would be happy to get involved in local discussions but was not within their remit to suggest a suitable location as there are many factors to be considered. They shared a successful skate park is one which has support of the local community, buy-in from all partners and is seen as an area that can contribute to the increased health, wellbeing, accessibility and social inclusion of all. It should of course be free from crime, or the fear of crime.

3.0 Stakeholder Sessions

- 3.1 Stakeholder groups and individuals were contacted who were involved or based within the vicinity of each of the three suggested sites. This included representatives from Education, Community Use, Anstruther skate group, Pittenweem community council, Pittenweem west braes project, keep bankie park green, keep bankie park green again, Friends of bankie Park, residents of bankie park area, East Neuk Centre Trust, and Anstruther Community Council were invited to take part in further discussions.
- 3.2 The Place Standard tool was used at the stakeholder meetings as a method to measure and assess responses in key category areas that would be relevant to the skatepark project. This included, Moving Around, Public Transport, Traffic and Parking, Streets and Spaces, Natural Space, Play and Recreation, Facilities & Amenities, social contact, feeling safe and Care & Maintenance.
- 3.3 At each of the meetings, representatives were asked questions related to the category and encouraged to have a discussion and reach a consensus on the score to be placed for each of the sites. The rating method is 1 –7 where 1 means there is a lot of room for improvement and 7 means there is little room for improvement. In addition, group comments were taken on board at each of the meetings.
- 3.4 All of the scores were collated for each of the three site areas and these are presented at Appendix 1.
- 3.5 Additional comments were gathered at the stakeholder meetings and are presented in appendix 2.

4.0 Conclusion

- 4.1 All of the stakeholders invited along were in favour a skatepark facility for young people in the area.
- 4.2 Each of the site's present advantages and disadvantages as shown in appendix 1.

Waiting Restriction Amendments – Cupar Road, High Street & Blyth Street, Newport

Report by: John Mitchell – Head of Roads & Transportation Services

Wards Affected: Ward No. 17 – Tay Bridgehead

Purpose

The purpose of this report is to allow the North East Fife Area Committee to consider proposals to amend existing restrictions and introduce a 'No Waiting At Any Time' prohibition in Cupar Road, Newport.

Recommendation(s)

It is recommended, in the interests of traffic management and road safety, that Committee:

- (1) agrees to the promotion of a Traffic Regulation Order (TRO) to revoke The Fife Council (High Street, Newport-on-Tay) (Amendment) Order 2021 and introduce the parking restrictions detailed in drawing no. TRO23_42 (Appendix 1) with all ancillary procedures; and
- (2) authorises officers to confirm the TRO within a reasonable period unless there are objections.

Resource Implications

The cost to formally promote this TRO will be approximately £2,300, which covers Roads & Transportation Services' and Legal Services' staff costs, advertising, and installation. This will be met from approved Service budgets.

Legal & Risk Implications

There are no known legal or risk implications.

Impact Assessment

The general duties section of the impact assessment and the summary form have been completed. No negative impacts have been identified.

Consultation

The local Ward Councillors, Newport, Wormit & Forgan Community Council, Parking Management team and Police Scotland are aware of the proposal.

Formal consultation required by the Road Traffic Regulation Act 1984 for the TRO process will be carried out through the posting of legal notices in a local newspaper and on the affected length of roads. In addition, details of the proposed TRO will be made available on Fife Council's website.

1.0 Background

- 1.1 The Fife Council (High Street, Newport-on-Tay) (Amendment) Order 2021 (plan shown in Appendix 2) was made in May 2021, following a request from the Community Council to have a disabled bay provided outside the Spar which, at the time, housed the Post Office. Between the making of the TRO and the changes being done on the ground the situation changed, whereby the Post Office closed and the Community Council requested that the changes were abandoned to retain the two bays in Blyth Street, as they were then well placed for the Blyth Hall which is the venue for the new Outreach PO service.
- 1.2 Cupar Road has a combination of business and residential properties with shops concentrated at the west end. Blyth Street contains public car parking. St Mary's Lane is narrow with limited space for vehicles to manoeuvre. It is also the location of the community centre.
- 1.3 There have been reports of obstructive parking on Cupar Road at the junctions with St Mary's Lane and Blyth Street.

2.0 Issues and Options

- 2.1 In response to the request of the Community Council to cancel the disabled bay on High Street and retain the two in Blyth Street, it is proposed to revoke the 2021 Order to allow the original restrictions to remain.
- 2.2 On Cupar Road, to stop vehicles from parking between the bus stop and the junction of Blyth Street and at the junction of St Mary's Lane it is proposed to introduce "No waiting At Any Time" (double yellow line) restrictions, as shown in Appendix 1.
- 2.3 St Mary's Lane has been approved for a Cat 1 resurfacing scheme for the current financial year. If approved, the TRO implementation will be carried out in conjunction with this scheme.

3.0 Conclusions

- 3.1 It is considered, in the interests of traffic management and road safety, that these traffic restrictions be promoted.

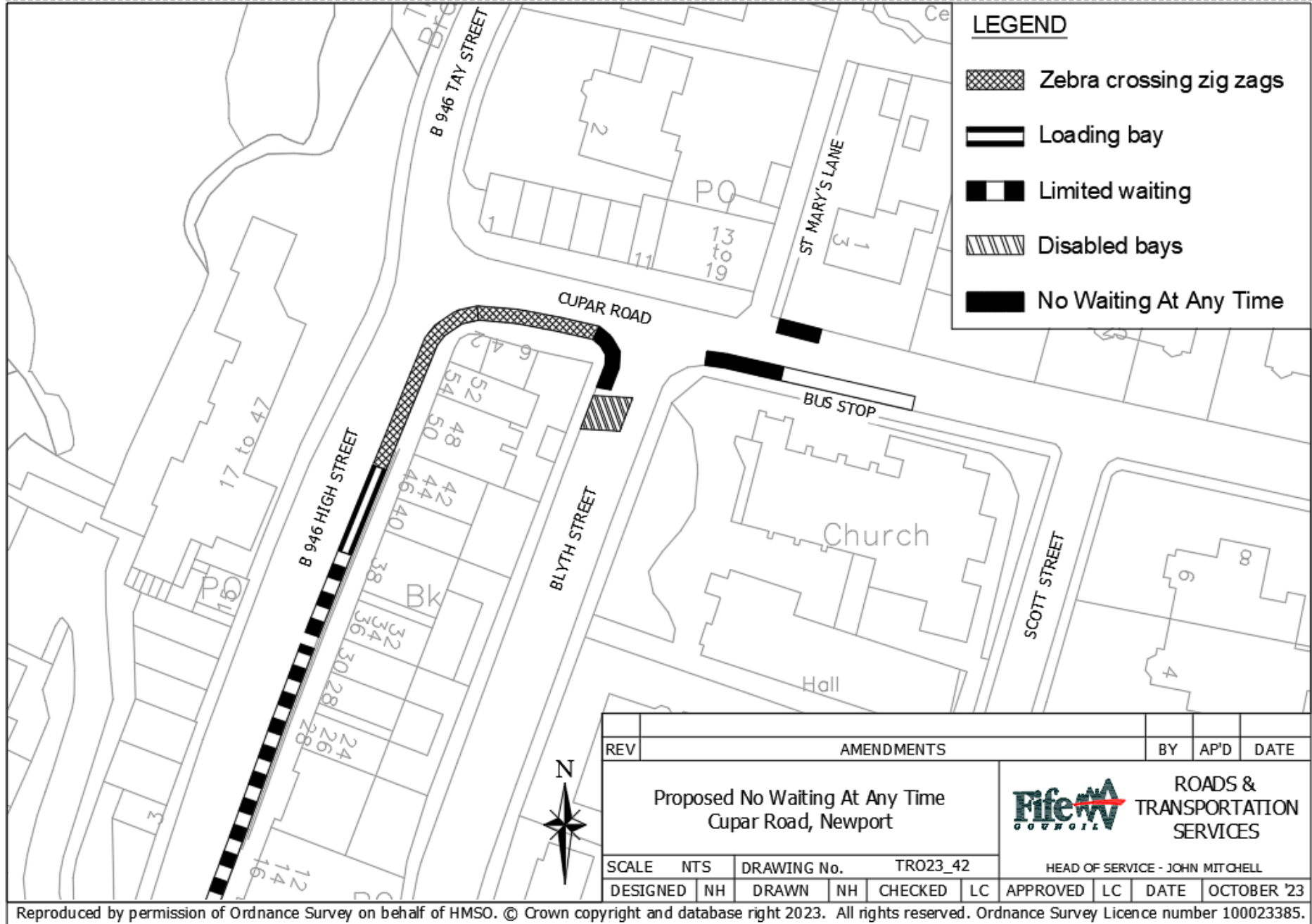

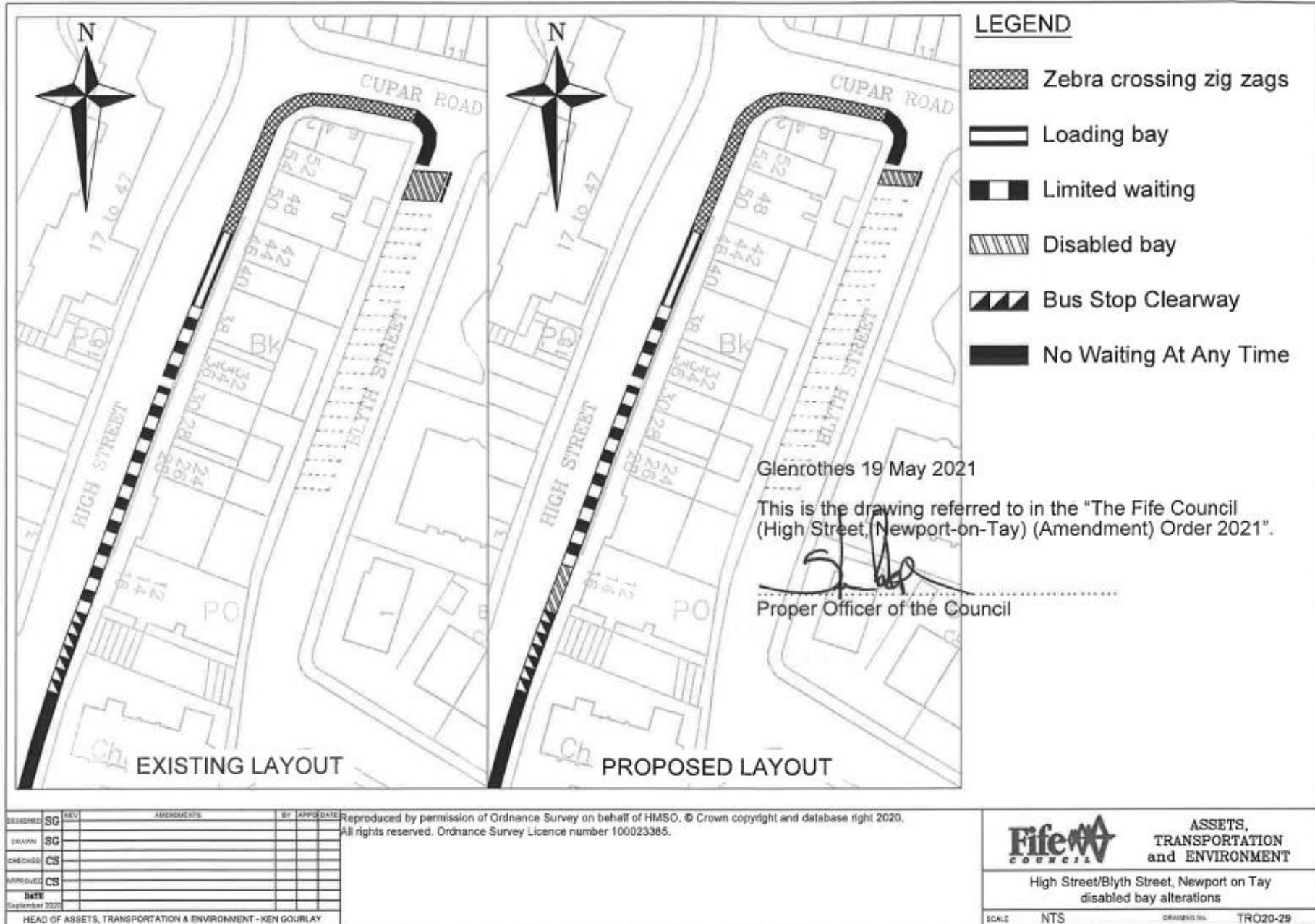

Purpose

The purpose of this report is to allow the North East Fife Area Committee to consider proposals to introduce 'No Waiting At Any Time' restrictions in Shanwell Road South, Tayport.

Recommendation(s)

It is recommended, in the interests of traffic management and road safety, that Committee:

- (1) agrees to the promotion of a Traffic Regulation Order (TRO) to introduce the restrictions detailed in drawing no. TRO23_38 (Appendix 1) with all ancillary procedures; and
- (2) authorises officers to confirm the Traffic Regulation Order within a reasonable period unless there are objections.

Resource Implications

The cost to formally promote this TRO will be approximately £2,500, which covers Roads & Transportation Services' and Legal Services' staff costs, advertising, and delivery of the new infrastructure. This will be met from approved Service budgets.

Legal & Risk Implications

There are no known legal or risk implications.

Impact Assessment

The general duties section of the impact assessment and the summary form have been completed. No negative impacts have been identified.

Consultation

The local Ward Councillors, Tayport Community Council, Parking Management team and Police Scotland are aware of the proposal.

Formal consultation required by the Road Traffic Regulation Act 1984 for the TRO process will be carried out through the posting of legal notices in a local newspaper and on the affected length of roads. In addition, details of the proposed TRO will be made available on Fife Council's website.

1.0 Background

- 1.1 Shanwell Road South gives access to commercial premises and the access road to Tentsmuir, which is managed by Fife Coast and Countryside Trust. Clear access must be maintained for the bus turning circle.
- 1.2 The road is narrow with limited space for turning vehicles and is an attractive location for individuals visiting Tentsmuir Forest and the Fife coast.
- 1.3 Links Road North has a public car park for those who wish to access Tentsmuir for recreation.

2.0 Issues and Options

- 2.1 Obstructive parking has been reported in the section of road between the factory access road and Lundin Bridge. The bridge is the extent of the road adoption.
- 2.2 It is proposed to provide "No Waiting At Any Time" (double yellow line) restrictions from the end of adoption to the immediate east of Lundin Bridge westwards to a point east of no's 46/48 as shown in Appendix 1.
- 2.3 The existing 'keep clear' markings would be removed, as these would be superseded by the proposed double yellow lines.

3.0 Conclusions

- 3.1 It is considered, in the interests of traffic management and road safety, that these traffic restrictions be promoted.

Parking Congestion Measures in North East Fife

Report by: John Mitchell, Head of Roads & Transportation Services

Wards Affected: 16, 17,18,19 & 20

Purpose

The purpose of this report is to update Members following the motion on parking congestion measures raised at North East Fife Area Committee on 24 November 2021 (2021 NEFAC 206 para 402 refers).

Recommendations

It is recommended that Committee notes:

1. the issues highlighted relating to Controlled Parking Zones and residents parking permits in Fife and other Scottish Local Authority areas;
2. that officers consider that the residents' parking permit scheme remains the most appropriate means to support residents within towns and villages in North East Fife; and
3. the Local Transport Strategy considers parking at a strategic level and will inform a subsequent review of the Fife Parking Strategy to consider issues in more detail.

Resource Implications

The management of parking is met from approved Service budgets.

Legal & Risk Implications

There are no known legal risks.

Impact Assessment

An Equality Impact Assessment and a Fife Environmental Assessment Tool (FEAT) assessment are not required because the report does not propose a change or revision to existing policies or practices.

Consultation

Finance and Legal Services were consulted in the development of this report.

1.0 Background

- 1.1 A motion was agreed at NEFAC on the 24 November 2021 (2021 NEFAC 206 – Para. 402 refers):
- Many parts of North East Fife suffer from parking congestion which is inconvenient for residents and visitors and a potential danger to the public when emergency services are inconvenienced. North East Fife Area Committee requests a report from officers outlining how measures such as residential parking permit or controlled parking zone schemes have been used by Fife Council and other Scottish local authorities to ease parking congestion and an officer view on the opportunities that these measures may present to improve parking congestion in North East Fife. North East Fife Area Committee also agrees that officers consider how best to include any of these measures as part of the current review of local transport strategy (due to conclude in 2022) in so far as that applies to their potential use in North East Fife.*
- 1.2 The management of car parking plays an important role in supporting town centre vitality, reducing congestion and traffic fumes, improving air quality, and improving access to public transport interchanges. Parking charges are a key tool in maximising the turnover of spaces to allow access for shoppers and businesses whilst also encouraging sustainable travel as an attractive choice.
- 1.3 The current parking management measures in Fife are designed to provide flexible options for customers, whilst aiming to encourage a turnover of visitors in busy areas. Turnover of parking in short stay areas, along with options for accessible, off-street, longer stay parking is designed to support local communities, visitors, and businesses.
- 1.4 Access to parking within Fife operates on a shared-use basis. This means that parking spaces can be used by those eligible for a residents' parking permit, season ticket holders and pay-and-display users. This gives more flexibility in the use of the available parking and helps to maximise capacity.
- 1.5 Controlled Parking Zones are typically adopted in cities when there are large areas with common on-street restrictions and / or charges during specified times and this can help reduce the need for street furniture. Fife does not have any Controlled Parking Zones. In North East Fife, due to the size of the towns and the unique detail of parking restrictions in many historic areas, a Controlled Parking Zone would be inappropriate to manage parking.
- 1.6 Resident parking schemes have many benefits for residents. However, restrictions are still in place for other users, including visitors. They are not always ideal in all locations and requests need to be reviewed on a case-by-case basis.
- 1.7 Demand for parking in some towns in North East Fife can be high, especially during the summer when many visitors are attracted to the area. Therefore, to manage this, a Pay & Display zone is in place within St Andrews and there are on-street parking restrictions within Cupar, Anstruther, Falkland, Newburgh, Newport-on-Tay, Tayport, Pittenweem & Crail.
- 1.8 On-street parking demand in St Andrews, Cupar and Anstruther town centres is supported by both free and charged off-street car parks, which help to ease on-street congestion and provide accessible parking close to the amenities. Other settlements have free off-street parking to support residents, businesses, and visitors within these communities.

- 1.9 In North East Fife, residents' parking schemes are in place in St Andrews and Cupar, giving qualifying residents exemption to either parking charges or waiting restrictions. Residents' permits cost £100 pa in St Andrews and £50 pa in Cupar. At present, there are 101 residents' permits in use in St Andrews and 32 residents' permits in use in Cupar.
- 1.10 A quarterly season ticket is also available for charged long-stay car parks in St Andrews and Cupar:

- 1.11 An initial review of neighbouring local authorities has been conducted and the main points are summarised below. More detail is contained in Appendix 1 to this report.

Dundee City Council

Dundee City Council operates a Controlled Parking Zone in Dundee city centre, signed at entry points. There is a further zone adjacent to Ninewells Hospital.

Dundee has a residents' permit scheme which operates on a shared-use basis. It allows residents to park in all city centre car parks and on-street in the city centre Controlled Parking Zone.

City of Edinburgh Council

A Controlled Parking Zone operates within Edinburgh city centre. To park on-street within the zone you need to either pay and display or hold a valid parking permit.

Since 2001, Edinburgh has seen increased use of buses and cycling, with car ownership in the city falling. Increased parking charges over the last five years have seen an increase in compliance with parking restrictions and a fall in the number of Penalty Charge Notices (PCNs) served.

Edinburgh City Council's draft Parking Action Plan seeks to improved managed parking in the city whilst supporting alternatives to car use such as walking, cycling and public transport. It proposes:

- introducing shared use parking places which can be used by permit holders and pay-and-display users, to increase accessibility to parking places and the flexibility of the parking controls
- extending the operating hours of parking restrictions in the evenings and at weekends to tackle demand
- developing a parking pricing strategy to manage demand and encourage people to consider their travel options and reduce private car dependency.

Perth & Kinross Council

Perth & Kinross Council operate three on-street parking zones in the City of Perth with a scale of tariffs reducing from Zone 1 (central) to Zone 3 (outer). The Controlled Parking Zones were originally signed at the entry points, but now rely on on-street signage.

2.0 Issues & Options

- 2.1 New powers under the Transport (Scotland) Act 2019 to enforce pavement parking, parking at dropped kerbs and double parking are due to come into effect at the end of 2023. These will have an impact on parking management across all local authorities in Scotland.
- 2.2 Fife Council's Car Parking Strategy & Operations team receive enforcement requests from the community. These are likely to increase once the Footway Parking Bill (Transport Scotland Act, 2019) is enacted in December 2023. With these new powers, Parking Attendants will be able to take enforceable action against vehicles parking on pavements, over dropped kerbs and which are double parked (excluding any exemptions).
- 2.3 The Local Transport Strategy, in considering fair access to daily activities, proposes a review of the current Fife Parking Strategy to provide a vision and action plan for parking in Fife and continued management of parking supply in major towns and cities to balance access and sustainable travel priorities. The review will be informed by the legislative changes above and the final publication of the Local Transport Strategy, which is expected to be published in late 2023.

3.0 Conclusions

- 3.1 The management and enforcement of parking measures in Fife will continue under the current strategy. Controlled Parking Zones and other parking management mechanisms were investigated. However, at present, residents parking schemes are considered to be the more appropriate mechanism to help manage parking and support local residents and communities.
- 3.2 Any changes to current parking management arrangements would be examined by a review of the Fife Parking Strategy (proposed within the Local Transport Strategy) and a review of the impact of legislative changes.

Local Community Planning Budget Request – Options in Life

Wards Affected: 20 - Cupar

Purpose

To seek agreement from the Area Committee for a contribution from the Local Community Planning Budget (LCPB) for Ward 20.

Recommendation

The Committee is asked to agree to an allocation of £10,000 towards the costs of renovating the TSB building in Cupar to transform into a building for social and education centre for young people with learning disabilities.

Resource Implications

There is sufficient funding available in the Local Community Planning Budget for 2023/24 should this contribution be agreed.

Legal & Risk Implications

There are no legal or risk implications based on this report.

Impact Assessment

An Equality Impact Assessment has not been undertaken because the report does not propose a change or revision to existing policies and practices.

Consultation

Ward 20 members have been consulted and are supportive of the application.

1.0 Background

- 1.1 The criteria for spend from the Local Community Planning Budget requires authorisation from the Area Committee before amounts of over £5,000 can be committed.
- 1.2 This report is to seek agreement from this Area Committee for a contribution from the Ward 20 element of the Local Community Planning Budget.

2.0 Project Information

- 2.1 Options in Life is a charity based in North East Fife, it runs a social inclusion and skills development programme for isolated adults with learning disabilities.
- 2.2 Last year Options in Life purchased the former TSB building in Cupar town centre. The intention is to transform the building into a social and education centre for young people with learning disabilities in North East Fife.
- 2.3 Inside the building will be a training kitchen, café, a sensory room, 2 classrooms, a social room and to the rear of the building a learning garden.
- 2.4 Funding will be used to set up the social room which will include the purchase of equipment and refurbishment costs.
- 2.5 The room will function as a safe, supervised space in the community where young people with learning disabilities can meet, socialise, and engage in both organised and independent activities.
- 2.6 Over the past few years there has been a significant decline in both day centre and community-based provision for people with learning disabilities in Fife and as a result demand for our service has become overwhelming and has justified the effort to launch this new provision in NEF. Through the current lack of supported opportunities in Fife people suffer isolation, loneliness, and poor mental wellbeing.
- 2.7 The project meets local planning priorities by increasing access to opportunities that reduce isolation and improve quality of life. It is targeting a marginalised group that have experienced a narrowing of available support over the past few years and are suffering as a consequence. The social space and overall opportunities within the new building will have a significant impact on their wellbeing and the wellbeing of the unpaid carers and family members who support them. Once open, the building is expected to regularly accommodate over 300 people with learning disabilities and their families.
- 2.8 The Charity has an existing business model which enables it to generate funds through charges which support its ongoing operation. The level of income generated is directly correlated to the number of people served and that number will rise substantially with the opening of the new premises. The building will allow capacity

to increase by 300% and the demand to achieve this has been established through the compilation of waiting lists and daily enquiries many from the Social Work Service, community organisations, schools, and Fife College.

The building itself creates the opportunity to establish several new income streams. At the entrance of the building will be a café, open to the public, run by people with learning disabilities to gain work experience and employability skills. The income generated from the café will be reinvested to building running costs. There is substantial space in the 3-story building, some of which will be hired out to community groups to generate additional income. The increased scale and scope of the service will improve efforts to secure ongoing grant funding. There is potential to use the carpark to the rear of the building for commercial benefit and to sell the produce made in the training kitchen.

The social room will have relatively low ongoing costs after the initial capital investment.

OnFife Service Update

The purpose of this report is to provide an update to the North East Fife Area Committee on OnFife's service offer in the area, reviewing activity in the past six months and outlining plans in the coming year.

It is recommended that the Committee review the information and explore how OnFife can better engage with and support the ongoing work within the area, ensuring a joined-up approach to service delivery which will enhance the offer to communities in North East Fife, expand the return on investment of the public pound and contribute to the Community Wellbeing agenda.

1.0 Background

- 1.1 Fife Cultural Trust (the Company), established by Fife Council on 1 October 2012, delivers Libraries, Arts, Museums, Galleries, Archives, Theatres and Creative Development Services on behalf of Fife Council with a view to enriching lives in Fife and ensuring the long-term sustainability of these services.
- 1.2 A company limited by guarantee, Fife Cultural Trust's principal activity is the provision of cultural services for Fife. It is responsible for community development in the creative and cultural fields and for operating and delivering the following facilities and services: -
 - Libraries; inclusive of mobile libraries and a home delivery service
 - Maintenance and development of library services within Fife Council's four integrated customer service facilities
 - Museums, galleries, archives and local studies, heritage sites, and a mobile museum
 - Stewardship and care for the objects and archives in Fife Council's collections
 - Theatres and community venues
 - A Creative Development team to drive innovation, cultural collaboration, volunteering, sponsorship and funding
 - Marketing & Customer Engagement to best profile and promote these services while driving sales and analysing customer data
- 1.3 Our aim is to assist in the provision of cultural facilities and activities with the object of improving quality of life via the provision of accessible and affordable opportunities for all members of the public in Fife, allowing them to participate in cultural activities and access the cultural facilities.

2.0 Issues and Options

Emerging from the Pandemic

- 2.1 Since the pandemic, we, like the cultural sector as a whole, continue to face the challenges arising from the pandemic, such as changes in customer habits, footfall, pre-booking habits (for theatre and exhibitions) and a slow return to in-person events and activities.
- 2.2 In terms of customer engagement, our primary focus is retaining existing customers and increasing their frequency of attendance at cultural activities and events. In 2022, we developed a two-year Recovery and Renewal Strategy to give us a clear focus on recovering from the pandemic and rebuilding to thrive in the longer-term. The overriding purpose of this strategy is **Bringing People Back** and working to create **long-term sustainability**.

Our Service Offer

- 2.3 Our Creative Services consist of the following four highly collaborative teams: Creative Development; Customer Engagement; Community Events & Programme and Cultural Heritage & Wellbeing, who come with a combined skillset that is of direct benefit to organisations working within communities inclusive of creative approaches to community engagement and wellbeing, creative facilitation, funding, creative approaches to dementia support, informal approaches to literacy work, events and project management and volunteer co-ordination. Additionally, we are well versed in brand development and awareness and the importance of public relations (PR), personality and tone of voice in the development of stories which are accessible to communities and which are core to great PR and communications.

Achievement and Performance

- 2.4 Our services are designed to support Fife's communities and, as such, sit and report within the wider strategic framework of The Plan for Fife, supporting it and reporting on performance against its key priority areas.
- 2.5 Delivering within the fabric of Fife's seven areas, we are well networked with Community Managers and wider service provision and are actively working to ensure increased collaboration of service delivery to achieve a greater return on investment of the public pound.
- 2.6 **Within the North East area, we have nine libraries** including St Andrews; Cupar; Newburgh; Newport; Tayport; St Monans; Elie; Ladybank; Auchtermuchty. We also support the Fife Council Waid Library at Waid Campus. Of OnFife's libraries, 7 are small, single-staffed and two (Cupar, St Andrews) are medium size with more staff and capacity to deliver a range of events and activities. These spaces offer safe, warm places in which to access books and computers along with a range of activities from reading groups and the ever-popular Bookbugs.
- 2.7 We manage **St Andrews Museum** in Kinburn Park and are responsible for **The Laing** in Newburgh, **St Monans Windmill** and **heritage displays in Newburgh and Newport-on-Tay Libraries**.

Thriving Places

- 2.8 Despite the ongoing economic climate and associated challenges which it brings for the cultural sector, our teams achieved tremendous results during 2022/23, contributing to the quality of life of those living, working and visiting Fife through imaginative creative support, events and online digital activities. Successes included exhibitions, dementia-friendly projects, the reopening of Adam Smith Theatre, the welcome return of panto and summer holiday provision.
- 2.9 Open throughout the week, our libraries offer popular spaces which are used by young and old to borrow books, join a reading group or just have a quiet space to read the newspapers and access the computers. **St Andrews Library** has recently been re-decorated, with a new Kitchen improving our support for Warm spaces. This initiative was successfully launched with free tea and coffee, board games and jigsaws available, thanks to funding from Fife Council.

Staff report this made a difference to the customers and the meeting room became a popular social space to pop into to either study or relax. Staff have taken time to really connect with the local communities and families in the area and our customer base has increased since reopening on Wednesdays following on from reduced hours in place since returning from the pandemic. Saturday mornings are proving particularly popular with young families. The new study space which has been created upstairs now accommodates students who frequent it as a quiet space in which to study.

The team are keen to support those facing financial difficulties and are liaising with Barclays Bank who are now there three days a week offering financial advice.

- 2.10 With funding from Fife Council's Community Recovery Fund for North East Fife we have been able to repurpose the Reference Room in **Cupar Library**, transforming it into a more welcoming space for all who use it, a place which facilitates wider community events and talks, creating opportunity for social interaction, informal learning and engagement. This development will also improve the customer experience of the ancestral tourists who visit Cupar Library to use the local studies resources and to get

advice from the Fife Family History Society volunteers, making them more likely to return.

People spending time in in the Cupar Library either carrying out research or attending talks are more likely to spend time in Cupar town centre itself, accessing shops, cafes and other local businesses.

The Library offers a small, display space for local community and heritage groups to showcase their resources and to highlight items from the OnFife collections. Recent displays include: The Puddock a Scottish fairy tale by story teller Sheila Kinninmonth and from Fife Folk Museum about their Scottish Fire & Rescue Service exhibition. The current displays are about Sir David Lindsay's play: *Ane Satyre of the Thrie Estaitis* and the magic lantern used by George Normand (born in Cupar in 1875) who built up a personal collection of glass slide photographs he took in the Howe and North East Fife.

- 2.11 In terms of **changing exhibitions, heritage and contemporary art displays and events and activities drawing on our collections**, the area is served by **St Andrews Museum** which re-opened to the public in May 2023 following an 8-month closure for essential repair works.

We took the opportunity of this closure to re-vamp the venue, with a refresh of décor throughout, an improved café facility and a change to some of the permanent displays in the ground floor A-Z gallery, bringing new objects out on display. During the closure period, staff were able to undertake research in to the museum collections and the history of the building and this has resulted in new guided tours to set the context of Kinburn House.

Our first special exhibition of 2023 was ***Brushstrokes***, drawn from our own extensive art collection. This exhibition featured paintings selected by St Andrews Museum staff who wrote the labels giving a personal touch to the visitor experience. We established a family activity area in the Activity Room adjacent to the exhibition galleries with a range of activities to engage families over the summer holidays and at weekends.

The Museum hosts Fife Contemporary's new exhibition ***Crafted Selves: The Unfinished Conversation*** from 14 October 2023 to 24 February 2024, when the exhibition will then transfer to OnFife's Kirkcaldy Galleries. The exhibition showcases the work of 13 Scotland based artists exploring dual identities in their work.

After exploring various options for the café at St Andrews Museum over recent years, we were able to reopen the facility in June in partnership with a well-established food and hospitality business. The contract was initially for a four-month period, during which the operation would be evaluated by both OnFife and the provider. Unfortunately, the company has decided not to continue at the museum beyond the end of September 2023, with its commitment to serving up fresh home-made produce from its base in Midlothian proving logistically more problematic than expected. Recognising the importance of a café facility for the visitor experience and income generation and are now following up with other potential interested parties and meantime we will be returning to an 'honesty' service, although this will be more enhanced than previously with high quality coffee and tea machine, chilled soft drinks and a small selection of cakes and tray bakes.

Opportunities for All

- 2.12 **Cupar, St Andrews, Elie, Ladybank and Newport Libraries** are part of Fife Council's **Warm Spaces** initiative offering free hot drinks, board games, jigsaw puzzles and – at St Andrews – two volunteers to welcome everyone, in particular those facing challenges

from the cost-of-living crisis. Our libraries have continued the Warm Spaces offer over the summer.

- 2.13 OnFife libraries took part in the annual national Summer Reading Challenge (SRC) and in North East Fife, we have worked with **Fife Council Holiday Club** at Leuchars and our Mobile Library to give children in rural areas an opportunity to take part, signing up to read books over the summer holidays. **844** children signed up in NE Fife with breakdown: St Andrews Library had 266; Tayport 70; Elie 12; St Monans 22; Auchtermuchty 36; Cupar 229; Ladybank 35; Newburgh 41; Newport 75. Waid Library signed up 58 children. This represents 26% of all participants in Fife's SRC which is a tremendous achievement with 7 single-staffed and 3 medium sized libraries, including Waid.
- 2.14 Our North East libraries have been delighted to welcome more nursery and class visits from their local areas and staff have been running school visits and Bookbug sessions out with our Library opening hours to encourage them back through the doors. Across North East Fife, our staff continue to run a range of free activities for children and families over the summer holidays and in term time, such as World Plant Explorers and Kids' Den Lego at Cupar Library, Elmer (the Elephant) Day at Newport Library and a Junior Book Group starting after school, monthly from October at Ladybank Library. These events which often sell out are a great promotional tool for us, increasing family awareness of our offer and footfall.

St Andrews Museum also offered a range of family craft activities over the summer holidays including talks by the curator of **Brushstrokes** exhibition, staff-led and freelance artists delivering workshops.

At the start of September St Andrews Library launched **our Autumn / Winter programme** which includes a series of talks and art classes for adults as well as fortnightly Book blethers which are informal get togethers to talk about books. Monthly WalkOn sessions are run for physical and mental wellbeing and socialising plus monthly art classes for adults.

The Library's Family offer includes Bookbug storytelling sessions on Thursdays and alternate Saturdays, as well as Storytime and craft sessions.

- 2.15 In March 2023 we launched our new Library Management System (Spydus) improving public access to our library services and resources and offering greater choice. We have now switched from Libby to PressReader for our magazine and newspaper provision. It's something many of our customers have asked for and we are pleased to be able to provide this new free service to library members across Fife giving digital access to an extensive range of more than 7,000 newspapers and magazines from more than 100 countries in 60+ languages.

Community Led Services

- 2.16 We work closely with and participate in Heritage & Fife Family History Fair, this year hosted on 16 September in Cupar. Our Local Studies Officer and Local Studies Supervisor in Cupar had a stall promoting the archives and local studies services we provide.
- 2.17 In the coming months we are working with members of St Andrews Community Council to refresh and re-interpret the display of civic regalia at St Andrews Town Hall during the period of closure for refurbishment work. Martin Passmore from the Community Council visited St Andrews Museum earlier this year with Councillor Jane Ann Liston to see how OnFife cares for the collections at the Museum and at our Collections Centre at Bankhead, Glenrothes.

- 2.18 In September we hosted an art installation *IMMERSE@The Windmill* at St Monans Windmill as part of the St Monans Festival. *IMMERSE* is a 2-year art project created by local artist Joanna van den Berg who secured Creative Scotland funding for her site-specific work inspired by and reflecting coastal and wild swimming experiences. Over three days, we welcomed 626 visitors to the site and gathered valuable feedback about what local people and visitors would like to see happen at the Windmill in future.
- 2.19 We are committed to engaging with our communities and to taking a long-term approach to this, ensuring that our service offer is relevant and reflects the needs of those in our communities. Funding from Creative Scotland has allowed us to invest in widening our engagement skillset by participating in an international Change Network which will equip 10 members of staff and Board members with skills to better engage with local communities, understanding their needs and working with them to shape service development and delivery in their areas.

Inclusive Growth & Jobs

- 2.20 As an organisation, we look to both support the growth and career development of our people and provide services that will help with job opportunities and contribute to **Fife's creative economy**.
- 2.21 We recruited two volunteers to assist with delivering our Warm Spaces offer at St Andrews Library and will be developing volunteer opportunities to deliver our Macmillan Cancer Information mini-pop ups.
- 2.22 Our Macmillan Project Officer and Project Co-ordinator recruited a team of volunteers to support our Macmillan Cancer Information and Support Centres at three OnFife Libraries, pop-up Information points at Victoria Hospital (Kirkcaldy) and Queen Margaret Hospital (Dunfermline) with mini-pop ups to be established including Cupar, St Andrews, St Monans and Ladybank.
- 2.23 Mindful of the ongoing financial challenges, funding secured from Creative Scotland's Recovery Fund for Cultural Organisations is allowing us to explore ways of diversifying income. As such, we commissioned an external sponsorship agency to audit our assets and help create a framework for attracting sponsorship for our events and activities. In time, we will be looking for opportunities to engage with sponsors to support events and performances as well as smaller events within our library spaces.

Future Challenges & Plans

- 2.24 The year ahead continues to be extremely challenging for the cultural sector as a whole, with no end in sight for the ongoing war in Ukraine, the related fuel and cost of living crisis and the additional impact of Brexit in the UK. Local authority budgets have been challenging and the sector has waved goodbye to many longstanding cultural venues, while several library closures have been announced across Scotland. These are trends that are likely to continue and we are working hard to sustain our services, ensuring alignment with the Plan for Fife and driving a shared approach to joined-up cultural service delivery across Fife's public sector.
- 2.25 The pandemic has had a monumental impact on the mental wellbeing of the population and, given the correlation between culture and its positive impact on wellbeing, and in line with Fife Council's commitment to improving mental health and wellbeing across Fife, we will develop and deliver our new approach for wellbeing which will be designed to work closely with Fife's local area teams, NHS Fife and Fife Health & Social Care. As budgets for 2024/25 are clarified, we will undertake a wider review of Service provision, utilising a raft of data inclusive of feedback, footfall, intelligence from our new Library

Management System and PatronBase -the ticketing software platform we use to manage and run events and our Relevance Work in communities.

- 2.26 In the next six months at St Andrews Museum we will install *Flooring the World* from March to August 2024. This exhibition focuses on Fife's linoleum industry and has been made possible with funding from the Esmée Fairbairn Foundation and the Museums Association.
- 2.27 We will explore with local communities further opportunities to access and use St Monans Windmill for create and community activities as well as access for those visiting North East Fife and using the Coastal Path.
- 2.28 We will have the results of OnFife's Customer Satisfaction Survey from across our venues and service areas together with feedback from the Scottish Library & Information Council (SLIC) National Public Library Survey that will give us information about how customers use and regard our library services.

3.0 Conclusions

- 3.1 This report sets out an overview of the OnFife services and activities delivered in the North East Fife Area as well as a preview of what's coming up. OnFife will continue to provide inclusive and welcoming cultural services, activities and events that excite, inspire and improve the lives of those who participate and Fife's communities more generally. We want to ensure that what we deliver is relevant and to do this we are looking to better engage and network at local area level, building stronger partnerships and supporting the ongoing work within the area.
