

**THE FIFE COUNCIL (PICKLETILLUM AVENUE, DRUMOIG - 20 MPH SPEED LIMIT
EXTENSION) ORDER 2025**

Fife Council propose to make an Order under the Road Traffic Regulation Act 1984 to extend the existing 20 m.p.h. speed limit on Pickletillum Avenue from a point approx. 6m west of the extended southwest property boundary of no. 17 Pickletillum Avenue in an easterly then westerly direction for approx. 234m.

EXTENSION) ORDER 2025**

The Fife Council (“the Council”) in exercise of the powers conferred on them under sections 84(1) and 124(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council’s area in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Pickletillum Avenue, Drumoig - 20 mph Speed Limit Extension) Order 2025" and shall come into operation on theday of Two Thousand and Twenty Five
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. Drawing number TRO25_66 showing the road affected by this Order delineated in red is annexed and signed as relative hereto.
