Annual Taxi/Private Hire Car Inspection Report for October and November Tests - Glenrothes Zone

Report by: Tom Henderson, Service Manager, Fleet Operations.

Wards Affected: 14, 15 & 16

Purpose:

To advise the Committee of the outcome of the Annual Taxi and Private Hire Car Inspection Tests for the Glenrothes zone.

Recommendation:

It is recommended that:

- (1) random inspection tests, six months after the annual test dates, should be considered, where appropriate, to ensure public safety; and
- (2) the Committee takes any other steps it deems appropriate.

Resource Implication:

Arrangements may have to be made for 2 random inspection tests.

Legal & Risk Implications:

There is a possible public safety risk if no random inspections are carried out.

Policy & Impact Assessment:

None

Consultation:

None

1.0 Background

- 1.1 This report gives details of the results of the inspections carried out on vehicles operating in Glenrothes zone in October and November 2021.
- 1.2 Of the 94 vehicles tested in Glenrothes, 92 passed first time, which equated to 97%. The percentage pass rate in 2019 was 96%.
- 1.3 Summaries of the results and failures are attached in Appendix 1 to this report.

2.0 Issues and Options

- 2.1 As well as considering random testing of vehicles, the Committee, may deem it appropriate to:
 - invite those operators whose vehicles failed the test to a meeting with the Convener and Vice-Convener of the Committee to discuss their maintenance procedures; or
 - consider whether or not to hold Hearings under paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982 which relates to suspension of the licences.

3.0 Conclusions

- 3.1 I'm delighted to report that the first time pass rate has increased from 2019. The Operators should be congratulated for their first class efforts in continuing to maintain their cars to a very high standard particularly at this very difficult time.
