**THE FIFE COUNCIL (MAIN STREET, COLINSBURGH) (PROHIBITION OF WAITING)
ORDER 2025**

The Fife Council ("the Council") in exercise of the powers conferred on them by sections 1, 2 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Main Street, Colinsburgh) (Prohibition of Waiting) Order 2025" and shall come into operation on the day of 2025.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Fife Council (Waiting and Loading Restrictions and On-Street Parking Places) Consolidation Order 2013 shall be amended as follows:-

- (1) The following entry shall be inserted in Schedule 3 – No Waiting At Any Time in numerical order in accordance with the TRO Ref:
