# **Become a Childminder**

Childminders are an important element of the childcare sector in Scotland and offer a unique experience of childcare for children and families. They provide care and learning in the childminder's own home, generally in small groups with no more than six children at one time. Often a childminder can provide flexibility for parents or carers who need to manage work commitments, and may be used to provide wrap around care alongside nurseries or schools.

Childminders are also consistently rated, through independent inspection by the Care Inspectorate, as providing high quality childcare across all quality criteria.



Childminding is a hugely rewarding career that provides you with the opportunity to:

Provide a valuable, professional childcare service for your community

Develop new skills and qualifications

Be your own boss, from your own home

Earn money while working around your family's needs

Before you can start welcoming children to your childminding business, you will first need to register with the Care Inspectorate. This process usually takes three to six months. #### CI Guidance for applicants applying to register a care service

When you have submitted your application and paid the registration fee, the Care Inspectorate will contact you at some point during the process to arrange to visit you at the home your service will operate from. They visit to discuss how you will meet the needs of the children and their families. This will include how you will provide care to the children including how you plan and arrange activities. They will also make sure that the home is suitable and safe for caring for other people's children



#### How long does it take to become registered?

On average it takes between three to six months to become fully registered. However, it all depends on how quickly your references are returned, your PVG scheme membership takes to come in and how many childminders are applying at the time.

#### How many children can I care for at one time?

Childminders normally care for a maximum of six children at any one time under the age of 16, of whom no more than three are not yet attending primary school and of whom no more than one is under twelve months. Numbers are inclusive of children of the childminder's family and household.

#### How much does it cost to set up a childminding business?

The cost for each childminder varies but the common costs will include: Care Inspectorate registration fee (currently £28). Public Liability Insurance (£35). Information Commissioner's Office registration fee (if necessary). Cost of start-up equipment (including smoke alarms, fire blanket, toys, and safety gates). Business stationery such as a cashbook and contracts.

#### Am I entitled to sick leave and maternity pay?

As a childminder you will be self-employed. This means you are responsible for your tax and National Insurance payments. It also means you may not be eligible for the same maternity pay or sick leave as employed workers. Check the gov.uk website for full information on your entitlements as a self-employed childminder.

#### When I can apply to come into partnership

Once you are set up and running your childminding business you can apply to become a funded provider. You do not need to wait for an inspection. If you would like to become a funded provider we have a step by step guide to help.
