the opportunity to have wheelchair accessible vehicles, up to a maximum of 7 years old from date of 1st registration, licensed as taxis or private hire vehicles. It is hoped that this pilot would assist in encouraging taxi and private hire operators to consider operating more wheelchair accessible vehicles in East Fife.

Annual Taxi/Private Hire Car Inspection Report for February to April 2025 - East Fife Area

Report by: Billy Ferguson, Service Manager, Fleet Operations

Wards Affected: 17, 18, 19, 20 and 21

Purpose:

To advise the Committee of the outcome of the Annual Taxi and Private Hire Car Inspection Tests for the East Fife Area.

Recommendation:

It is recommended that the Committee takes any steps it deems appropriate.

1.0 Background

- 1.1 This report gives details of the results of the inspections carried out on vehicles operating in East Fife between February and April 2025.
- 1.2 Of the 206 vehicles licensed in East Fife, 161 vehicles passed first time which equates to 78%, 45 failed with 43 passing on retest & two still have to be retested equating to 22%. In 2024, 222 vehicles were tested and 187 vehicles passed first time which equated to 85%. 35 vehicles failed but passed on re-test which equated to 15%.
- 1.3 Summaries of the results are attached in Appendix 1 to this report.

2.0 Issues and Options

- 2.1 The Committee, may deem it appropriate to:
 - subject those vehicles failing the test to a random test;
 - invite those operators whose vehicles failed the test to a meeting with the Convener and Vice-Convener of the Committee to discuss their maintenance procedures;
 - request that those operators failing the test attend an open day at Fleet Operations; or
 - consider whether or not to hold Hearings under paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982 which relates to suspension of the licences.

3.0 Conclusions

- 3.1 It is extremely disappointing that the first-time pass rate has decreased substantially with so many vehicles failing the test first time around. Those operators whose vehicles passed the test first time should be congratulated for maintaining their vehicles to the high standards expected and those operators whose vehicles failed the test should be reminded that their vehicles should be maintained to a very high standard, at all times.

1.0 Background

- 1.1 This report gives details of the results of the inspections carried out on vehicles operating in Levenmouth Zone between February and April 2025.
- 1.2 Of the 88 vehicles licensed in Levenmouth, 81 passed first time, which equates to 92%, 7 failed and passed on re-test equating to 8%. The percentage pass rate in 2024 was 97%.
- 1.3 Summaries of the results and failures are attached in Appendix 1 to this report.

2.0 Issues and Options

- 2.1 The Committee, may deem it appropriate to:
 - subject those vehicles failing the test to a random test;
 - invite those operators whose vehicles failed the test to a meeting with the Convener and Vice-Convener of the Committee to discuss their maintenance procedures;
 - request that those operators failing the test attend an open day at Fleet Operations; or
 - consider whether or not to hold Hearings under paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982 which relates to suspension of the licences.

3.0 Conclusions

- 3.1 Although the first-time pass rate has decreased slightly, those operators whose vehicles passed the test first time should be congratulated for maintaining their vehicles to the high standards expected. However, the Operators whose vehicles failed the test should be reminded that their vehicles should be maintained to a very high standard, at all times.

- 3.1 Although the first-time pass rate has decreased slightly, those operators whose vehicles passed the test first time should be congratulated for maintaining their vehicles to the high standards expected. However, the Operators whose vehicles failed the test should be reminded that their vehicles should be maintained to a very high standard, at all times.
