

**THE FIFE COUNCIL (BENARTY AREA - LOCHORE, CROSSHILL AND GLENCRAIG - SPEED LIMITS)
ORDER 2025**

Fife Council propose to make an Order under the Road Traffic Regulation Act 1984 to introduce a 20 m.p.h. speed limit in various streets in the Benarty Area (Lochore, Crosshill and Glencraig) as follows:- B920 Main Road/Main Street/Lochleven Road, Lochore from approx. 110 metres south of the extended south kerbline of Manse Road to approx. 20 metres north of the extended north kerbline of New Flockhouse for approx. 1765 metres; and Balbedie Court, Lochore and Mucklestone Court, Crosshill for their entire lengths.

The Fife Council in exercise of the powers conferred on them under section 84(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with section 124 of and Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Benarty Area - Lochore, Crosshill and Glenraig - Speed Limits) Order 2025" and shall come into operation on the day of .
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 2 to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. The Fife Council (Benarty Primary School, Ballingry – Part Time 20 M.P.H. Speed Limit) Order 2007 is hereby revoked.
5. The Fife Council (B920 Glenraig to Lochgelly – 30 M.P.H. Speed Limit) Order 2016 is hereby revoked.
6. The Fife Regional Council (Speed Limits) (Consolidation) (Revocation) Order 1992 shall be amended as follows:

In Schedule 1 (30 m.p.h Restricted Roads) Dunfermline District delete the following entry

"Ballingry/Glenraig" from Town/Village and "TM/SLO/D/5" from Drawing No.
7. Drawing numbers TRO25_60/PN, TRO25_60/PS, TRO25_60/30N and TRO25_60/30S showing the roads affected by this Order delineated in black are annexed and signed as relative hereto.

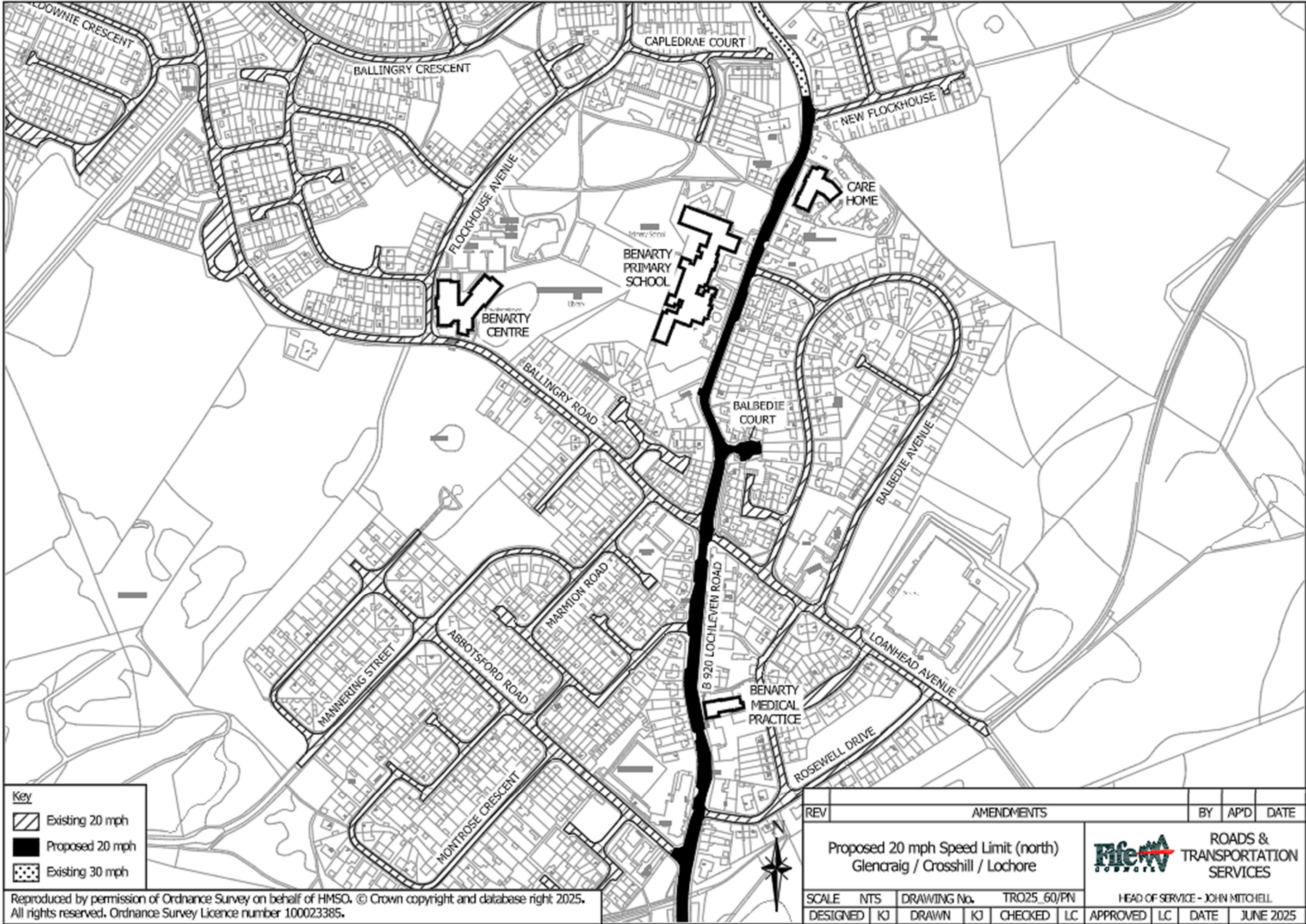
