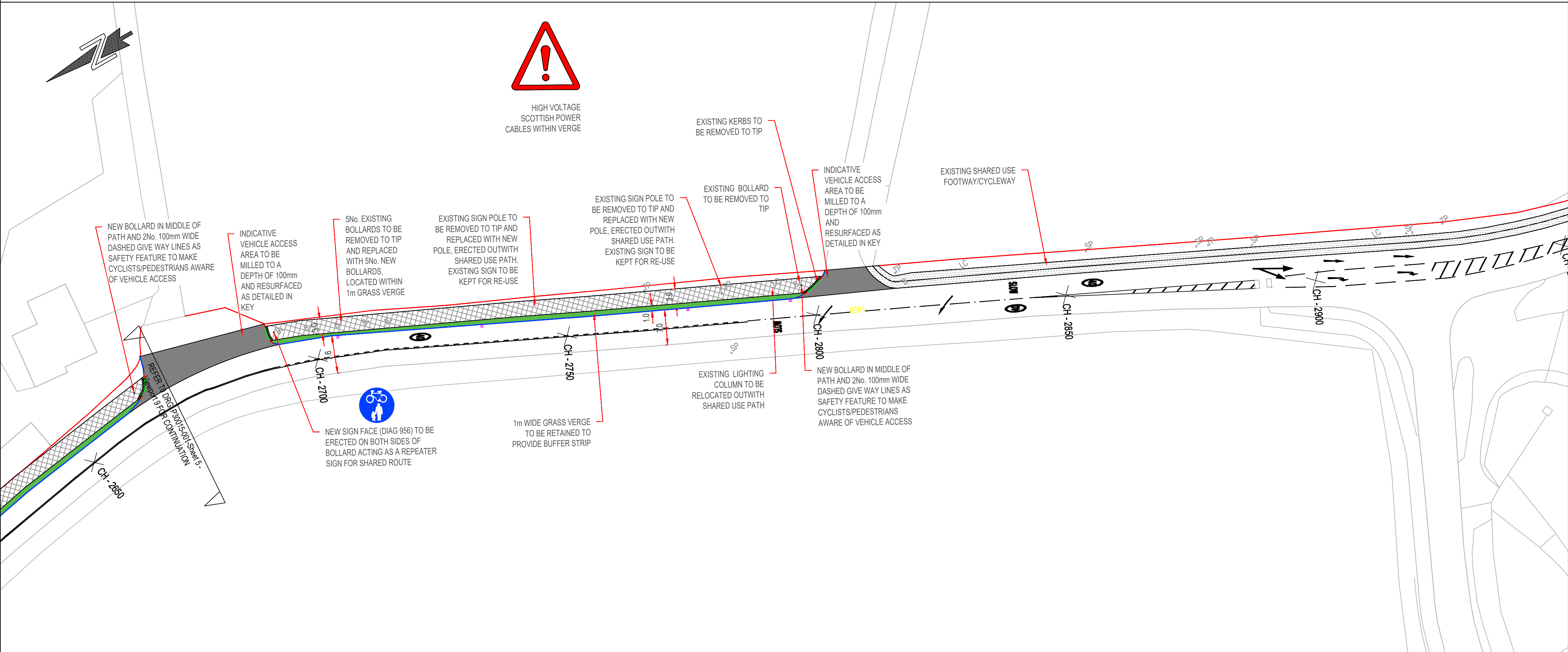
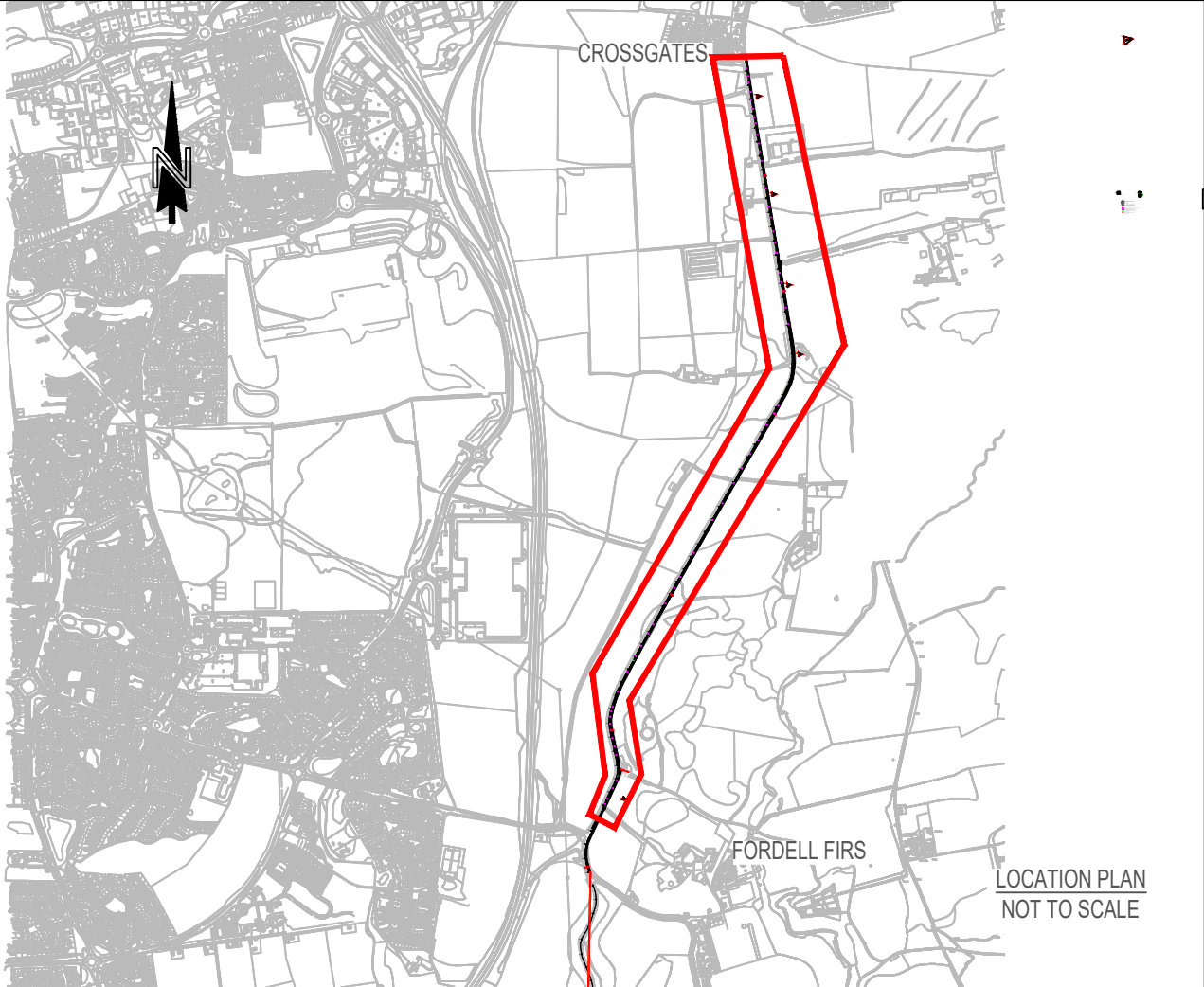

 - 1m WIDE GRASS VERGE
 - 100mm DEEP EXCAVATION OF EXISTING CARRIAGEWAY AND RESURFACING OF VEHICLE ACCESS AREAS USING A 55mm BINDER LAYER OF ASPHALT CONCRETE AND A 45mm SURFACE LAYER OF HOT ROLLED ASPHALT
