- 1. This Order may be cited as "The Fife Council (Main Street, Balmullo 30 m.p.h. Speed Limit) Order 2025" and shall come into operation on the day of Two Thousand and Twenty Five.
- 2. No person shall drive any motor vehicle at a speed exceeding 30 m.p.h. miles per hour on the length of road specified in the Schedule to this Order.
- 3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
