

THE FIFE COUNCIL (SUNNYSIDE, STRATHKINNESS) (PROHIBITION OF WAITING) ORDER 2026

On 13/05/2026 Fife Council made an Order under the Road Traffic Regulation Act 1984, the effect of which is as stated in the issue of the St Andrews Citizen published on 23/01/2026.

A copy of the Order, which is operational from 01/06/2026 and a drawing showing the affected roads, may be inspected, without payment of fee, during normal office hours at Fife Council Headquarters, Fife House, North Street, Glenrothes and via public access pc's at your closest library. The documents will also be available online at www.fife.gov.uk/notices. Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, may, within six weeks from 13/05/2026 apply to the Court of Session for the purpose.

THE FIFE COUNCIL (SUNNYSIDE, STRATHKINNESS) (PROHIBITION OF WAITING) ORDER 2026

The Fife Council ("the Council") in exercise of the powers conferred on them by sections 1, 2 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Sunnyside, Strathkinness) (Prohibition of Waiting) Order 2026" and shall come into operation on the 1st day of June 2026.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Fife Council (Waiting and Loading Restrictions and On-Street Parking Places) Consolidation Order 2013 shall be amended as follows:-
 - (1) The following entries shall be inserted in Schedule 3 – No Waiting At Any Time in numerical order in accordance with the TRO Ref:
