THE FIFE COUNCIL - FIFE LICENSING FORUM- REMOTE MEETING

12 August, 2021

2.00 p.m. – 2.50 p.m.

PRESENT: Jeff Ellis (Convener), John Barclay, Jim Bett, Ian Davidson, Neil Ewing, Fiona Rattray and Paul Smith.

1. WELCOME AND APOLOGIES FOR ABSENCE

Jeff Ellis, Convener, welcomed members to the meeting. It was noted that there was not a quorum of members present and that any decisions would require to be ratified at the next meeting.

2. MINUTE

The Forum considered the minute of meeting of 3 June 2021.

Decision

The Forum agreed to approve the minute.

3. APPOINTMENT OF NEW MEMBER

The Forum was asked to ratify the decision taken at the meeting on 3 June recommending that Ian Davidson, Lead Nurse, NHS Fife Addiction Services, be accepted as a member.

Decision

The Forum agreed to confirm the appointment of Ian Davidson to the Forum, for ratification at the next meeting subject to a quorum of members being present.

UPDATES FROM FIFE LICENSING BOARD

The Forum considered a report detailing the business of the Fife Licensing Board - "List of Decisions" from the Board meeting of 19 April 2021, which was sub-divided into: Provisional(s); New Grant(s); Variation (Major)(s); Personal Licence Review(s); and Premises Licence Review(s). June Barrie advised that there had also been Licensing Board meeting held in June but the meeting report papers had not yet been finalised. The meeting scheduled for August had been cancelled and the next meeting would therefore be held in October.

Decision

The Forum noted:-

- (1) the decisions of the Board meeting on 19 April; and
- (2) the information given relating to the Board meetings.

5. CONSTITUTION & MEMBERSHIP

The Constitution of the Forum had been circulated for information and included details relating to membership. Jeff Ellis advised that he might have to resign as changes in his personal circumstances meant that he could not guarantee his attendance at future meetings. Members discussed options and were advised that there was only one more meeting scheduled in 2021 and that the appointment of a Convener would be considered at the Annual General Meeting which would be the first meeting in 2022.

Decision

The Forum:-

- (1) agreed that, should Jeff not be able to attend the next meeting, John Barclay would substitute as Convener for that meeting; and
- (2) noted that the appointment of a Convener would be considered at the Annual General Meeting in early 2022.

6. UPDATE ON CORONAVIRUS PANDEMIC IMPACT

There was discussion around the ongoing Coronavirus pandemic and the impact on licensed premises. It was reported that letters sent to the Scottish Government and Party Leaders had received no replies other than from Willie Rennie.

There was general agreement that the continuing requirement to wear a face covering when moving around licensed premises, especially nightclubs and pubs, was very difficult to enforce as there were exemptions for people with certain medical conditions. Neil Ewing advised that the Police had been encountering incidents regarding wearing of masks and that they would speak to premises owners if complaints were made. A common sense approach was being taken by the Police and the Licensing Standards Officers.

Finally, it was also reported that some premises had not opened immediately after 9 August due to the uncertainty over ongoing requirements such as recording of customer details and social distancing but that more were reopening gradually. Premises were generally being well supported and most customers were well behaved.

Decision

The Forum noted the current position.

7. ALCOHOL FOCUS SCOTLAND - EFOCUS NEWSLETTERS

The Forum noted that eFocus newsletters could be accessed directly through the Alcohol Focus Scotland website and a link was provided.

8. ANY OTHER COMPETENT BUSINESS**(1) Licensing**

John Barclay asked about checks to ensure that licenses had been kept up to date and the situation regarding Licensing Standards Officers (LSOs). June Barrie advised that there were currently two LSO's but that recruitment of LSO's was under consideration. Neil Ewing advised that he was in contact with the LSO's and that they were trying to visit all licensed premises as soon as possible. In response to a query regarding the number of renewal applications, June advised that she was aware of new personal licence applications being submitted and she would check the number of renewals to see if there were fewer than normal. Neil Ewing advised that he was aware that the number of applications being submitted was starting to pick up.

(2) Coronavirus Case Numbers

Ian Davidson advised that it was difficult to demonstrate any direct correlation between the increased opening of hospitality venues on 9th August and case numbers as there were many factors to consider. There were reports that the rate might still be coming down but it was too early to tell.

9. DATE OF NEXT MEETING

The Forum noted that the next meeting would be held on 25th November 2021 at 2.00 p.m. and that the Council would be considering a report in September on the arrangements for holding meetings in future.

Fife Licensing Board
Annual Functions Report 2020 – 2021

This report has been prepared in accordance with the provisions of Section 9A of the Licensing (Scotland) Act 2005 (the “2005 Act”).

Fife Licensing Board is the licensing authority responsible for regulating the sale of alcohol in the area of Fife for the purposes of the 2005 Act. The current Board was formed in May 2017 and is made up of ten elected members from Fife Council.

Fife is located on the east coast of Scotland, lying between the Firth of Tay on the north and the Firth of Forth on the south, and is bordered by Perth and Kinross and Clackmannanshire Councils. The population of Fife is rising and is currently 373,550. There are five main centres of population, namely, Dunfermline, Kirkcaldy, Glenrothes, Levenmouth and St. Andrews. Fife Licensing Board meets at the Council’s administrative centre at Fife House in Glenrothes.

As of 31 March 2021, the Fife Licensing Board area had 3021 personal licence holders and 1039 premises licences comprising 206 on sale, 354 off sale and 479 on and off sale. The corresponding figures for the previous reporting year 2019/20 were 2967 personal licences and 1054 premises licences (213 on sales, 356 off sales and 485 on & off sales).

There has been an increase in the number of personal licenceholders which is believed to be due to Covid-19 regulations extending the timescales for undertaking and submitting evidence of refresher training, which has reduced the number of personal licences which the Board is required by the 2005 Act to revoke for not providing proof that refresher training has been undertaken.

There are 15 fewer premises licences in Fife since the last reporting period.

The Board is responsible for considering applications for premises licences (including provisional and temporary premises, transfer, variation and confirmation of provisional premises), occasional licences, extended hours and personal licences.

Licensing Objectives

The 2005 Act sets out the following five licensing objectives:-

- preventing crime and disorder
- securing public safety
- preventing public nuisance
- protecting and improving public health
- protecting children and young persons from harm

The Licensing Board must have regard to the licensing objectives when considering all applications as the licensing objectives provide a basis for the administration of the licensing regime and a potential reason for refusal. There is a presumption of grant of an application if none of the statutory grounds for refusal apply. Breach of one or more of the licensing objectives may provide grounds for reviewing a premises licence. The Board recognises decisions to refuse applications must be evidence based and contain reasons as to why one or more of the licensing objectives has been engaged. The Board may attach conditions to a premises licence that it considers necessary or expedient for the purposes of any of the licensing objectives. In exercising its functions under the Act, the Board must consider the licensing objectives.

Board Business

The meetings of the Board during the reporting year 1 April 2020 to 31 March 2021 were significantly affected by the restrictions required because of the Covid-19 pandemic. The scheduled meetings of the Board between 1 April and 31 August 2020 were cancelled. Applications submitted which could legally be delegated to the Clerk were determined by the Clerk. The Board dealt with a small number of occasional licence applications during this period to which objections or representations had been submitted, and which were thus not delegated, with the Board members considering the applications, reports and objections by written submissions. Physical meetings of the Board resumed in the Council Chamber in Fife House in August 2020 in accordance with health and safety advice to ensure the safety of those attending. A practice was introduced to allow applicants in respect of whose applications no objections, representations or other reports had been received to lodge written submissions on their application with the Board instead of appearing before the Board to minimise the number of persons attending the meeting. No meetings of the Board were held between January and the end of March 2021 due to the restrictions.

Applications were dealt with by the Board in an open and transparent manner, in accordance with the licensing legislation, statutory guidance and the Board's statement of licensing policy. Meetings of the Board are conducted in accordance with rules made by the Board at Kirkcaldy on 16th June 2008 (subsequently updated).

A copy of the applications and responses to the applications are issued to the Board members and applicants a week in advance of the board meeting. This gives fair notice to all parties involved in the process. The Board is aware of the need to ensure access for all to the licensing process and will provide information and assistance where requested. The Board always tries to be transparent, consistent and proportionate when dealing with applications. Each application made to the Licensing Board is decided on its own individual merits within the framework of the 2005 Act.

Decisions of the Board

In the reporting period, the Board considered nine applications for a new premises licence and ten applications for a provisional premises licence. Objections to some of these applications were received, mainly relating to concerns regarding potential noise nuisance for live music, persons leaving the premises late in the evening, smokers making noise outside the premises and general anti-social behaviour. Objections were also made in relation to perceived over provision of licensed premises. Although, Fife Licensing Board has no current policy on the overprovision of licensed premises, each overprovision objection was considered. All objections were taken into account during consideration of the applications and the concerns of objectors addressed during the applicants' submissions and discussion by the Board. All nineteen of the premises/provisional premises licence applications were granted. Two confirmation of provisional premises licence were also granted.

The Board considered 26 applications for variations (other than a minor variation) to premises licences; 25 were granted, and 1 was withdrawn. As with the premises licence and provisional premises licence applications, some objections were received in relation to the applications, however, after consideration of the objections in each case the Board granted the applications.

135 applications for minor variation were received by the Board, all of which were granted by the Clerk under delegated powers.

52 applications for transfer of a premises licence were received and granted.

The Board received 531 occasional licence applications during the reporting year which is a considerable reduction on the 1105 applications in the previous year 2019/20. 507 of the applications were granted, 19 were withdrawn prior to determination and 5 were not considered. This reduction in numbers is due to events not taking place during periods of lockdown and restrictions. The Board and Licensing Team introduced a procedure to expedite the processing and granting of occasional licence applications, whilst adhering to the requirements of the 2005 Act, to assist the licensed trade in reopening after restrictions eased or in establishing outdoor areas for customers.

No applications for extended hours were received during the year which is understood to be as a result of the Covid-19 restrictions on trading by premises. Similarly, because of the restrictions, the Board did not make a general determination extending licensed hours during the 2020/21 festive period.

Spreadsheets listing the applications for premises licences, provisional premises licences, confirmation of licences, variations of premises licences, transfers, reviews of premises licences, applications for occasional licences, including the decisions taken on the applications will be published with this statement.

Reviews

In the period 1 April 2020 to 31 March 2021, three personal licence review applications and five premises licence review applications were considered by the Board.

Two of the personal licence reviews related to inconsistency with the licensing objectives. The board decided there was no grounds for the review on one and on the other review, the board made the decision to give a written warning to the personal licence holder.

The other personal licence review was in relation to a relevant offence – conviction, where the board made the decision to suspend the personal licence for 6 months.

Five of the premises licence reviews related to failing to uphold one or more of the Licensing Objectives. The board made the decision that on one of the reviews, the grounds for review was not established, they also decided that on the other four reviews that the grounds for review were established and gave two written warnings, amended the premises licence on one and no further action was taken on the other one.

The outcomes of the premises licence reviews are indicated on the spreadsheet.

Licensing Forum

There is a properly constituted Licensing Forum operating in Fife. Members consist of representatives from the on and off trade, health, police, Licensing Standards Officers and members of the public. The Board invites the Forum to comment on matters of policy and the Forum shows a keen interest in the Board's decision making and processes. The Forum responds well to requests for information and feedback, and comments on policy matters and the like.

Fife Licensing Forum meets on a quarterly basis in central Fife, mainly in the afternoon. Members of the licensing board frequently attend the licensing forum meetings to keep abreast of any issues or concerns the licensing forum may have. Board members in attendance at meetings then feed back to the Board as a whole and the process is also done in reverse whereby the board members feed any relevant information to the forum at meetings. Meetings of the forum were also affected

by the lockdown and restrictions with some meetings cancelled and others held remotely. The joint meeting of the Board and forum was held remotely in November 2020.

The Forum has not made any recommendations or given advice to the Board that has not been considered by the Board, during the period being considered by this report.

Conclusion

The operation of licensed premises was restricted to a greater or lesser extent throughout most of the reporting period. The volume of applications to the Board reduced during this period. The Board and Licensing Team worked to process applications as expeditiously as possible in line with the different ways of working which were introduced to mitigate the risk of the spread of infection and worked with the Licensing Standards Officers to give advice to licenceholders on how they could operate their premises in compliance with the restrictions. Compliance with the restrictions was generally good and the Board congratulates members of the licensed trade in Fife for their efforts in promoting and upholding the licensing objectives in difficult circumstances.

Fife Licensing Board recognises the efforts of those who have an input into the operation of the Licensing Board and will continue to work with partner agencies to ensure the good practice going forward.
