# Apply for the Young Person Under 22 Travel Scheme – Age 11 – 21

### Scottish National Entitlement Card (NEC)

Please find enclosed a paper application for the Young Person's Under 22 Travel Scheme for applicants aged 11- 21. This paper application can be used if you have not held a National Entitlement Card previously and are unable to apply online at www.getyournec.scot.

You need to complete the form and:

- If you are aged between 11-15:
  - you and your parent/guardian will have to provide Proof of Person\* along with Proof of Address and Proof of Child/Parent or Guardian relation.
  - You should also provide a Passport-style photograph\*\*

Your parent/guardian **MUST** sign the declaration on the form asking for you to be given access to free bus travel within Scotland.

- If you are aged 16+:
  - You should provide us with Proof of Person\* along with Proof of Address. **We do not require parent/guardian approval.**
  - You should attach a passport-style photograph\*\*

You **MUST** sign the declaration.

\* If you have been unable to supply photographic evidence as proof of person please arrange an appointment to attend a Customer Service Centre to have your application verified by a member of staff. Alternatively, please have the REFEREE Section completed by an approved Photo Referee. A list is on the back of the application.

\*\* If you cannot provide a passport-style photo please arrange to have a photograph taken at a Customer Service Centre.

Your application and attachments need to be verified at a Fife Council Customer Service Centre, please make an appointment to attend by calling the Contact Centre on 03451 550066. Take this letter along with your application when you attend.
