Fife Council propose to make an Order under the Road Traffic Regulation Act 1984 to introduce a 20 m.p.h. speed limit on Woodmill Rd approx. 75m from the junction with A823, Bothwell Gdns Roundabout to Woodmill Terr; Woodmill Terr for its entire length; and Woodmill Rd from Woodmill Terr easterly for approx. 400m.

The Fife Council in exercise of the powers conferred on them under section 84(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with section 124 of and Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Woodmill Road, Dunfermline - 20MPH Speed Limit) Order 2025" and shall come into operation on the day of .
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. The Fife Council (Woodmill Road, Dunfermline – Part Time 20 MPH Speed Limit) Order 2006 is hereby revoked.
5. Drawing number TRO25\_30 showing the roads affected by this Order delineated in black is annexed and signed as relative hereto.

**SCHEDULE**

Woodmill Street, Dunfermline from a point 75 metres or thereby from the junction with A923, Bothwell Gardens Roundabout to Woodmill Terrace.

Woodmill Terrace, Dunfermline for its entire length.

Woodmill Road, Dunfermline from Woodmill Terrace in an easterly direction for a distance of 400 metres or thereby.
