#### 62. WELCOME AND APOLOGIES FOR ABSENCE

The Convener welcomed everyone to the meeting and introduced newly appointed member, Sarah Crawford, Chairperson, Kingdom of Fife Branch CAMRA (The Campaign for Real Ale) and noted apologies for absence.

#### 63. CONVENER'S ANNUAL REPORT

The Forum considered the Convener's annual report providing an overview of the work of the Forum over the past year, including alcohol deliveries; volume of applications considered by the Fife Licensing Board; business rate increases; duty increases; reduction of licensed premises in Fife; alcohol-related deaths; and minimum unit pricing. Some discussion followed with members expressing varying opinions on the matters presented in the report.

#### Decision

The Forum noted the report.

### 64. APPOINTMENT OF CONVENER

In accordance with the constitution, nominations were sought for the appointment of the Convener for this year - April 2025 to March 2026.

### **Decision**

As no nominations were received, the Forum members present agreed to reappoint Gregor Hannah for a further year to April 2026. Gregor accepted the appointment.

#### 65. REAPPOINTMENT OF MEMBERS

### **Decision**

The Forum noted that:-

- (1) membership numbers were now at the maximum of 18 according to its constitution; and
- (2) Catherine Chudleigh (Consultant, Public Health, NHS Fife) would be returning as a member of the Forum for its next meeting, at which time, Dr Curnock would stand down as her substitute.

#### 66. MINUTE OF PREVIOUS MEETING - 24 NOVEMBER 2024

The Forum considered the minute of the meeting of the Fife Licensing Forum on 21 November 2024.

### **Decision**

The Forum approved the minute.

## 67. JOINT LETTER TO MINISTER FOR HEALTH, SCOTTISH GOVERNMENT RE MANDATORY TRAINING FOR DELIVERY DRIVERS/HEALTH'S ADDITIONAL NARRATIVE

The Forum considered the draft letter to the Scottish Government relating to mandatory training for drivers delivering alcohol to members of the public, agreed by the Fife Licensing Board for joint signing by the Board and the Forum.

#### **Decision**

The Forum:-

- (1) agreed, with a majority of 12 votes out of a possible 18 votes, to jointly sign the letter with the Board, subject to: a minor amendment to paragraph three to read: '...it recognises legal concerns about the ability to insist on such training ...'; correction of typographical errors; and an update to the recipient address which was now out of date; and
- (2) acknowledged that the suggested additions from Public Health and ADP at agenda item 6 (b), would be directed to the relevant recipients separately.

#### 68. POLICE REPORT

Inspector Stuart Allan, on behalf of Neil Ewing, Licensing Sergeant provided an update on Police activity since the last meeting of the Forum (which had been circulated separately), including joint Police/LSO visits to premises relating to underage sales, proxy sales, issues with management where advice had been given (for which Police Scotland would be submitting a review to the Board); sale of illegal/counterfeit vapes; Fife Pub Watch schemes; and Best Bar None awards.

### Decision

The Forum noted the update.

#### 69. LICENSING STANDARDS OFFICERS UPDATE

Douglas Hardaker (Lead Officer, Environmental Health - Public Protection) provided a verbal update on LSO activity/concerns, including: live music complaints; a revoked licence of a takeaway selling alcohol; perceived lack of appropriate training for bar staff; and concerns about a lack of comprehensive records of training undertaken by bar staff, although training for individual licence holders appeared to be kept up to date.

### **Decision**

The Forum noted the update.

### 70. UPDATES FROM FIFE LICENSING BOARD

The Forum considered the minutes of meetings of the Fife Licensing Board of 2 December 2024 and 3 February 2025.

#### Decision

The Forum:-

- (1) noted the minutes; and
- (2) acknowledged that several licence applications had been granted with 'delivery conditions', however, as these conditions were not legally enforceable, the applicant could ask that they be removed and Police Scotland would likely not object.

### 71. DATE OF NEXT MEETING

The Forum considered the dates for the meetings in 2025. Forum meeting appointments had previously been issued by the Committee Officer and meetings could be attended either in person or remotely.

#### Decision

The Forum:-

(1) agreed the meetings for the remainder of this year on 22 May, 28 August and 27 November (Thursday at 2.00 pm, Fife House); and

(2) noted that the provisional date for the joint meeting with the Fife Licensing Board, provisionally scheduled for 24 April 2025, was to be confirmed subject to the Board's agreement and there being a quorum of members available from both the Forum and the Board to attend.
