1.0 Background

1.1 In terms of the Civic Government (Scotland) Act 1982, Taxi Fare Scales require to be reviewed and completed within 18 months of the last review.

1.2 The last Review came into operation on 5th December, 2022 and, following consultations with the Taxi Associations/Taxi Operators in the forthcoming Review, any changes will be implemented on 3rd June 2024.

2.0 Issues and Options

- 2.1. Consultations require to be carried out with the Taxi Association/Taxi Operators before the Committee takes a decision on the Review.
- 2.2 In 2022 the consultations were carried out by a Sub-Committee of this Committee which consisted of the Convener, Vice-Convener and four other members and it is suggested that a similar arrangement should be continued, if necessary.

3.0 Conclusions

- 3.1 In order to enable a decision to be taken by this Committee and still allow appropriate time for advertising and the lodging of appeals, if any, a decision on the Review will require to be taken by this Committee at its meeting on 12th March, 2024.
- 3.2 A report, therefore, will be submitted to this Committee on 12th March, 2024 for a decision on what the fare scale will be for the 12 months following 3rd June, 2024.

Miscellaneous Licensing - Review of Fees

Report by: Eileen Rowand, Executive Director, Finance and Corporate Services

Wards Affected: All

Purpose

The Committee is asked to approve the increases to Miscellaneous Licensing Fees effective from 1 April 2024.

Recommendation(s)

It is recommended that the Committee approves the fees detailed in Appendix 1 of this report in respect of miscellaneous licensing with effect from 1st April, 2024.

Resource Implications

None

Legal & Risk Implications

The Civic Government (Scotland) Act 1982 gives the Council as licensing authority discretion in setting fees in respect of applications for licences under the 1982 Act and requires the authority to review the fees from time to time to ensure that the total amount of fees covers their administrative expenses in processing the applications. Fees and expenditure in respect of taxi and private hire cars including drivers require to be accounted for separately from the other types of miscellaneous licensing.

Impact Assessment

An EqIA is not required as this report does not propose a change or revision to existing policies and practices.

Consultation

The Head of Finance has been consulted in respect of the proposed fee increases. Environmental Health Service has been consulted in respect of licences in which they have an involvement.

1.0 Background

- 1.1 The 1982 Act requires the Council to review fees for licence applications to ensure that the fees generally meet the costs of administering the licensing system. The fees were last reviewed by this committee on 12 March 2019 and increased with effect from 1 April 2019. Appendix 1 to this report shows the table of fees proposed to be applied from 1 April 2024.
- 1.2 In setting fees and expenses in relation to taxis and private hire cars section 12 of the 1982 Act requires the authority to seek to ensure that the total amount of such fees is sufficient to meet the expenses incurred by them in carrying out their functions in respect of taxi/private hire car licence applications. This means that the total fees received in respect of applications for licences for taxi and private hire car operators, booking offices and taxi and private hire car drivers must be broadly equivalent to the costs and expenses of administering these applications. The costs and expenses for these type of licences include the costs for inspection and testing of vehicles, provision of plates and badges, the costs of medical inspections for some drivers as well as staffing, printing and other overheads and central support costs incurred by the Council.
- 1.3 Environmental Health Service previously carried out an exercise examining the costs incurred by them in supporting the miscellaneous licensing functions of the Council. They identified that certain types of application (principally skin piercing and tattooing) required officers to visit premises sometimes on more than one occasion and that the licensing fee was not sufficient to meet the costs of these visits. Inspections are also carried out in respect of cinema licences, late hours catering licences, some street traders' licences, indoor sports entertainment licences, public entertainment licences and market operators' licences.

2.0 Issues and Options

2.1 The Head of Finance and the Head of Legal Services have over the past few months carried out a detailed accounting exercise to identify the costs incurred in administering the taxi/private hire car applications including drivers, as well as the fee income. The total cost and expenditure statement is attached as Appendix 2 and shows that the expenditure exceeds the fee income by £23,450. The proposed increases in fees for taxi/private hire cars of approximately 10% as listed in Appendix 1 have been calculated to ensure as far as possible that the total fee income for taxi applications in the

forthcoming financial year meets the costs and expenditure of administering the scheme of licensing for taxis.

- 2.2 Environmental Health have advised that they are increasing their inspection fees by 3% in April, these new charges are detailed in the report.
- 2.3 In addition to the inspection fees set out in the foregoing paragraphs, it is proposed to increase the fees for miscellaneous licensing (other than taxis/private hire cars) by approximately 10%, as shown in Appendix 1. These fees have not increased for 5 years and the increase will meet increases in staffing and other costs over this period. Detailed work on the total cost of these types of licensing will be carried out in the forthcoming financial year.
- 2.4 The Miscellaneous Licensing Team currently carries out a number of additional administration tasks that take a considerable amount of time without charge. It is proposed that admin fees be introduced for each of these tasks, as listed in Appendix 1.
- 2.5 It is proposed to increase the fees for both taxi/private hire car applications and miscellaneous licensing applications on an annual basis in line with the Council's policy on increases in fees.

3.0 Conclusions

The increase in fees for taxi and private hire car licensing including drivers and booking offices is required to ensure that the total fees received cover the costs of administering the licensing regime. The increase in relation to the remaining miscellaneous licensing in the remit of this committee is reasonable and proportionate and will contribute to the aim of ensuring that the fee income meets in full the cost of administering the miscellaneous licensing licensing system.

Civic Government Licensing Enforcement Officer Report

Purpose

The purpose of this report is to inform members of the Committee of the activities of the Civic Government Licensing Enforcement Officer from October 2023 – December 2023.

Recommendation(s)

The Committee is asked to note the contents of the report.

Resource Implications

The costs of the officers' activities are met from the existing budget.

Legal & Risk Implications

The activities of the Civic Government Licensing Enforcement Officer will ensure the Council are seen to be taking appropriate action to ensure those individuals and companies issued with licences by Fife Council are maintaining high standards and complying with the conditions of the licences issued.

Impact Assessment

The activities of the Civic Government Licensing Enforcement Officer will not impact on any one area of the community more than any other. There is therefore no requirement for an impact assessment.

Consultation

To ensure the activities of the Civic Government Licensing Enforcement Officer are focussed on areas of particular need, close consultation is held with members of the Civic Government Licensing Team, the Convener and Vice Convener of the Committee, other services within Fife Council and Police Scotland Fife Division. Licence-holders and members of the public are consulted on a needs basis during enquiries into complaints or compliance checks.

1.0 Background

- 1.1 There is one Civic Government Licensing Enforcement Officer working 8am to 6pm Monday to Thursday, with flexibility for working outwith these hours/days. Currently, the officer is primarily working from home. The objectives of this post are to:
 - Make enquiry into complaints relating to the holders of licences under the • Civic Government (Scotland) Act 1982
 - To undertake spot checks to ensure the conditions of licences are complied with
 - To take appropriate enforcement action where conditions of licences are not being complied with
 - To improve standards of licence holders
 - To undertake joint inspections with other agencies or services of Fife Council to determine compliance with licence conditions
 - To take action in relation to unlicensed activities and report where necessary to Police Scotland (Fife Division) for consideration of prosecution

2.0 Enquiry Activity

- 2.1 This report covers the period from 1 October 2023 – 31 December 2023.
- 2.2 The Enforcement Officer has undertaken 31 enquiries into complaints, suspected non-compliance with licence conditions, requests for assistance with applications and other licensing issues. Some of these complaints have been straightforward and were easily resolved, others however have been more complex and required extended enguiry and input from other services or agencies. These enguiries included the following licensed activities:

This included 2 separate joint operations with police officers from Police Scotland.

2.5 These have resulted in the following outcomes/disposals:

- 13 No Issues
- Non-compliance with conditions of licence 7

2.6 **Facebook Update**

The Facebook page continues to be a popular means to circulate information relevant to the taxi trade in Fife. Recent posts have included:

- Road Closures and diversions •
- Changes to online applications and substitutions •
- Information on the annual test schedules
- Note of appreciation to operators on annual test results •

2.7 **Unmet Demand Monitoring**

Regular checks at taxi ranks across Fife and discussion with taxi operators continued during the period covered by this report to assess levels of demand. During the period 9 rank checks were carried out at various times of the day and night. These observations and consultations show there is no change to the level of demand for taxi services

There is not therefore considered to be any significant unmet demand for taxi services in Fife. The 2014 Halcrow report on unmet demand remains relevant.

3.0 Conclusions

3.1 The work of the Enforcement Officer continues to focus on areas of particular need through the analysis of complaints and observations in the Licensing Unit and at Regulation and Licensing Committee.

Consultation with other services and joint working is continuing to ensure a coordinated approach to enforcement where that is appropriate.

Advice

Advice was given to:

- An unlicensed individual advertising the use of executive vehicles for hire and reward
- Several taxi operators and drivers on minor complaints from the public or other operators/drivers
- A concerned operator regarding Uber operating in Fife
- A taxi driver who may have facilitated shoplifters leaving the scene after committing theft
- A local businessman on the licensing requirements for selling swords, knives, etc.
- A complainer regarding noise nuisance from a late hours catering premises

Assistance Provided

In order to assist the licensing team dealing with incomplete applications, the Enforcement Officer has made efforts to contact the applicants and obtain the documents/information that is required to progress the applications.

Licences Applied For

Market Operator Licences were applied for after intervention from the Enforcement Officer into unlicensed events.

Skin Piercing & Tattooing Licences were applied for after intervention from the Enforcement Officer into unlicensed activities.

A Vehicle Operator applied to substitute his vehicle after intervention from the Enforcement Officer regarding damage to his vehicle.

Monitor

Monitoring is continuing into the activities of taxi drivers and operators in the East and West Fife areas following complaints of non-compliance with licences.

Unfounded

6 complaints were considered unfounded after investigation; these all related to taxi drivers.

Verbal Warning

1 verbal warning was given to a vehicle operator after it was established that they had allowed the MOT on one of their fleet of taxis to expire. It was MOT'd the same day that it was pointed out to them and put down to an administrative error.

Written Warning

2 taxi drivers have been issued with written warnings:

One driver has been accused of inappropriate conduct in the taxi and the matter has also been reported to the police with an investigation ongoing. The warning has been issued pending the outcome of the police investigation.

One driver of a private hire car had parked in a taxi rank to pick up a hire. He had not yet attended the Taxi Driver Training Course and claimed to be unaware of the rank rules.

Withdrawn

3 taxi driver applications were withdrawn following intervention from the Enforcement Officer when it became clear that they were unaware of the restrictions on the lawful licensed activity. Section 2.4-2.5 gives quantitative information relating to spot checks conducted by the Enforcement Officer.

This appendix gives detail in relation to some of the outcomes listed in that section.

Checks were made on:

- 3 Late Hours Catering premises
- 3 Second Hand Dealers trading in motor vehicles
- 2 Skin Piercing & Tattooing premises offering acupuncture
- 3 Street Traders
- 9 Taxi Drivers

These included a joint inspection of Skin Piercing & Tattooing premises with PS Ewing, licensing sergeant of Police Scotland which revealed that both premises were unlicensed. Both have now applied for the appropriate licences.

A joint operation was also carried out with the Community Policing team at Kirkcaldy Police Station into Late Hours Catering premises and taxis on a Friday night. This resulted in 2 premises found to be operating after 11pm without licences and were warned accordingly. Both premises have now applied for the appropriate licences. No issues were found with the other premises.

Of the 9 taxi drivers checked, 6 were found to have no issues. 3 received warnings for breaches of the conditions of their licences:

1 driver was sent off the rank to retrieve his ID badge as he did not have it with him, he was wearing a tracksuit in contravention of the dress code (which he admitted he was unaware of) and the vehicle was in a dirty state internally.

1 driver was sent off the rank to retrieve her ID badge as she did not have it with her, no fare scale notice was within the taxi and the vehicle was in a dirty state externally and internally.

1 driver was warned due to the dirty state of the vehicle, particularly the uncovered rear seats.
