Cameron Local Place Plan Report 2024 Information Notice (Pre-Submission Notice) 11th June, 2024

A Local Place Plan (LPP) Report proposal has been prepared by Cameron Community Council, reflecting the thoughts, aspirations, conclusions, comments and opinions of the local resident community, gathered during an extensive and participative process initiated in the Summer of 2023 and completed in Spring 2024.

Area covered by the LPP:

The boundary and scope of the LPP covers all the land within the parish boundary. A map of the area is shown on the frontispiece of the Report.

Key Proposals in the LPP include but are not limited to:

- Reconsidering or completing traffic calming or speed restriction measures
- Reconsidering absent or incomplete pavements in community clusters
- Strengthening the protection of SPA Cameron Reservoir
- Supporting Craigtoun Country Park as a quality tourist and community destination
- Ensuring the Feddinch golf development includes restoration of the damaged culvert on the A915
- Re-establishing the south-north medieval pilgrim road from Earlsferry to St Andrews
- Maintaining, enforcing and extending the core paths to also provide cycle paths and bridleways
- Redesignating unused land and derelict buildings at Lathockar for new housing
- Resolving Fife Council responsibilities for the repair and maintenance of Mount Melville access road
- Clarifying and publicising reporting mechanisms for blocked ditches and minor potholes
- Preventing further holiday "lodge" developments in Cameron

These proposals are detailed, mapped where appropriate and set out within the LPP Report.

The purpose of the LPP Report

The purpose of the Cameron Local Place Plan Report 2024 is to encourage Fife Council, in a changing World, to protect the best, special qualities of our unique, rural, historic district for our local population, wildlife and environment, whilst supporting beneficial development, now and for generations to come. Once registered by the planning authority, LPPs are intended to be taken into account in the preparation of the local development plan.
