201. CIVIC GOVERNMENT LICENSING ENFORCEMENT OFFICER'S REPORT

The committee considered a report by the Executive Director, Finance and Corporate Services on the activities of the Civic Government Licensing Enforcement Officer from January to April 2025.

Decision

The committee noted:-

- (1) the extensive and varied amount of work carried out by the Enforcement Officer during the period identified; and
- (2) that there would be further updates, on the activities of the Enforcement Officer, brought before the Committee on a regular basis.

202. TAXI AND PRIVATE HIRE CAR INSPECTION TESTS FAILURES – EAST AND WEST FIFE AREAS AND LEVENMOUTH ZONE

The committee considered a report by the Service Manager – Fleet Services which provided details on what measures could be implemented for those failing the annual inspection tests.

Decision

The committee agreed that the following measures should be implemented for those operators whose vehicles failed the annual inspection tests this time around (specifically in relation to East and West Fife Areas and the Levenmouth Zone) and that these measures be taken against those operators whose vehicles fail any future inspection tests:-

- (1) All operators failing the test be called to a meeting with relevant Councillors and officers to discuss failure rates in all three areas as well as the measures to be taken against them;
- All taxi and private hire operators licensed in Fife will be advised that they will (2) have to complete and sign a declaration prior to their annual inspection tests confirming they have checked all items that are listed on the inspection test sheets issued by Fleet Services. If the declaration is not completed and returned prior to their annual test, their test will be cancelled and the operator will be instructed to return the licence plates to the appropriate garage until the declaration has been received by the garages and the vehicle has passed the annual inspection test;
- (3) Any operators with vehicles failing the annual test in future may have to wait for a re-test for their vehicle;
- (4) All vehicles failing the annual inspection test will have to undertake and pass an additional MOT test 6 months after the annual inspection test. The cost of the additional MOT test will be at the operator's expense. The details of the additional MOT certificate belonging to the vehicle that failed the annual inspection must be provided to the appropriate test centre within one week of its new MOT test. Failure to do so will result in the operator being instructed to return the licence plates to the test centre until the additional MOT certificate is received:
- (5) Spot checks would continue to be carried out on a regular basis throughout Fife; and
- (6) Any operator failing the annual inspection test in the future would be called before a hearing of the Regulation and Licensing Committee for possible suspension of their licence.

Taxi Fare Scale Review 2025

Report by: Executive Director, Finance and Corporate Services

Wards Affected: All

Purpose

The purpose of this report is to seek authority to commence the 2025 review of the fixing of scales for the fares and other charges in connection with the hire or with the arrangements for the hire of a taxi, in terms of Section 17 of the Civic Government (Scotland) Act.

Recommendation(s)

It is recommended that the Committee:-

- (1) notes the legal requirements on licensing authorities in respect of the fixing of scales for the fares and other charges in connection with the hire or with the arrangements for the hire of a taxi, in terms of Section 17 of the Civic Government (Scotland) Action 1982;
- (2) notes the process of reviewing the fares and other charges in connection with the hire or with the arrangements for the hire of a taxi; and
- (3) agrees to commence the process of reviewing the fares and other charges in connection with the hire or with the arrangements for the hire of a taxi.

Resource Implications

There are no direct financial implications arising from the recommendations of this report.

Legal & Risk Implications

There is a statutory requirement to complete the review within 18 months of the previous review which was effective from 3 June 2024.

1.0 Background

- 1.1 In terms of Section 17 of the Civic Government (Scotland) Act 1982, the licensing authority must fix scales for the fares and other charges in connection with the hire of or with the arrangements for the hire of a taxi, within 18 months of the last review, beginning with the date on which the scales came into effect.
- 1.2 The last review of taxi fares and other charges was commenced by the Committee at its meeting on 13 February 2024 (paragraph 88 of 2024.R.L.75) and following a period of consultation, a report setting out the outcome of the consultation was considered by this Committee on 12 March 2024 (paragraph 99 of 2024.R.L.92). The Committee agreed to the new scales of fares and charges proposed.
- 1.3 The current scales of taxi fares and charges came into effect on 3 June 2024 and now require to be reviewed following consultations with the Taxi Associations/Taxi Operators in the forthcoming review in accordance with the statutory 18 month timescale, the new scales must be fixed by 3 December 2025.

2.0 Issues and Options

- 2.1 All taxi operators licensed in Fife together with the Taxi Associations will be consulted before the Committee takes a decision on the review.
- 2.2 A further report will be submitted to the Committee advising of the outcome of the consultation and seeking the Committee's agreements in respect of the proposed scales of fares and charges.
- 2.3 The Committee's proposed scales will thereafter require to be published in a newspaper circulating in this area setting out proposed scales, explaining the effect of the proposed scales and proposing a date on which the proposed scales are to come into effect. Any person may make representation in writing until the date specific by the licensing authority for doing so, falling at least one month after the first publication by the authority of the proposed scales. It is also proposed to make use of the Council's social media with messages being placed on the Council's Facebook page and X (formerly Twitter) feed during this part of the process.
- 2.4 In the event that, following publication of the proposed scales, no adverse representations are received by the relevant date, if the Committee are minded to delegate authority for the purpose, the Head of Legal and Democratic Services may implement the proposed scales, as required.
- 2.5 In the event that adverse representation are received on the proposed scales, a further report will be submitted to this Committee to consider those representations.
- 2.6 The Committee is asked to note that the final decision taken by the Committee regarding scales will be intimated to taxi operators who will be afforded the opportunity to appeal the decision to the Traffic Commissioner for the Scottish Traffic Area.
- 2.7 In 2024 the consultations were carried out by a working group of this Committee which consisted of the Convener, Vice-Convener and four other members.

3.0 Conclusions

3.1 In order to enable a decision to be taken by this Committee and still allow appropriate time for advertising and the lodging of any appeals, a decision on the review will require to be taken by this Committee at its meeting on 9 September 2025.

3.2 A report therefore will be submitted to the Committee on 9 September 2025 for a decision on the fare scale which will be in operation and effective for the 12 month period following 3 December 2025.
