The Fife Council ("the Council") in exercise of the powers conferred on them by sections 1, 2 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Order may be cited as "The Fife Council (Disabled Persons' On-Street Parking Places) (Amendment No. 23) Order 2026" and shall come into operation on the day of Two Thousand and Twenty Six.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
