#### 86. SUSPENSION OF TAXI/PRIVATE HIRE CAR DRIVERS LICENCES

The Council's Lead Officer, Miscellaneous Licensing, reported to the Committee that a decision was taken by the Executive Director, Finance & Corporate Services using the powers given to her under Section 2 of the Council's List of Officer Powers 'Emergencies and Cases of Urgency' to suspend two taxi/private hire car drivers licences with immediate effect under paragraph 12 of Schedule 1 to the above Act having advised the Convener and Depute Convener of the Committee of this decision. The decision was taken as information had been received which had to be considered prior to this meeting of the Committee.

# 87. CINEMAS ACT 1985 - VARIATION OF LICENSING CONDITIONS - THE BYRE THEATRE, ABBEY STREET, ST. ANDREWS - 16 MARCH 2024

The Committee considered a report by the Lead Officer, Miscellaneous Licensing on a request to vary licence conditions to allow the theatre to screen a non-BBFC certificated film.

The Committee agreed to grant permission to allow the non-BBFC certificated film, as circulated to the Committee, to be shown by the Byre Theatre on 16 March 2024.

## 1.0 Background

- 1.1 In March 2024 the Council received notice from a representative of the Byre Theatre regarding films due to be screened as part of the Sands: International Film Festival of St Andrews between 19 – 21 April 2024.
- 1.2 This films still have to be classified by the BBFC. Therefore, as required by the Council's Standard Conditions of Licence, the Byre Theatre is seeking permission for the films, detailed in the information circulated, to be shown. The committee has previously agreed to similar variations.
- 1.3 Committee members should note that any permitted variation would relate only to the films specified as circulated to members, and any films not so specified would be required to adhere to the Council's Standard Conditions of Licence.
- 1.4 This permission will apply, as appropriate, to the Byre Theatre on 19 21 April 2024 only.

#### 2.0 Conclusions

2.1 Condition 3 of the Council's standard conditions, which applies to all cinema licences, states that:

No film shall be exhibited unless -

- (a) it has received a "Uc", "U", "PG", "12A", "12", "15" or "18" certificate of the British Board of Film Classification; or
- (b) it is a current news-reel which has not been submitted to the British Board of Film Classification.

Full conditions are attached at Appendix 1.

- 2.2 However, condition 7 of the cinema licence conditions states a film may be exhibited, or persons or any class of persons, may be admitted thereto if the permission of the Licensing Authority is first obtained and any conditions of such permission are complied with.
- 2.3 The Committee has given approval for certain venues to show uncertificated films previously.

#### CONDITIONS

- 1. The licence holder or the responsible manager, his deputy for the time being or occupier of the premises shall immediately communicate to the Chief Fire Officer of Fife Fire and Rescue Service any outbreak of fire, however slight.
- 2. All attendants on duty to assist persons entering or leaving the auditorium shall wear a distinguishing uniform, armband or badge.
- 3. No film shall be exhibited unless -
  - (a) it has received a "Uc", "U", "PG", "12A", "12", "15" or "18" certificate of the British Board of Film Classification; or
  - (b) it is a current news-reel which has not been submitted to the British Board of Film Classification.
- 4. No person under the age of 18 years shall be admitted to any exhibition at which there is to be shown any film which has received an "18" certificate from the British Board of Film Classification.
- 5. No person under the age of 15 years shall be admitted to any exhibition at which there is to be shown any film which has received a "15" certificate from the British Board of Film Classification.
- 6. No person under the age of 12 years shall be admitted to any exhibition at which there is to be shown any film which has received a "12A" certificate from the British Board of Film Classification unless they are accompanied during the showing of the film by a person of 18 years or over.
- 7. Notwithstanding the conditions hereinbefore contained, a film may be exhibited, or persons or any class of persons, may be admitted thereto if the permission of the Licensing Authority is first obtained and any conditions of such permission are complied with.
- 8. A representation or written statement of the terms of any certificate given by the British Board of Film Classification shall be shown on the screen immediately before the showing of any film to which it relates and the representation or statement shall be shown for long enough and in a form large enough for it to be read from any seat in the auditorium.
- 9. There shall be prominently exhibited at each public entrance whenever the premises are open to the public a notice indicating in tabular form and in clear bold letters and figures -
  - (a) the title of each film to be shown on that day, other than trailers and films of less than five minutes duration;
  - (b) the approximate times of commencement of each such films;
  - (c) whether each such film has received a "Uc", "U", "PG", "12A", "12", "15" or "18" certificate from the British Board of Film Classification.
  - (d) The effect of such "Uc", "U", "PG", "12A", "15" or "18" certificates in relation to the admission of persons under the age of 18 years.
- 10. The nature of any certificate received in respect of a film from the British Board of Film Classification shall be clearly indicated by the letter "Uc", "U", "PG", "12A", "12", "15" or "18" in any advertisement of the film displayed at the premises.

- 11. No advertisement displayed at the premises of a film to be exhibited at the premises shall depict as a scene or incident in the film any scene or incident which is not included in the film as certified by the British Board of Film Classification or approved for exhibition by the Licensing Authority, as the case may be.
- 12. Where the Licensing Authority has given notice in writing to the licence holder of the premises objecting to an advertisement on the grounds that, if displayed, it would offend against good taste or decency or be likely to encourage or incite to crime or to lead to disorder or to be offensive to public feeling, that advertisement shall not be displayed at the premises except with the consent in writing of the Licensing Authority.
- 13. Where the Licensing Authority has given notice in writing to the licence holder of the premises prohibiting the exhibition of a film on the ground that it contains matter which, if exhibited, would offend against good taste or decency or would be likely to encourage or incite to crime or to lead to disorder or to be offensive to public feeling, that film shall not be exhibited in the premises except with the consent in writing of the Licensing Authority.

# Taxi Fare Scale Review

Report by: Eileen Rowand, Executive Director, Finance & Corporate Services

Wards Affected: All

#### **Purpose**

The purpose of this report is to invite the Committee to consider the information provided in relation to the review of fares and to agree a fares tariff and charges for 2024/2025.

#### Recommendation

The Committee is asked to:

- consider the recommendations of the Taxi Fare Scale Review Sub-Committee and agree a fares tariff and charges for 2024/2025;
- authorise/remit to:-
  - (i) the Executive Director, Finance & Corporate Services to advertise the proposed tariff for 2024/2025; and
  - (ii) the Taxi Fare Scale Review Sub-Committee to consider any further representations following the advertisement of the proposed tariff.
- note that any person may have the opportunity to make representations in writing within one month of the first publication of the proposed scales. Thereafter the fixed scales will be advertised giving any person who operates a taxi or any person or any organisation appearing to the Traffic Commissioner to be a representative of taxi operators the opportunity to appeal to the Scottish Traffic Commissioner within a 14 day period.

#### **Resource Implication**

#### Staff time in arranging:

- for all vehicles to have their meters recalibrated, if necessary;
- to write to all those who submitted representations advising them of the proposed fare scales and allowing for appeals; and
- to advertise the proposed fares in the newspapers.

#### **Legal & Risk Implications**

There is a statutory requirement to complete the review within 18 months of the previous review which was effective from 5th December 2022.

#### **Policy & Impact Assessment**

As this review is carried within the statutory time frame, there is no requirement for any impact assessment.

#### Consultation

The Taxi Fare Scale Review Sub-Committee met with taxi/private hire car operators/taxi association representatives in Fife on 29th February 2024 to consider the written representations received and to hear their views. The note of that meeting is contained within Appendix 1 to this report.

The Sub-Committee was thereafter consulted and advised that the all items RPI had decreased from 13.4% in December, 2022 to 4.9% in January, 2024.

The Sub-Committee then considered the representations made to it and took into consideration the costs of running a taxi business, drivers' wages, running costs for cars, maintenance, cost of replacing vehicles, cost of fuel and insurance.

The Sub-Committee were of the view that there should be no increase in the level of fares this year.

A table showing sample tariffs from other Licensing Authorities as at February, 2024 is contained in Appendix 3.

The existing tariff of fares and other charges is contained in Appendix 4.

# 1.0 Background

- 1.1 At the meeting on 13th February, 2024 (paragraph 88 of 2024.R.L.75 refers) the Committee agreed that:
  - a Sub-Committee consisting of Councillors Adams, Browne, Hayes, Lindsay, MacDiarmid and Pryde consider the 2024 statutory review of taxi fares and related matters in Fife and meet with the representatives of taxi operators in Fife to make recommendations to this Committee on the level of fares for 2024/2025; and
  - a report be submitted to the Committee on 12th March 2024 for a decision on what the fare scales will be for the eighteen months following 3rd June, 2024.
- 1.2 The report is submitted in implementation of the above decision.

# 2.0 Issues and Options

2.1 As the review of fares has to be carried out at eighteen monthly intervals, to allow this to happen in this timescale the Committee has to decide the level of fares and other charges at this meeting.

The Committee can agree:-

- to accept the proposals put forward by the Sub-Committee not to make any changes to the current fare scales and other charges; or
- to make different changes to the fares and other charges than those recommended by the Sub-Committee.

# 3.0 Conclusions

- 3.1 The Sub-Committee were of the view, given the information provided, that there should be no increase in the level of fares this year.
- 3.2 It, accordingly, made the following recommendations:
  - (i) there be no increase in fares for the 18 months from 3rd June, 2024; and
  - (ii) the decision of the Committee be advertised in the press to allow for any representations which would thereafter be considered by the Taxi Fare Scale Review Sub-Committee with the final fixed scales being intimated to all operators of taxis operating in Fife.

#### **REVIEW OF TAXI FARE SCALE**

Councillor Tom Adams opened the meeting by welcoming the operators and explained that this meeting had been called as part of the review of taxi fare scales to consider representations submitted on behalf of the taxi operators. There were 10 written representations received and will be listed on Appendix 2 of the Taxi Fare Scale Report submitted to the Regulation & Licensing Committee on 12th March, 2024.

Gillian Love advised that although there had been no further written representations received, Brian Buchanan, John Gibb, Dawn Hunter and William Watson all advised they would propose that there be no increase in the fares and charges at this review. Brian Buchanan suggested there be an additional charge for the use of 8 seater vehicles and earlier times at stage 3 and 4 at Christmas & New Year.

Councillor Adams gave each of the representatives in attendance an opportunity to speak to their representations or give their views and Gillian Love advised that proposals for amending/not amending the taxi fare scales would be considered by the Sub-Committee and a recommendation would be submitted to the Regulation & Licensing Committee on 12th March, 2024. Gillian also advised that following a decision by the Committee, the proposed tariff would be advertised in the local press and would allow for any further representations. If any such representations were received, these would be considered by the Sub-Committee prior to any final tariff being advertised in the local press which would also state the rights of appeal.

Thereafter, if no appeal has been submitted to the Traffic Commissioner, it was hoped that the date for implementation of any new fare scales would be 3rd June, 2024.

Other/

Other issues raised during the discussion included:

#### Taxi and Private Hire Inspections

Gillian Love mentioned that the first-time percentage pass rates had fallen in recent times and gave the operators details that if anyone fails a test the Committee may issue a warning letter for a first failure, bring operators in for a meeting with the Convener/Depute, be given a random test or be brought in for possible suspension. It was suggested there may be automatic random testing for each failure and a charge of £50 could be charged as well as the £100 retest fee. The operators advised that it would be helpful for all licensed operators to be invited in to open days at the garage for advice on how tests are carried out.

#### Wheelchair Accessible Vehicles

Gillian Love advised that she had received a few queries around the lack of wheelchair accessible taxis and private hires in Fife, particularly the East area. Gillian asked the operators for their views on this, and they advised it was due to a combination of different reasons, mainly the lack of drivers for these vehicles as well as the cost of the vehicles.

#### Taxi Drivers Medicals

Gillian Love advised that the Council asked anyone over 70 or with an existing medical condition that might affect their driving to attend a medical assessment. However, this may change in future which could lead to everyone requiring a medical on 1<sup>st</sup> application. Thereafter anyone under 45 would self cert every 5 years until 45 then attend another medical. Thereafter they would have a medical every 5 years until they are 65 then would have to get a medical every year. (Subject to satisfactory medicals at all times). The cost of the medicals is quite excessive, and Gillian asked the operators their views on whether the driver could produce their own medicals at their own costs. The operators felt that might be too onerous on new applicants and may lead to less drivers applying for licences. Gillian advised the views would be taken into consideration if any changes were to be made.

#### Increase In Licensing Fees

Gillian Love advised that there would be an increase in fees from 1<sup>st</sup> April 2024 and that the fees have not been raised since 2019 which worked out at 2% each year. Gillian also mentioned there will be new fees for substitution of vehicles, partnership additions and duplicate licences.

#### Taxi and Private Hire Partnerships and Company Applications

Gillian Love mentioned how partnerships and company applications are dealt with in that two or more individuals can go into business as a partnership but everyone in the partnership is equally responsible for everything including the licence. Gillian suggested that anyone going into a partnership should seek independent legal advice.

In relation to company applications, licensing is looking for the legal name and number of the company, as in Companies House, as well as who is running the company and will be named on the licence as opposed to those with significant control i.e. a shareholder if they are not running the company.

#### **Emergency Works in Ranks**

Gillian Love advised that if any emergency works are required at or near a taxi rank then all taxis should vacate the rank to allow the work to be carried out. Gillian also said that it is likely a temporary taxi rank will be provided in most instances.

#### Uber

Gillian Love and Craig Ritchie advised that there had been complaints of Uber drivers operating in Fife. Craig contacted Uber and was advised that their drivers shouldn't be operating in Fife as there was no licence in Fife for this. Uber were not currently looking to be licensed in Fife.

#### Age Based Vehicle Rule

There had been a few enquiries made to licensing about a change in the above. The operators mentioned that newer cars are not lasting as long when being used as taxis and Euro 6 vehicles are a bit more complicated to run. The operators asked if vehicles over 5 years old could be considered to go on as a taxi or private hire car and lots of discussion took place around this. Gillian advised the views would be taken into consideration if there was to be a policy change to this rule.

As always, we are for small annual increases and although it was decided that there should be no increase last year I now believe that we need a substantial fare increase this year to get us back on track and hopefully next year we can get back into a routine of minimal increases which have always been better suited to the operators and the public.

Our customers are not silly, they know prices have to go up, they see bus and train fares going up and like everyone they may have an opinion but on the whole they are very understanding

I will reiterate my comments from previous years that operating taxis is not all about fuel costs! Fuel accounts for between 10 and 13% of an operators costs and although increases affect our profit levels our main concerns, as a fleet company employing staff, are the wages which take about 70% of our costs. This may not be the same for the single owner/driver businesses but for us and many other fleet owners it's the ever increasing motor insurance costs, motor maintenance costs, council licensing costs, but the biggest increase to our business's are the staff wages.

As councillors you are continually asking us to improve our standards so it's up to you to provide us with a reasonable fare structure that will allow us to continue to reinvest in our businesses. In my opinion you can not expect higher standards without giving us a decent fare increase.

I believe that this year the start price on the meter should increase by 10% keep the yardage as it is.

The costs involved in running taxi and private hire vehicles over the last 4 years have jumped considerably.

Fife Council licensing fees are about to climb 10 per cent, with the addition of other new fees.

Car prices, for a five year old within current Council allowed time limit have risen from around 6k to over 10k. If a car lasts 4 years £20 a week,

My wheelchair access i used to buy for 14k, 3 year old, low milage via motability. Now motability have made way 5 years, hence too old to put on. Should one younger not now be needed by a wheelchair user, another user gets it. In 2022 i bought 4 for £25k plus vat New, Now they are £34k plus vat new.

I am also having major issues with the euro 6 engines with lots of faults with all the electronics in cars. I currently have 2 in dealerships, which still cost me £400 a month each, since before Christmas.

Insurance is climbing at a alarming rate, usually about a third more, from around £1500 a car to £2200 a car £13 a week extra.

Tyres, brakes, and all other parts have risen about 25 per cent over the last 3 years. Drivers to earn the keep of the car, they want guarnteed money now, with the minimum wage about to goto £11.44 an hour. If you were paying this, plus holiday pay, employers n/i .etc, they would be costing you £14 a hour. To achieve this and remain in profit you would need £35 a hour. Currently a average local hire is £6, 4 hires an hour max £24 a hour, loosing money.

Currently the running mile is £2.35, to achieve £35 a hour, the car would need to do a average of 15 miles a hour.

To achieve £35 a hour, flag would need £4.50, running mile £2.50

Who pays the driver when the phones not ringing.

I appreciate that some councils are much less per mile, but Fife is spread out and can take time from dropping one hire to the next. If you were dropping off and collecting just around the corner the rate could be less..

Unfortunately customers aren't appreciate that drivers need to earn money, and with a lot off non regulated vehicles now on the road offering lifts due to taxis being so expensive, the trade will suffer over time. We need to explain to customers costs involved.

Thank you for your emails.

Both of us would like to attend on Thursday.

We are only just now in the process of submitting our tax returns for 2022-23 so do not have income and expenditure figures from our businesses to indicate the rise in costs, and I'm not sure they would show the rising costs clearly as we have expanded our business significantly since taking over St Andrews Taxis in 2022. The expansion has been funded by capital injection.

The following are where we have noticed a significant rise in costs in the last year - the links supply evidence:
