INSURANCE

All Wildfowlers require to hold Third Party Public Liability Insurance Cover for £5,000,000 minimum. This is a condition of issue of Permits and it should be noted that NO Permit will be issued unless proof has been provided that the applicant holds such Insurance Cover, e.g. BASC Membership, copy of relevant section of Household Insurance Policy etc.

GENERAL

All Wildfowlers will be required to follow the "Notes for Guidance of Wildfowlers" issued to Permit holders. Wildfowlers are particularly requested to complete carefully the return on the Permit and include <u>all</u> visits to the Reserve. It should also be noted that all Permits <u>must</u> be returned to the Fife Council <u>within 21 days</u> of the end of the season.

In order to aid the control of the Permit System, please notify changes of address/vehicle registration number during the season promptly to avoid any unnecessary difficulties regarding identification of Wildfowlers by the Countryside Ranger.
