

THE FIFE COUNCIL (VARIOUS STREETS, CUPAR - 40 M.P.H. SPEED LIMIT) ORDER 2025

On 26/06/2025 Fife Council made an Order under the Road Traffic Regulation Act 1984, the effect of which is as stated in the issue of the Fife Herald published on 31/01/2025.



**THE FIFE COUNCIL (VARIOUS STREETS, CUPAR –
40 M.P.H. SPEED LIMIT) ORDER 2025**

The Fife Council in exercise of the powers conferred on them under sections 84(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with section 124 of and Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Various Streets, Cupar - 40 m.p.h. Speed Limit) Order 2025" and shall come into operation on the Eleventh day of July Two Thousand and Twenty Five.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. Drawing numbers TRO23_63-4, TRO23_63-5, TRO23_63-6 and TRO23_63-7 showing the roads affected by this Order delineated in black are annexed and signed as relative hereto.



| A916 | From a point 142 metres of thereby south of the junction with South Road in a southwesterly direction for a distance for 400 metres or thereby. |


- Westfield Road** From a point 24 metres or thereby west of the junction with Drum Road in a southwesterly direction for a distance of 820 metres or thereby.
- Brighton Road** From the extended southwest boundary line of property Firbank in a southwesterly direction for 480 metres of thereby.

Cupar Muir** From a point 354 metres or thereby southwest of the junction with Spruce Gardens in a southwesterly direction for 512 metres or thereby.

Picture caption: Plans showing extents of 40mph speed limits in Cupar area:






