Levenmouth Reconnected Programme Grant Awards

Wards Affected: Ward 21 – Leven, Kennoway and Largo, Ward 22 – Buckhaven, Methil and Wemyss Villages

Purpose

The purpose of this report is to allow Committee to consider projects recommended for funding from the third round of the Levenmouth Reconnected Programme Large Grant Fund and progress on the small grants programme.

Recommendation(s)

It is recommended that Committee:

- Approves funding for the Mountfleurie Industrial Estate Site Servicing project as detailed in Appendix 1 & 2 from the Levenmouth Reconnected Programme fund; and
- 2. Agrees to increase the small grants fund by a further £50,000 from the Levenmouth Reconnected Programme fund.

Resource Implications

The total grant award remaining for recommended projects is \pounds 7,265,170. The total grant awarded to small projects from the budget of \pounds 100,000 is currently \pounds 88,410. An additional \pounds 50,000 is sought for this programme. This would be funded from the approved Levenmouth Reconnected Programme budget. Should the recommended large grant fund project be approved and an additional \pounds 50,000 be allocated to the small grants programme \pounds 6,531,674 would remain in the LRP budget.

Legal & Risk Implications

Legal Services has reviewed and agreed the Grant terms and conditions.

An Equality Impact Assessment and a Fife Environmental Assessment Tool (FEAT) assessment have not been completed because the report does not propose a change or revision to existing policies or practices. Individual projects will carry out their own Impact Assessments.

Consultation

Fife Council Financial Services, Legal Services and the Communications and Customer Insights team have been consulted in preparing this report.

Consultation has been undertaken with the Levenmouth Reconnected Working Group and Oversight Group, and Transport Scotland in the assessment of individual projects.

1.0 Background

- 1.1 The process to approve grant awards from the £10m Levenmouth Reconnected Programme (LRP) fund was approved by the Policy & Coordination Committee on 13 May 2021 (2021 PC78 para. 296 refers). The committee agreed that larger grant applications, seeking over £5,000 (up to a maximum of £5m), would be assessed by a Working Group panel with a recommendation made to the Oversight Group for approval and then advanced to the Levenmouth Area Committee for decision. Small Grant awards are assessed and processed by the Levenmouth Local Community and Neighbourhoods Panel.
- 1.2 The first round of the Large Grant Award programme saw Levenmouth Area Committee approve five projects with a total value of £1,638,402 (Levenmouth Area Committee of the 23rd of March 2022, 2022 LAC 132 para 312 refers).
- 1.3 The second round of the Large Grant Award programme saw two projects considered for funding by the assessment panel. However, due to the need to consider these projects within the anticipated wider programme, on 14 September 2022 Levenmouth Area Committee agreed that a final decision on an award to these projects should be deferred (2022 LAC 4 para 10 refers).
- 1.4 In round three for Large Grant funding, applications were received from seven projects. These were assessed by the LRP Working Group panel and presented to the LRP Oversight Group and Ward Councillors. They agreed that further information was required from all projects before a decision could be made on funding.
- 1.5 Additional information was requested and received from two community-based projects allowing these to be assessed further by the LRP Working Group panel and discussed with Ward Councillors and the LRP Oversight Group.
- 1.6 In February 2023, Fife Council was awarded £19.404m from the UK Government Levelling Up Fund, with £14.424m specifically allocated to the Levenmouth Active Travel Network and the Leven River Park Routes. Applications to Sustrans' Places

for Everyone (PfE) programme were also made for these projects and these have been successful, subject to confirmation of funds from Transport Scotland for 2023/24. The Sustrans PfE panel recommended a total award of £5.772m.

1.7 A feasibility study is currently being undertaken to determine options for improvements to the Levenmouth bus network. This study is programmed to be complete by September 2023 and options will be presented to the LRP governance groups and Ward Councillors to determine the preferred options. It is anticipated that a bid to the LRP Large Grant fund would then be made for this project.

2.0 Issues and Options

- 2.1 The LRP Oversight Group has recommended that the following project receives LRP grant funding:
 - Mountfleurie Business Park Site Servicing
- 2.2 Appendix 2 summarises this project.
- 2.3 Appendix 3 summarises projects that have been successful in receiving small grants and shows the benefits and outcomes delivered.
- 2.4 The original small grant project budget of £100,000 is nearly fully committed (£88,410 at June 2023). This programme has funded a range of small local projects delivering across the themes of the Levenmouth Reconnected Programme
- 2.5 Given the value of the Small Grant Project Budget and the local desire for its continuation, it seems appropriate for a further £50,000 to be added to the budget.

3.0 Conclusions

3.1 The project applications for Large Grant Funding received to date have been scrutinised and it is recommended that the Mountfleurie Industrial Estate Site Servicing project be recommended for approval. The project meets the objectives of the Levenmouth Reconnected Programme.

Project summary:

This project will help continue to accelerate the social and economic benefits of the Levenmouth reinstated railway by unlocking 1.05 hectares of currently vacant and derelict land (VDL) to give a net developable area (NDA) of circa.0.81 hectares after roads and drainage allowance for employment land. Refer to Appendix 1

The site is located at Mountfleurie Industrial Estate which sits adjacent to a key gateway route in the locality. Within Fife Council ownership the site is located within equal distance of both the proposed Cameron Bridge and Leven railway stations. Refer to appendix 1A.

This site also benefits from being an allocated employment site within Fife's Local Development Plan (FIFE plan, 2017) which describes the site as suitable for development for the following class uses:

- Class 4 business use as an office, research and development of products and processes and any industrial process
- Class 5 general industrial use for the carrying on of an industrial process other than one falling within class 4
- Class 6 use for storage or as a distribution centre

The remediation and servicing of this VDL site requires public sector enabling investment to unlock the site and create market ready employment land. This could attract private sector investment of circa £4M-£5m, stimulating private sector confidence in the area and providing end use employment opportunities. Monies allocated from Fife Council Vacant and Derelict Land Fund will help remediate the site however further capital to service this site is necessary to avoid delays in realising this opportunity.

The proposed remediation and site servicing works will ensure the site is immediately developable for employment use and will ensure the locality has a necessary supply of connected and accessible employment land. This will not only act as a driver for economic growth but complements the investment being made in the reinstated railway to support sustainable workforce mobility.

This project will:

- Bring back into productive use 1.05 hectares of recognised vacant and derelict land which will provide a net development area of 0.81 hectares reducing the amount of currently un-redeveloped brownfield sites across Levenmouth to help stimulate economic growth, create jobs, tackle inequalities, and improve the physical environment.
- Attract additional private sector investment to Levenmouth using data from comparable projects, it is anticipated that this project will lever in an estimated additional £4M - £5m of private sector investment based on the net developable area (NDA) and average build costs.
- Contribute to inclusive growth by extending labour market opportunities across the locality. At optimum level and depending upon eventual end user requirements supporting in the region of 57 direct 114 indirect job opportunities by unlocking this site for enterprise investment and development.
- Tackle climate change by creating sustainable accessible employment land and opportunities connected by different modes of transport e.g. the reinstated railway alongside the planned mobility hub and active travel networks

Linking to the strategic investment being made in reinstating the Levenmouth Railway this project was highlighted and accepted as a key area of focus detailed within the Levenmouth Reconnected Programme Economic Development Strategic Brief (prepared 30 April 2021 V1.0) which was communicated across partners and stakeholders including community anchor organisations and elected members and received cross party and community partner support.
