MADE ORDER

THE FIFE COUNCIL (A955, EAST WEMYSS) (SPEED LIMITS) ORDER 2025

The Fife Council ("the Council") in exercise of the powers conferred on them under sections 84(1) and 124(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (A955, East Wemyss) (Speed Limits) Order 2025" and shall come into operation on the Second day of June Two Thousand and Twenty Five.

2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the Schedule to this Order.

3. The Fife Council (A955 Dysart to Buckhaven – 40 m.p.h. Speed Limit) Order 2005 ("the Principal Order") shall have effect as follows:

In the Schedule to the Principal Order at the entry A955 Coaltown of Wemyss to East Wemyss the words

"to a point 15 metres or thereby west of the projected western kerblines of Hendrie Road, East Wemyss"


shall be deleted and the words

"to a point 190 metres or thereby southwest of the extended west kerblines of Hendrie Road, East Wemyss"

substituted therefor.

4. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
5. Drawing number TRO25/07 showing the roads affected by this Order delineated in black is annexed and signed as relative hereto.
