# **Civic Government Licensing Enforcement Officer Report**

## **Purpose**

The purpose of this report is to inform members of the Committee of the activities of the Civic Government Licensing Enforcement Officer from January 2025 – April 2025.

# Recommendation(s)

The Committee is asked to note the contents of the report.

## **Resource Implications**

The costs of the officers' activities are met from the existing budget.

# Legal & Risk Implications

The activities of the Civic Government Licensing Enforcement Officer will ensure the Council are seen to be taking appropriate action to ensure those individuals and companies issued with licences by Fife Council are maintaining high standards and complying with the conditions of the licences issued.

#### **Impact Assessment**

The activities of the Civic Government Licensing Enforcement Officer will not impact on any one area of the community more than any other. There is therefore no requirement for an impact assessment.

#### Consultation

To ensure the activities of the Civic Government Licensing Enforcement Officer are focussed on areas of particular need, close consultation is held with members of the Civic Government Licensing Team, the Convener and Vice Convener of the Committee, other services within Fife Council and Police Scotland Fife Division. Licence-holders and members of the public are consulted on a needs basis during enquiries into complaints or compliance checks.

# 1.0 Background

- 1.1 There is one Civic Government Licensing Enforcement Officer working 8am to 6pm Monday to Thursday, with flexibility for working outwith these hours/days. Currently, the officer is primarily working from home. The objectives of this post are to:
  - Make enquiry into complaints relating to the holders of licences under the Civic Government (Scotland) Act 1982
  - To undertake spot checks to ensure the conditions of licences are complied with
  - To take appropriate enforcement action where conditions of licences are not being complied with
  - To improve standards of licence holders
  - To undertake joint inspections with other agencies or services of Fife Council to determine compliance with licence conditions
  - To take action in relation to unlicensed activities and report where necessary to Police Scotland (Fife Division) for consideration of prosecution

# 2.0 Enquiry Activity

- 2.1 This report covers the period from 1 January 2025 30 April 2025.
- 2.2 The Enforcement Officer has undertaken 47 enquiries into complaints, suspected non-compliance with licence conditions, requests for assistance with applications and other licensing issues. Some of these complaints have been straightforward and were easily resolved, others however have been more complex and required extended enquiry and input from other services or agencies. These enquiries included the following licensed activities:

2.4 49 Spot checks have been conducted by the Enforcement Officer on the following licensed activities:

# 2.6 **Unmet Demand Monitoring**

Regular checks at taxi ranks across Fife and discussion with taxi operators continued during the period covered by this report to assess levels of demand. During the period 42 ranks checks were carried out at various times of the day and night. These observations and consultations show there is no change to the level of demand for taxi services.

There is not therefore considered to be any significant unmet demand for taxi services in Fife. The 2014 Halcrow report on unmet demand remains relevant.

#### 2.7 Additional Activities

On the 18<sup>th</sup> of February 2025, in response to local issues involving the taxi trade and late hours catering premises in the St Andrews area, the Enforcement Officer attended a team briefing of police officers at St Andrews Police Station and delivered an input on the licensing requirements and conditions applicable to taxis/PHCs and late hours catering premises. This was well-received and has since been followed up with a day of action.

# 3.0 Conclusions

3.1 The work of the Enforcement Officer continues to focus on areas of particular need through the analysis of complaints and observations in the Licensing Unit and at Regulation and Licensing Committee.

Consultation with other services and joint working is continuing to ensure a coordinated approach to enforcement where that is appropriate.

This appendix gives more detail in relation to some of the outcomes listed in that section.

#### **Advice**

Advice was given to:

- An unlicensed individual advertising on social media that she was available to 'do lifts' for payment.
- Several taxi operators and drivers on minor complaints from the public or other operators/drivers
- Several vehicle operators following complaints from neighbours about drivers on contracts sounding their horns when attending the pick-up address.
- A Street Trader regarding a similar complaint of an excessively loud horn when delivering fish
- A funfair operator regarding a complaint from the public about noise and anti-social behaviour

#### **Assistance Provided**

In order to assist the licensing team dealing with incomplete or unclear applications, the Enforcement Officer has made efforts to contact the applicants and obtain the documents/information that is required to progress the applications.

Assistance has also been provided to other Services e.g. Trading Standards, Environmental Health, etc. through joint visits to licensed premises.

#### **Application withdrawn**

A taxi driver application was withdrawn after involvement from the Enforcement Officer when it was discovered that the applicant had restrictions on his Right to Work in the UK and he would be breaching these by driving a taxi.

#### **Monitor**

Monitoring is continuing into the activities of a taxi driver in the Leven area following an unsubstantiated complaint of inappropriate behaviour where the police have been involved.

A Street Trader's activities are also being monitored following a complaint of obstruction and littering.

Monitoring is also continuing into the activities of a taxi driver who has been reported to the police for alleged theft/embezzlement of the takings from at least 2 taxi companies he has worked for.

## **Other Agency**

Information has been passed to the police regarding unlicensed activities following complaints from the public.

# **Report to Committee**

2 separate complaints from the public against a taxi driver in East Fife have resulted in the Enforcement Officer submitting a report to the Committee seeking suspension of his taxi driver licence.

#### Unsubstantiated

14 complaints were considered unfounded after investigation; 2 of these related to street traders while the others all related to taxi drivers/operators.

# **Verbal Warning**

8 verbal warnings were given to taxi drivers for a variety of infringements of their licences.

#### **Written Warning**

One driver of a taxi has been issued with a written warning after admitting that he undertook the complainer's car on a dual carriageway, having been granted his current licence with a warning. He was also required to re-attend the Taxi Driver's Training Course and sit a driving assessment at his own expense, which he has complied with.

Section 2.4-2.5 gives quantitative information relating to spot checks conducted by the Enforcement Officer.

This appendix gives detail in relation to some of the outcomes listed in that section.

#### Checks were made on:

- 7 Late Hours Catering premises
- 3 Second Hand Dealers
- 4 Street Traders
- 35 Taxi Drivers

A joint operation was carried out with the Road Policing officers of Police Scotland, Fife Division on 18<sup>th</sup> April 2025 in the East Fife area.

Of the 35 taxi drivers checked, 31 were found to have no issues. 4 received warnings for breaching the conditions of their licence. All 4 were failing to display their ID badge.

Of the 7 late hours catering premises, 5 were found to have no issues. 2 were failing to display their licences.

1 of the 3 second hand dealers was also failing to display their licence and had to request and pay for a copy of their licence.

1 of the street traders was found to have another member of staff serving the public who was unlicensed. They have since applied for a licence.

# TAXI AND PRIVATE HIRE CAR INSPECTION TEST FAILURES – EAST AND WEST FIFE AREAS AND LEVENMOUTH ZONE

Purpose:

To advise the Committee of the outcome of a meeting held to discuss measures for those failing the annual inspection tests in East and West Fife Areas & Levenmouth Zone

It is recommended that the Committee agrees to the measures detailed below.

# 1.0 Background

- 1.1 This report gives the outcome of the meeting held on 13th May 2025 as directed in the decisions detailed in minute reference numbers 186, 187 & 188 of 2025.R.L.148.
- 1.2 At the meeting held on 6th May three test reports for the above areas were considered and as there were a number of failures at annual inspection the Committee agreed to continue consideration of these three items to allow the Convener & Vice Convener together with the previous Convener of the Committee, Cllr. Lindsay, to meet with Council officers to consider what measures could be taken against those operators whose vehicles failed the annual inspection tests this time around and whether these measures could be introduced to all operators who had any vehicles failing the annual inspection tests in future.

# 2.0 Issues and Options

- 2.1 Councillors Adams, Browne & Lindsay agreed that the following measures should be taken against those operators whose vehicles failed the annual inspection tests this time around. It was also agreed that these measures should be taken against those operators whose vehicles fail any future inspection tests:
  - All operators failing the test be called to a meeting with the above-mentioned Councillors and officers of the Council to discuss the failure rates in all three areas as well as the measures to be taken against them;
  - All taxi & private hire operators licensed in Fife will be advised that they will have to complete and sign a declaration prior to their annual inspection tests confirming they have checked all items that are listed on the inspection test sheets issued by Fleet Services. If the declaration is not completed and returned prior to their annual test, their test will be cancelled and the operator will be instructed to return the licence plates to the appropriate garage until the declaration has been received by the garages and the vehicle has passed the annual inspection test;
  - Any operators with vehicles failing the annual test in future may have to wait for a re-test for their vehicle;
  - All vehicles failing the annual inspection test will have to undertake and pass
    an additional MOT test 6 months after the annual inspection test. The cost of
    the additional MOT test will be at the operator's expense. The details of the
    additional MOT certificate belonging to the vehicle that failed the annual
    inspection must be provided to the appropriate test centre within one week of
    its new MOT test. Failure to do so will result in the operator being instructed to
    return the licence plates to the test centre until the additional MOT certificate
    is received;

- Spot checks will continue to be carried out on a regular basis throughout Fife
- If the new measures are agreed by the Committee, any operator failing the annual inspection test in the future will be called in to a hearing by the Regulation & Licensing Committee for possible suspension of their licence.

#### 3.0 Conclusions

3.1 As the Committee was disappointed in the failure rates at annual test it is felt appropriate to introduce the above measures to increase the number of vehicles passing the test first time.
