145. NOTICE OF MOTIONS

The Council considered a report by the Head of Legal and Democratic Services which requested the Council consider the motions submitted in terms of Standing Order No. 8.1.

The Provost advised that in agreement with the movers of the motions, given the similarities between Motions No. 4 and 6 on the agenda, these motions were to be conjoined. The wording of the revised conjoined motion was circulated for members information.

Motion 1

Councillor Liston, seconded by Councillor Brett, moved as follows:-

Fife Council agrees to:

- 1. Declare a 'Climate Emergency';
- 2. Work with others, taking the lead if necessary, to make Fife carbon neutral by 2030, taking into account both production and consumption;
- 3. Work with partners and community groups across Fife to deliver this new goal through all relevant strategies and plans, and encourage them to adopt the likes of our Environmental Assessment passed earlier this year in the consideration of each new policy and procedure;
- 4. Assist communities to become more resilient to the impacts of global warming, particularly to flooding and to drought

- 5. Ensure that all reports in preparation for the 2020/21 budget will take into account the actions the council will take to address this emergency;
- 6. Report to Full Council before the end of 2019 with the actions the Council has, and will take, to address this emergency.

Amendment

Councillor Vettraino, seconded by Councillor Hamilton, moved as follows:-

"Council agrees to declare a Climate Emergency for Fife and, as the only democratically elected body representing Fife alone, to provide leadership in working with others to address urgent challenges of climate change.

Council recognises that what is needed are results not rhetoric and by merely expressing wants does not make them happen.

Council further agrees to:-

- 1. Acknowledge the latest target set by the Scottish Parliament and to seek to reduce Fife's carbon emissions by 75% compared with the baseline by 2030 reduce by 90% by 2040 and be carbon neutral by 2045;
- 2. Continue to develop its Sustainable Energy and Climate Action Plan, which is currently under preparation for consultation and due to be submitted for final consideration by the Environment and Protective Services Committee in February 2020;
- 3. That the Plan should include a clear strategy and actions with realistic targets, to address climate change and achieve the overall target for reduction in carbon emissions, and should take account of the 12 point guidance on taking forward the climate change emergency agenda locally produced by the Association of Public Service Excellence;
- 4. Taking account of the capacity and resources, both required and available to it, that the Council will incorporate the cost of climate change adaptation and mitigation within its budgetary decisions;
- 5. To engage with its community planning partners to revise the Plan4Fife to include a clearer commitment and actions to address climate change;
- 6. To assist communities to be more resilient to the impacts of global warming and climate change and work with partners and communities across Fife in pursuit of these targets.

Councillor Graham, seconded by Councillor Smart, moved as follows:-

"Fife council notes and applauds the news that the Levenmouth Rail Link is to be open with an investment of £75m to reinstate the line plus additional investment with the Levenmouth blue print to the Levenmouth area from both Fife Council and Scottish Government.

Council also recognises that the credit for this life and area changing announcement needs to go to the members of the Levenmouth Rail Campaign, Fife Council and Scottish Government staff along with the people of Levenmouth.

We thank the members of LMRC for the work they have done and with the professionalism in which they have executed their campaigning."

Decision

The Council agreed the motion unanimously.

Motion 3

Councillor Liewald, seconded by Councillor Marjoram, moved as follows:-

"That this Council recognises and acknowledges the problems and anxieties of perimenopausal and menopausal women and ensures that all staff are treated fairly, equally and with dignity and respect, whilst seeking to improve their well-being, comfort and general health. Furthermore that this council are committed to introducing a policy that will positively impact on our female work force, with this Council providing appropriate support to women who are experiencing symptoms of the menopause."

Decision

The Council agreed the motion unanimously.

Conjoined Motions 4 and 6

Councillor Calder, seconded by Councillor Beare, moved as follows:-

"Council notes the significant negative impact and threats a 'No-Deal Brexit' would have on public services, residents, businesses and other organisations across Fife. Council notes that the Westminster Parliament has legislated to prevent a no-deal Brexit, agrees that the UK should in no circumstances leave the EU on a no-deal basis and condemns the Prime Minister's suspension of the UK Parliament found to be unlawful by the Court of Session in Edinburgh, and the Supreme Court in London.

Council asks the Council Co-Leaders to write to the Prime Minister in that regard."

Councillor Dempsey, seconded by Councillor David J Ross, moved as follows:-

"Council notes we have to leave the European Union in order to uphold the democratic outcome of the 2016 referendum and that we need to leave on the best deal possible."

Amendment 2

"Council further condemns the Prime Minister's flippant use of pejorative and inflammatory language that is whipping up division in our society and creating an environment that encourages hate speech, verbal abuse and the threat of physical violence"

With the agreement of the Provost, the mover of the conjoined motion agreed to accept amendment 2. For the purposes of the vote this became the substantive conjoined motion.

Councillor Barratt, seconded by Councillor Marjoram, moved as follows-

The International Treaty to Prohibit Nuclear Weapons

"Fife Council is an active member of the Nuclear Free Local Authorities (NFLA), and the Hiroshima-led Mayors for Peace; both of which have been working for almost four decades to promote multilateral nuclear disarmament.

NFLA and Mayors for Peace work with the International Campaign to Abolish Nuclear Weapons (ICAN), which received the Nobel Peace Prize for its work in encouraging over two thirds of United Nations members to agree to the International Treaty to Prohibit Nuclear Weapons (TPNW).

Council supports ICAN's new 'Cities Appeal' which urges Councils to formally support the TPNW. It has already been signed by a number of important global cities likes Hiroshima, Nagasaki, Paris, Berlin, Oslo, Washington DC, Toronto, Sydney, Melbourne, Los Angeles, Geneva, Mainz, Trondheim, Zaragoza and in the UK, Manchester, Renfrewshire, Edinburgh, West Dunbartonshire and Hebden Royd.

In supporting the Cities Appeal, Council is deeply concerned about the grave threat that nuclear weapons pose to communities throughout the world. We firmly believe that our residents have the right to live in a world free from this threat. Any use of nuclear weapons, whether deliberate or accidental, would have catastrophic, farreaching and long-lasting consequences for people and the environment. Therefore, we warmly welcome the adoption of the Treaty on the Prohibition of Nuclear Weapons by the United Nations in 2017, and we call on the UK Government to join it.

Council agrees to sign the Cities Appeal and instructs the Chief Executive to write to the UK Government to inform them of this resolution and urge them to take account of it."

Amendment 1

Councillor Miklinski, seconded by Councillor Dempsey, moved as follows:-

"Council recognises that a Government's first priority is the security of its citizens. In a world where totalitarian states such as North Korea, Russia and China hold substantial nuclear weapons and the means to deliver them, the possession of an independent, credible nuclear deterrent represents the ultimate guarantor of the UK's security. Council agrees that wishful thinking is not an effective nuclear policy."

Amendment 2

Councillor Brett, seconded by Councillor Lothian, moved as follows:-

"Council seeks a nuclear free Britain and a nuclear Free World. Council believes that these aims, and all of Britain's interests, are best advanced by actively and constructively/

constructively working with the UK's allies and partners in the European Union, the Commonwealth, the United Nations and NATO to develop effective global solutions.

Britain needs to step down the nuclear ladder, pursue multi-lateral disarmament and meet the UK's obligations as a signatory to the Treaty on the Non-Proliferation of nuclear weapons."

Amendment 3

Councillor Guichan, seconded by Councillor Noble, moved as follows:-

"Add

Council recognises Fife's economy and history of supplying highly skilled manufacturing work for the Ministry of Defence and therefore calls for the establishment of Defence Diversification Agencies at Scottish and UK levels, with a focus on ensuring a just transition for communities whose livelihoods are based in the defence sector and that jobs, engineering and scientific skills are not lost."

With the agreement of the Provost, the mover of the motion agreed to accept amendment 3. For the purposes of the vote this became the substantive conjoined motion.

Amendment 2 - 6 votes Amendment 1 - 12 votes Conjoined Motion - 40 votes

Decision

As there was a clear majority, the Council agreed in terms of the conjoined motion.
