367. MINUTE

368. ALLOTMENT & COMMUNITY GROWING STRATEGY 2024-2029 UPDATE

The committee considered a report by the Head of Communities and Neighbourhoods Service providing an update on progress of the Allotment and Community Growing Strategy 2024-2029.

369. TACKLING MARINE POLLUTION - MEMBERSHIP OF KIMO UK AND KIMO INTERNATIONAL

Decision

Decision

374. AFFORDABLE HOUSING PROGRAMME - ELGIN STREET, DUNFERMLINE (PRIVATE REPORT)

The committee considered a report by the Head of Housing Services updating on progress to conclude legally binding agreements for the delivery of 41 social rented homes at the site known as Elgin Street, Dunfermline.

Decision

The committee:-

- (1) authorised the Head of Legal and Democratic Services to enter into legally binding agreements on terms to their satisfaction to enter into a Design and Build Contract for the development of 41 new affordable homes at the Elgin Street, Dunfermline site; and
- (2) to approve an indicative price for the development, recognising that the figure may be adjusted as detail of the proposal was finalised.
