# 153. STATUTORY REPORT TO SCOTTISH PARLIAMENT ON THE NUMBER OF ASSESSORS AND AVAILABLE RESOURCES

#### 154. ANNUAL HEALTH AND SAFETY REPORT 2024-2025

#### 159. ARTIFICIAL INTELLIGENCE

The committee considered a report by the Head of Business Technology Solutions outlining the potential benefits and risks associated with the adoption of Artificial Intelligence (AI) technologies within Fife Council which was the single most impactful digital development offering transformative opportunities for enhancing service delivery, improving efficiencies, enriching jobs and achieving better outcomes for residents of Fife.

#### Decision

The committee noted:-

- (1) the current and potential range of significant benefits that Fife Council could achieve through the use of Al technologies;
- (2) the need for governed approaches to mitigate risk and build trust in Al;
- (3) the impacts that the explosion of AI usage within populations could have on the council as a public service provider;
- (4) that further investment in AI technologies and investment in the adoption of AI would be required to deliver potential benefits; and

(5) the roles of the Digital Programme, Digital Portfolio Board and CET Reform Board in agreeing, governing and reporting on progress of Al.
