# 170. DIVERSION OF CORE PATH 329 AND RIGHT OF WAY – LOMOND QUARRY, GLENROTHES

The committee considered a report by the Head of Planning Services asking members to agree to promote and, if unopposed, confirm an order under S208 of the Town and Country Planning (Scotland) Act for the diversion of Core Path 329 and right of way at Lomond Quarry, Balgillie, Glenrothes.

# **Decision**
