# 55. UPDATE ON EXPERIMENTAL SCHOOL EXCLUSION ZONE AND PROPOSED PARKING RESTRICTIONS - PITCOUDIE PRIMARY SCHOOL (IONA PARK, GLENROTHES)

The Committee considered a report by the Head of Roads and Transportation Services:

- providing an update on the experimental School Exclusion Zone for Pitcoudie Primary School; and
- (2) seeking approval of a proposal to introduce a parking restriction in Pitcoudie Avenue and lock-up site, Glenrothes.

#### **Decision**

The Committee:-

- noted the update on the experimental School Exclusion Zone for Pitcoudie Primary School; and
- (2) requested a report to a future meeting on the proposed parking restrictions within the lock-up site following consultation with Ward members, Housing Services and owners of the lock-ups. Officers were asked to explore with Housing Services the appropriateness of a barrier system to address inconsiderate parking arising from the Temporary Experimental School Exclusion Zone if this became permanent.

The Committee adjourned at 3.45 pm and re-convened at 4.00 pm

#### 56. REPORT ON EDUCATIONAL OUTCOMES - 2021/22

The Committee considered a report by the Executive Director, Education and Children's Services providing details of the attainment outcomes achieved by pupils within the area's schools during the school year 2021/22. The report also provided an overview of the range of strategies being developed to support the key priority to raise attainment.

#### **Decision**

The Committee noted:-

- (1) the overall progress in raising levels of attainment in 2021/22; and
- (2) the strategies being implemented to raise attainment.

## 57. SUPPORTING THE GLENROTHES LOCAL COMMUNITY PLAN – AREA BUDGET REQUEST – THRIVING PLACES

The Committee considered a report by the Head of Communities and Neighbourhoods seeking funding for the 2022/23 financial year to support an increased Police resource in the Glenrothes Area for one year initially, following a rise in anti-social behaviour and violent crime. The total amount of funding requested was £47,178 split as follows: Ward 13 - £16,701; Ward 14 - £17,220; and Ward 15 - £13,257.

#### **Decision**

The Committee:-

- (1) approved the funding request for the additional Police resource, which was key to a successful partnership approach in addressing the rise in antisocial behaviour and violent crime and agreed the funding be split across the Ward budgets as follows:
  - Ward 13: £16,701;
  - Ward 14: £17,220;
  - Ward 15: £13,257;

- (2) noted Police Scotland would match this spend to create a team of two Police officers dedicated to addressing anti-social behaviour; and
- (3) requested an update report for this Committee's consideration in 9 months' time on outcomes in addressing anti-social behaviour and violent crime in the Glenrothes area.

## 58. SUPPORTING THE GLENROTHES LOCAL COMMUNITY PLAN – AREA BUDGET REQUEST – CLD SUMMER PROGRAMME

The Committee considered a report by the Head of Communities and Neighbourhoods relating to an application from the Glenrothes Area Community Learning and Development (CLD) Team seeking £26,420 from the Local Community Planning budget to support CLD led activity for children, young people and families during the summer break.

#### **Decision**

The Committee:-

- (1) agreed to allocate £26,420 of funding from the Local Community Planning budget to support the CLD led activity detailed in the report;
- (2) noted that the CLD led activity would form part of a wider summer partnership programme;
- (3) requested an elected member briefing detailing all other activities in addition to that funded and provided by Fife Council in the Glenrothes area for children, young people and families during the summer break; and
- (4) requested an outcome report for this Committee's consideration at its meeting on 4 October 2023, including the uptake of the summer activities, by whom and from where in the Glenrothes area children, young people and families had travelled.

## 59. SUPPORTING THE PLAN 4 GLENROTHES AREA: COMMUNITY RECOVERY FUND

The Committee considered a report by the Head of Communities and Neighbourhoods seeking approval of £40,800 funding from the Community Recovery Fund to support a range of proposals for the Glenrothes area as follows:-

- (a) Hope, Health and Happiness Brighter Futures Health Hub project (£14,300); and
- (b) Community Kick About and Children's Activity Groups Glenrothes Community Sports and Health Hub (£26,500) to cover the project for 2 years.

#### **Decision**

The Committee:-

- (1) agreed to allocate a total of £40,800 funding from the Community Recovery Fund as follows:-
  - (a) Hope, Health and Happiness £14,300; and
  - (b) Community Kick About and Children's Activity Groups £26,500;
- (2) noted sufficient funds were available in the Community Recovery Fund to support the proposal; and
- (3) noted that the balance remaining in the Reform and Recovery budget following the allocations approved at (1) above was £1,183,482.

The Committee considered a report by the Executive Director, Finance and Corporate Services relating to the workplan for future meetings of the Glenrothes Area Committee.

## **Glenrothes Flood Study - Summary Findings**

**Report by:** John Mitchell – Head of Roads & Transportation Services

Wards Affected: Wards 13, 14 and 15

#### **Purpose**

To update Committee on outcomes of the Glenrothes Flood Study.

#### Recommendation(s)

It is recommended that the Committee:

- (1) Note the status of the Glenrothes Flood Study as being concluded;
- (2) Note the summary findings of the Glenrothes Flood Study in this report;
- (3) Note that flood mitigation recommendations extend to enhanced watercourse maintenance in a number of locations, to be taken forward by Fife Council.

#### **Resource Implications**

Funding has been made available in previous Financial Years to carry out identified Flood Studies and follow-up works. A programme of works to carry out flood mitigation measures will be created accordingly. Any mitigation measures greater than £0.010m will require Capital resources to deliver.

#### **Legal & Risk Implications**

There is a risk that continued reactive mitigation could lead to a higher number of claims made to the Council for remuneration in line with perceived Council liability to protect private property. Carrying out investigation and follow up works will help to mitigate against this risk.

#### **Impact Assessment**

An Equalities Impact Assessment (EqIA) and a Fife Environmental Assessment Tool (FEAT) are not required as this report does not propose a change or revision to existing policies and practices.

#### Consultation

Consultation with Finance, Scottish Water, SEPA and Scottish Government has been carried out to inform this report.

## 1.0 Background

- 1.1 It is well documented that instances of flooding have increased in both frequency and intensity over recent decades. The Royal assent of the Flood Risk Management (Scotland) Act 2009 is evidence of the importance placed on this change to the environment and the impact of the flood hazard on Scottish communities.
- 1.2 Fife Council as a 'Responsible Authority' under the above Act, is tasked with certain activities whose sole aim is to mitigate the impact of flooding within areas for which it has remit.
- 1.3 Fife Council has two Flood Studies, a Surface Water Management Plan, an Integrated Catchment Study and a Scottish Water Section 16 Sewer Study within the Glenrothes Area Committee region.
- 1.4 The Glenrothes Flood Study was awarded to Amey OW Ltd (operating as Amey Consulting) on 09 August 2021 (following development of the project and procurement that started in March/April 2021) with an anticipated completion date of 08 August 2022.
- 1.5 Due to COVID-19 delays, the draft findings were made available to Fife Council in November 2022, and were to be followed by a series of Consultation sessions to take feedback from a range of Stakeholders. The last of which took place via email (due to calendar conflicts when seeking to arrange a meeting) on 17 March 2023. Feedback was requested by 31 March 2023; no significant comments supplied.
- 1.6 The 'Final Optioneering Report' was made available to Fife Council on 25 April 2023.

### 2.0 Issues and Options




Figure 1- Study area boundary and watercourses (from Glenrothes Flood Study - Hydraulic Modelling Report, 2022)

2.1. The Glenrothes Flood Study focussed on the Leven catchment from its confluence with the River Ore, and included the Back Burn, Balbirnie Burn, Coul Burn, Conland Burn and the Lothrie Burn. See Figure 1 for coverage.

- 2.2. The Flood Study followed the standard assessment methodology used for all Flood Studies in Scotland (see Background Papers 1 & 2 linked at the end of this document).
- 2.3. Data was gathered, assessments of flood risk were undertaken, and identification of potential mitigation options completed.
- 2.4. The SEPA Guidance 'Long List' of options is available in the Glenrothes Flood Study Optioneering Report v3 (24 April 2023).
- 2.5. The 'Long List' was then reviewed, and scores applied to each criterion appropriate to the location. The output of this process was a 'Short List' of actions to be considered in detail.
- 2.6. The completion of the flood modelling exercises concluded that while no properties were identified as being at risk of flooding, two locations were identified where infrastructure (roads, bridges and other transport routes) were potentially at risk.
- 2.7. The 'Short List' options to be taken forward included (ordered by preference):

- 2.8. Each of these 'Short List' options was assessed for costing and economic appraisal in line with the standard Treasury Green Book approach (100yr appraisal period, December 2022 prices).
- 2.9. It should be noted that it is not an obligation of Fife Council to undertake the reservoir inspections. Rather, it is the responsibility of the Reservoir Manager. Fife Council will therefore liaise with the Reservoir Manager in order to carry out the necessary reservoir inspections.
- 2.10. The two Capital Expenditure items will be considered against future budgets as they are not eligible for Scottish Government flooding budget contributions; there are no properties identified at risk of flooding.

### 3.0 Conclusions

- 3.1 The key conclusion from the Flood Study, based on the agreed assessment approach is that the likelihood of flooding affecting properties in Glenrothes for flood events with a fluvial return period greater than or equal to 0.5% AEP + 53% CCU (i.e. 1 in 200yr return period plus a suitable allowance for climate change, and in line with NPF4 defined 'area at risk of flooding) and 0.1% AEP (I.e. the 1 in 1000yr return period event) along the River Leven, Lothrie Burn, Back Burn, and their tributaries is minimal.
- 3.2 Further, the hydraulic modelling assessment concluded that there were zero properties potentially affected by flooding in the 50% AEP event (i.e. the 1 in 2yr return period event).

- 3.3 Yearly maintenance of highlighted watercourse reaches will be factored into existing Fife Council programmes.
- 3.4 There is no economic feasibility for flood protection options. The items noted above that are in private ownership and have capital Expenditure costs associated with them are Natural Flood Management proposals. There is however a need to bear in mind 3.1 above, that states that property inundation is currently expected to be minimal, so the need to take forward anything other than typical watercourse maintenance does not appear necessary.

## **Safer Communities Team Update Report**

Wards Affected: Glenrothes area (Wards 13, 14 and 15)

#### **Purpose**

The purpose of this report is to provide elected members with an update on the operational activity of the Safer Communities Team within the Glenrothes committee area during the 12 month period 1st April 2022 to 31st March 2023.

#### Recommendation(s)

The Committee is asked to note and comment on the activity to date.

#### **Resource Implications**

None.

#### **Legal & Risk Implications**

None.

#### **Impact Assessment**

An Equality Impact Assessment (EqIA) is not required as this report presents an update on the activity of the Safer Communities Team. No policy or funding changes are being proposed that are likely to have an impact on equality groups.

#### Consultation

Consultation has taken place with community safety partner agencies.


## 1.0 Background

- 1.1. The purpose of this report is to update elected members on the activity of the Safer Communities Team (SCT) within this committee area during the financial year 2022-23.
- 1.2. This report sits alongside individual updates from Police Scotland and Scottish Fire and Rescue Service (SFRS). It should be noted that the three core agencies (Police Scotland, SFRS and Fife Council's SCT) may comment on work carried out *in partnership* with each other and other agencies but cannot comment specifically on work carried out independently by other services.
- 1.3. Some information may be included on Fife-wide activity to raise awareness of the range of activities which may be of interest to members and their constituents.
- 1.4. Each activity is categorised as either People or Place focussed.

## 2.0 People Focussed Activity

- 2.1. Our Fife Cares service received 116 referrals in relation to **home safety advice** during 2022-23, an increase on the number received in the previous year (105 referrals). All clients were contacted and offered either a visit or a telephone contact.
- 2.2. The majority of referrals (97%) related to requests for tailored home safety advice specifically for families with children under five years of age.
- 2.3. In the last financial year, the majority of home safety referrals for child safety were received from Health Visitors (60%), whilst the remainder come from a variety of other sources such as Community and Family Nurses, Social Work, Housing Officers, and family support services such as Fife Gingerbread and Homestart.
- 2.4. Over the same period, referrals for home safety in relation to vulnerable adults were predominantly received from Social Work Services and Housing Services (53%), but also come from Community Nurses, Fife LGBT, Frontline Fife, Housing Associations and Safer Communities Officers.
- 2.5. During 2022-23, officers from the Safer Communities Team attended quarterly meetings of the Accident Prevention and Safety Awareness Cross Party Working Group chaired by Claire Adamson MSP and held at the Scottish Parliament. At the March 2023 meeting, as part of the 10<sup>th</sup> anniversary celebrations of the group, officers were invited to present a "good news" input on the Fife Cares service. This included information on how the service keeps abreast of changes, emerging trends and risks, and how it evolves in response. This input was extremely well received and led to further discussion between those in attendance. Appendix 1 contains details of the input delivered.
- 2.6. Referrals to the Fife Cares service regarding **home security advice**, under the Safe, Secure and Supported at Home initiative, decreased during 2022-23 compared to the previous year (77 and 95 respectively).

- 2.7. Safe Secure and Supported at Home referrals are mainly received from Police Scotland (54%), but also from other sources such as Fife Women's Aid, Housing Officers, Health Visitors and Social Work.
- 2.8. During 2022-23, Fife Cares staff were asked to provide 24 separate inputs to groups or community events across Fife, and at one national event, on the subject of Home Safety and Security. Four of these events took place in the Glenrothes committee area.
- 2.9. **Fife Community Safety Support Service** (FCSSS) is funded by the Safer Communities Team to provide support and/or mediation to those experiencing, or involved in, antisocial behaviour in a private space setting. The service received 38 referrals, an increase on the previous year (30).
- 2.10. Of the referrals received by FCSSS, seven resulted in the provision of emotional or practical support whilst the remaining 31 involved some form of mediation between the parties involved.
- 2.11. Appendix 2 provides examples of feedback received by FCSS plus some additional information on the service.
- 2.12. As of 17<sup>th</sup> January 2022, the Safer Communities Team became the single point of contact for all cases of private space antisocial behaviour (ASB). This, coupled with the increase of private space ASB during the pandemic, has led to a significant increase in cases dealt with by the team, as demonstrated by the following graph:




2.13. Of the cases within the Glenrothes committee area which were closed in 2022-23, 95% were resolved within locally agreed timescales. Please see table 1 below for timescales involved and appendix 3 for the Scottish Housing Regulator's definition of resolved cases.

2.14. Our **Pest Control** officers responded to 441 requests for service during 2022-23, compared to 545 in the previous year. The number and type of pests dealt with are depicted in the following chart:




- 2.15. Eighteen reports about **stray dogs** were received by the Safer Communities Dog Wardens, a slight decrease from the previous year (19). Sixteen of the dogs were microchipped, but none reflected the correct details of their owners. Fourteen dogs were subsequently claimed/returned to their owner and the remaining four were passed to an animal charity for assessment prior to being rehomed. Officers continue to raise awareness of the importance of microchipping and the legislation in force.
- 2.16. In 2022-23, Safer Communities Project Officers resumed their **Dog Watch** initiative, a project aimed at commercial dog walkers across Fife, which began in 2019 but had to take a break during the pandemic. This project aims to encourage commercial dog walkers who use Fife's parks and greenspaces to sign up to a voluntary scheme and register their details with the Council. By complying with the criteria within the scheme, commercial dog walkers can:

- reduce their impact on local parks and other users
- set a good example to other dog walkers
- deliver a safe and quality service for their customers
- 2.17. The wider public benefit from Dog Watch by knowing that those dog walkers who have signed up to the scheme have been individually inspected including their vehicles to ensure they are safe for transporting dogs. In 2022-23, a total of 17 dog walkers have joined, four of whom are from the Glenrothes area.
- 2.18. Reports of attacks by dogs during lambing season are unfortunately becoming more common. In partnership with Police Scotland, Safer Communities Team set up a pilot event at Falkland Estate on Friday 10<sup>th</sup> March to engage with members of the public and to provide awareness of the importance of keeping their dogs on the lead and under control, particularly during lambing season. This event also provided us with the opportunity to speak to the public about dog fouling and other wildlife issues.
- 2.19. Due to the success of this event and further reports about attacks, we hosted a similar event in Blairadam Forest on 12<sup>th</sup> April 2023. Whilst this event occurs within the current financial year, we felt it important to share this information now rather than wait to report it next year. The Blairadam Forest event included more partners to support the day, including Fife Coast and Countryside Trust, Forestry Commission, National Sheep Association, SSPCA (Scottish Society Prevention of Cruelty to Animals), PARC (Partnership against Rural Crime), Police Scotland. The event received national attention and was covered by STV, raising awareness at a crucial time in the lambing season and hopefully preventing further attacks across the country, not only in Fife. The plan is to make these annual events which we will host at various locations around Fife.
- 2.20. The Fife Community Safety Partnership has recently reinvigorated the Road Casualty Reduction Group, in which officers from Safer Communities Team are involved. Our Project Officers provided a number of **Road Safety** initiatives which covered the whole life spectrum from birth onwards (see appendix 4 for road safety activities focussed on each life stage).
- 2.21. Whilst some events were delivered to a Fife-wide audience, the following were delivered specifically within the Glenrothes committee area:
  - Junior Road Safety Officers Initiative (6 schools 33 pupils)
  - Safe Drive Stay Alive (3 schools 427 pupils)
- 2.22. Appendix 5 provides additional information about the range of road safety initiatives involving the Safer Communities Team in 2022-23.
- 2.23. Safer Communities Project Officers, in partnership with Transportation Services, Police Scotland, Scottish Fire and Rescue Service, and Scottish Ambulance Service, launched a Fifewide competition for primary schools to promote the new national **Roadstars** road safety resource. Carlton Primary School won the Roadstars Competition and were awarded £500 towards road safety resources for the school. Further details on this are included in

- appendix 5, along with additional information about the range of road safety initiatives currently co-ordinated by Safer Communities Project Officers.
- 2.24. Project Officers from the Safer Communities Team support the Fife Water Safety Group, which is a working group set up under the Fife Community Safety Partnership's Reducing Harm priority). During 2022-23, our officers attended the Train the Trainer for Waterside Responders Course, and they are working with RNLI to set up a course in 2023-24 for local businesses. The aim is to have local responders on hand in areas where water safety issues may occur.
- 2.25. Our project officers also identified the gap for an emergency first aid and water safety course for Wild and Open Water Swimmers. SCT officers will work with RNLI to create a suitable course to offer to these groups during 2023-24.
- 2.26. Our Youth Justice Officers received 45 referrals about young people in the Glenrothes area from the Youth Offender Management Group (YOMG) during 2022-23, an increase on the previous year (17). This is due to the increased capacity of Safer Communities Youth Justice Officers, following successful recruitment during 2022-23.
- 2.27. In previous years, we have been able to provide statistical evidence that our work with young people creates positive outcomes. Unfortunately, the information we use to demonstrate the success of our activity is held by Police Scotland and is currently unavailable due to a change of systems. We hope to be able to access this valuable information at a later date. In the meantime, our Youth Justice Officers are working on methods of obtaining feedback from young people and the different people involved in their lives to provide a qualitative evaluation of the work they carry out.
- 2.28. Appendix 6 provides more information about our youth justice activities during 2022-23.

## 3.0 Place Focussed Activity

3.1 In terms of **environmental enforcement** issues, 1372 requests for service were received for the Glenrothes area during 2022-23. The following graph shows comparative figures for the past three years:



- 3.2 There are 7 Safer Communities Officers deployed within the Glenrothes area, 2 of which address issues of low-level antisocial behaviour/neighbour disputes within domestic properties. Whilst the other 5 SCOs are authorised to take enforcement action for environmental offending, due to the hours of operation and the other tasks associated with their role, most of this work is carried out by 2 members of staff and the other 3 predominately focus on public space antisocial behaviour and noise complaints. Appendix 7 provides data showing the number of reports per type of Environmental Enforcement over the past three years.
- Our Safer Communities Officers (SCOs) carried out 2242 **patrols** in this area over the reporting period, an increase on the previous year (1853 patrols). The patrols have covered a variety of community issues, including public space antisocial behaviour, dog fouling, youth issues, fire raising, noise, vandalism, motorbike vehicle misuse, littering, fly tipping, fly tipping, drugs misuse and partnership working. Support referrals, intelligence and requests have come from a number of sources including but not limited to public reporting, Police colleagues, Fire colleagues Elected Members, Housing, Social Work, Education and partnership meetings. Although the patrols are mainly of a preventative nature, providing reassurance to members of the public, SCOs were required to take further action in 144 incidents.
- 3.4 A large number of these patrols (346) were carried out at Glenrothes Bus Station. SCO's work in partnership with Police, Clued Up, and our Youth Justice Officers in relation to youth disorder. SCO's attend to support bus station staff and provide a visible presence for members of the public. They engage with the young people in the area monitoring for any anti-social behaviour/vandalism/fire setting/consumption of alcohol and intervene where necessary.
- 3.5 At the end of January SCO's carried out a week of dawn and dusk twilight patrols in areas of concern around Glenrothes regards dog fouling, patrols were carried out early morning and late afternoon, many dog walkers were

- engaged with, providing them the reasons why the SCO's were there and the penalties for failure to pick up after their dogs.
- 3.6 In October 2022, a roadside litter campaign was run in the Glenrothes area. The Council's Domestic Waste and Street Cleansing Service Verge Cleaning Teams worked on the verges and the central reservation of the B921 from Bankhead to Kinglassie and involved lane closures, with street cleansing teams manually litter picking and mechanically sweeping the road channels. The Safer Communities Officers supported this initiative by engaging with local businesses, members of the public and by displaying signs, posters and stickers in car parks, laybys and prominent places along the route.

## 4.0 Campaigns and events

- 4.1. Team members are normally involved in a variety of **events** throughout each year. Due to the ongoing impact of the pandemic during 2022-23 we continued to utilise our **social media** platforms to convey the community safety message to the residents of Fife. We provided information, advice, and assistance on a number of different campaigns. We had over 8,500 followers on Facebook during 2022-23 and, overall, we reached over 685,000 people across Fife. See appendix 8 for further information.
- 4.2. In order to keep up to date with forthcoming events and activities co-ordinated by the Safer Communities Team or shared by the Team on behalf of partner agencies, members are invited to 'like' our Facebook page **Safer Communities Fife** or follow us on Twitter **@safeinfife**.

### 5.0 Conclusion

5.1 This report provides members with information on the wide range of safer communities' activity being undertaken in this committee area, in line with local priorities and emerging issues, and in partnership with other community safety organisations.

#### Fife Cares Input to Cross Party Working Group March 2023

Good news story of the Fife Cares Service where we provide free child safety visits and free home safety visits for vulnerable adults.

- This service is of the utmost importance to the people who are receive it and are working in it
- It is vital to maintain the service to help reduce unintentional harm and make a difference to those we can reach
- We continue to face huge challenges of reducing budgets and the increasing costs of everything, from staff costs to fuel and equipment
- We are continually examining our methods of working and the menu of equipment we provide as well as advice we give
  - We must examine our equipment against costs to see if there is an alternative way to deliver the safety involved
  - An example of this is to deliver safety gates along with appropriate advice instead of fitting stair gates
  - We are providing more advice both verbal and written in form of booklets and have produced our own library of booklets with advice, as well as utilising resources from other partners
  - We are also involved in making our delivery more efficient and effective such as delivering advice through discussion with groups such as nursery mums and elderly forums etc.
- In our partnership with RoSPA we look at what they are doing and have done and learn from their experience and knowledge. We also share what we are doing with them.
- Through partnership working we take on board issues raised at CPG (Cross Party Working Group) such as the danger of button batteries, and work with partners such as Child Accident Prevention Trust to promote safer use of such batteries.
- We promote these messages through events and social media as well as at each
  visit we carry out. Now we are finding that more parents of young children at visits
  are aware of these dangers. We do however continue to spread the messages.
- Evaluation of what we are doing is essential to our continued improvement—


- We use mobile working and utilise computer tablets to record our visits and now have evaluation questions on our work tablets for each visit
- We have just completed a pilot with a Child Nursery Focus Group examining what we do regarding child safety visits to find out what the parents think and what matters to them
- We listen to clients at our visits and collate information about what they need and what is important to them – recently we have had several issues raised around child car seats and we are also trained by RoSPA to check these and to provide appropriate advice.
- It is essential to attend important forums such as CPG to listen to and communicate with partners even when, on face of it, the subject does not seem connected. An example of this was Health and Safety in Waste Mgt. – Lithium-Ion battery risks – home fire risks


- We continue to work together to prevent unintentional harm


- All referrals were responded to within 2 working days



#### **Road Safety Initiatives**

#### In Car Safety


Clinics and Individual checks – SCT staff continue to carry out child car seat clinics, especially to coincide with National Child Safety week. In 22/23 we hosted three clinics, one in Dalgety Bay (SWF) with 10 seats checked, one in Leuchars (NEF) with 4 seats checked and one in conjunction with Police Scotland at Leven Prom with 16 seats checked.

Fife Women's Aid Training – Our staff are also in the process of carrying out training to Fife Women's Aid to assist them with the knowledge of how to fit their car seats safely when transporting children for their work.

#### **Primary**

**Roadstars Competition** – To promote the new national Roadstars road safety resource SCT partnered with Transportation services to launch a Fifewide Primary School competition. To encourage entries we pulled together our own version of

what we were asking schools to do with a number of partnering agencies and the Provost (Roadstars Song Partnership Version 2) A number of schools from across Fife entered and the eventual winner was Carleton Primary (Carleton Roadstars - YouTube), who were awarded £500 to place towards road safety resources at their school. They have chosen to use these funds to place markings in their



**Don't Park Here Campaign** – Just before the end of the 2021/22 school year, we again partnered with Transportation to run a new initiative called <u>Don't Park Here</u>. The aim being to produce short videos to discourage adults from parking irresponsible around the gates of schools and especially on yellow zig zags. We worked with three schools in Cowdenbeath, Dunfermline and Leven to produce these videos that schools could use on their social media in the new academic year.

JRSO Initiative – Our team continue to support the Junior Road Safety Officer (JRSO) initiative across all Fife Schools. During this financial year we have visited 37 primary schools to help establish JRSO's within their schools. The area breakdown for these schools is as follows (other schools are continuing to run the programme but have not needed our assistance to set up this year).

**Leuchars Event** – SCT were invited to Leuchars Army Base to attend a primary school event. Over 400 P6/7 pupils from schools across Fife attended an engagement day organised by Leuchars. We hosted a couple of workstation at the event, one was focussed on road safety using our reaction timers and snakes and ladders game, the other station was based around responsible recycling and was run by two SCO's.





Individual Inputs – In November we were invited into Hill of Beath Primary to talk to all of their pupils about road safety during two assemblies. This is a service we offer if there has been an issue at the school around road safety. As this was a cycling issue, we partnered up with the Bikeability Co-ordinator from Transportation.



#### Secondary

**S1 Talks** – Our project officers have continued to carry out S1 talks within the Kirkcaldy area, as we cannot provide this input to all schools we looked to where our resources are needed most, and this area has the highest number of statistical evidence for need for inputs. In 22/23 we carried out 25 class talks to 625 S1 Pupils at Balwearie HS (10 classes / 261 pupils), Kirkcaldy HS (9 classes / 220 pupils) and St Andrews HS (6 classes / 144 pupils).

**St Andrews HS** - In December 2022 a S2 pupil was unfortunately involved in a road traffic collision on coming out of school. The school then invited us in to deliver a short input at year group assemblies to S1-S4 (647 Pupils) and then we also talked to individual S1 (6 classes / 144 pupils) and S2 classes (6 classes / 145 pupils).

**S3** Project with Kirkcaldy HS – We were approached by the Guidance team in Kirkcaldy HS to help them create a suitable road safety resource that will engage their S3 pupils. We are working with them on this and hope to have something in place for the new academic year.

#### Safe Drive Stay Alive

**Inputs and follow Up Resource** – We have now fully moved the SDSA programme away from Rothes Halls and are taking the input directly to each school. This is still a partnership project but is led and co-ordinated by Safer Communities. All 18 high

schools received the SDSA input and this year we also were able to deliver to St Leonard's Private School in St Andrews. A total of 2480 pupils received the input.

We have also produced a follow up resource for the guidance staff to use within PSE classes. This enables the teachers to gain discussion with the pupils.

**SDSA Future** – This year we have also filmed other partners so that we can keep the film up to date with the most relevant content. We are also in discussions with Education to pursue the option of SDSA being a set part of the curriculum rather than an opt in programme.

#### **Pass Plus**

We continue to support and fund new drivers to gain additional driving knowledge and experience. This financial year we have held 4 online courses with a total of 12 new drivers attending. This project continues to have support from a Fife Road Policing officer. Numbers are not high in this project as funding is limited.

#### **Road Traffic Offenders**

**Course** – This 5 week course is run by Criminal Justice, but we are invited to present an input during week 1 and then present SDSA in week 5. This financial year only one course has taken place with 12 participants from across Fife. The next course is planned for May 2023.

**New Project** – Criminal Justice have contacted us about developing a new resource for Fife residents who they need to work with but are not in the system long enough to attend one of the above courses. We have had an initial meeting with them to discuss this and hope to create something for later this year.

#### **Taxi Drivers**

The Taxi Driver course has not run since early 2020 due to covid. Licencing have recently brought together all the partners to discuss setting up the courses again and they are due to start in April 2023. Safer Communities presents a generic road safety input at each of these dates.

#### **Older Drivers**

**Talks** – We currently offer talks to older groups about how to stay driving safely for longer. This financial year we have given 5 talks.

**Practical Days** – Last year we introduced the new Drivewise 65+ days. This is a practical session for older drivers who attend a venue and go on a drive observed by a Road Policing officer. They are then given hints and tips to help keep them safe and driving for longer. We held two events during the last financial year.

#### **Radio Campaigns**

**Slow Down for Schools** – We produced this radio campaign to encourage drivers to think about their speed when they are driving near to schools when the pupils are starting and finishing. The messages were recorded by safer Communities staff and Police Scotland. The plan is to have two campaigns running during the year, one at the start of the academic year in Aug/Sept and one when the pupils go back after Christmas. Due to funding, we did not hold this campaign in Aug 2022 but created a partnership with Ford in Dec 2022 and they supported our Jan 2023 campaign.

#### Partnership with Ford

We formed a partnership with Fife Ford in Dec 2022 and as part of this they are funding our radio campaigns for Slow Down for Schools, and we also hope to hold future radio campaigns on other subjects in 2023.

#### Youth Justice activities

Our officers co-ordinate or take part in activities and provided advice, guidance and information to young people, their parents/guardians and also professionals from other agencies, all of which is designed to support young people and to prevent them becoming involved in problematic behaviour, lifestyles or situations.

Listed below are some of the activities our Youth Justice Officers (YJO) were involved in during 2022-23:

 No Knives Better Lives inputs at Viewforth High School, Inverkeithing High School and Wade Academy.



- Anti Social Behaviour inputs at Auchtermuchty PS, St Johns PS, Kings Road PS, Methilhill PS, Rimbleton PSS, St Columbas HS, Warout PS.
- Diversifire at Dunfermline, Lochgelly and Methil.
- F24 program at Auchmuty High.
- Leading a Park Gowf diversion in Kirkcaldy in partnership with Fife Golf Trust and Dunnikeir Golf Club.
- Part of a partnership response to youth ASB in Cupar,
   Dunfermline and Glenrothes (supporting Clued Up and Cupar Youth Café).
- Supporting the Creative Change Collective Tic Tok program over 12 weeks delivered in Kirkcaldy.



- We have also supported
  young people both individually and in groups
  at Inverkeithing HS, Woodmill HS, St
  Columbas, Auchmuty HS, Madras College,
  Lochgelly HS.
- Co facilitating Ask/Tell Suicide Prevention training with Fife Health and Social Care Partnership.

  - o Brighter Futures Health Hub
  - YAP Group.



We asked our Youth Justice Officers to answer the following questions about work they took part in during 2022-23:

#### Why did you get involved in specific projects?

We attend regular meetings such as Youth Offending Management Group (YOMG), youth work meetings, strategy groups, Mentors in Violence Prevention (MVP) strategy group amongst others, as a result of attending these meetings it identifies opportunities to offer support.

#### Who, or which agencies, asked for your help and who have you helped?

Partners such as Education, Police Scotland and SFRS mainly. Other third sector partners we have approached directly - this is for support with their expertise, such as BRAG with their F24 experience or Clued Up to support programs with their inputs.

#### What partnership working took place?

Each partner plays to their strengths and knowledge base, e.g. – at Diversifire, SFRS lead the 'drill yard' element and YJO's are responsible for identifying and supporting the young people to complete the course successfully. Police Scotland lead an Anti-Social Behaviour input as well as provide an officer for the week to show the human side of Policing. Clued Up deliver a harm reduction input surrounding alcohol and substance use.


#### What was the outcome of your involvement with young people?






## **Environmental Enforcement Reports received by Safer Communities Team** by Type and Year


















#### **Safer Communities on Facebook**

- During 2022-23, the Safer Communities Team social media platforms:
  - attracted a total of 8,533 followers
  - o received 1,229 new page likes

# Proposed Waiting Restrictions – Iona Park, Pitcoudie Avenue and Pitcoudie Avenue Lockups

Report by: John Mitchell, Head of Roads & Transportation Services

Wards Affected: Ward 15- Glenrothes Central and Thornton

#### **Purpose**

The purpose of this report is to allow the Glenrothes Area Committee to consider proposals to introduce "No Waiting at Any Time" restrictions on Iona Park, Pitcoudie Avenue and at the Pitcoudie Avenue lockups site.

#### Recommendation(s)

It is recommended, in the interests of accessibility, that Committee:

- agrees to the promotion of a Traffic Regulation Order (TRO) to introduce the restrictions detailed in drawing no. TRO/23/40\_2 and TRO/23/40\_3 with all ancillary procedures; and
- 2. authorises officers to confirm the Traffic Regulation Order within a reasonable period unless there are objections.

#### **Resource Implications**

The cost to formally promote this TRO and deliver the associated traffic management works will be approximately £2,000, which covers Roads & Transportation Services' and Legal Services' staff costs, advertising and delivery of the new markings. This will be met from approved Service budgets.

#### **Legal & Risk Implications**

There are no known legal or risk implications.

#### **Impact Assessment**

The general duties section of the impact assessment and the summary form have been completed. No negative impacts have been identified.

#### Consultation

The local Ward Councillors, Parking Management team, Police Scotland, Housing Services, lockup owners and residents of Iona Park have been advised.

Formal consultation required by the Roads Traffic Regulation Act 1984 for the TRO process will be carried out through the posting of legal notices in a local newspaper and on the affected length of roads. In addition, details of the proposed TRO will be made available on Fife Council's website.

## 1.0 Background

- 1.1 On the 24<sup>th</sup> of May 2023 committee considered a report seeking approval to introduce parking restrictions on Iona Park and Pitcoudie Avenue lock up site. It was also proposed to change the single yellow lines on Pitcoudie Avenue to double yellow lines.
- 1.2 Committee requested officers to conduct consultation with Ward members, housing services, residents and lock up owners.
- 1.3 Officers were also asked to explore a barrier system at Pitcoudie Avenue lock ups with Housing Services.

## 2.0 Issues and Options

- 2.1 The three properties on Iona Park which would be affected by these restrictions were sent a letter on 13/06/2023. Out of the three properties, two have responded in favour to these restrictions while the other property has not replied. Responses attached to this report.
- 2.2 The Pitcoudie Avenue lockup users were also sent a letter on 03/07/2023 and out of the 27 letters that were sent we received 6 replies in favour. The rest haven't responded. Responses attached to this report.
- 2.3 The single lines on Pitcoudie Avenue will be changed to double yellow lines to eliminate any confusion drivers may have on whether they can or cannot park on this stretch of road.

## 3.0 Conclusions

3.1 In the interests of accessibility, it is recommended that a TRO is promoted to introduce a "No Waiting at Any Time" restriction on Pitcoudie Avenue, Iona Park and Pitcoudie Avenue lockups as detailed on drawing number TRO/23/40\_2 and TRO/23/40\_3.






Appendix 1 – Drawing no. TRO/23/40\_1 – Existing Parking Restrictions

# Proposed 20mph limit - at new development off A911 Kinross Road, Leslie

Report by: John Mitchell, Head of Roads & Transportation Services

Wards Affected: Ward 14 - Glenrothes North, Leslie and Markinch

#### **Purpose**

The purpose of this report is to allow the Glenrothes Area Committee to consider proposals for a new 20mph speed limit in the proposed development west of Leslie cemetery.

#### Recommendation(s)

It is recommended, in the interests of road safety, that Committee:

- 1. agrees to the promotion of a Traffic Regulation Order (TRO) to introduce the restrictions detailed in drawing no. TRO23\_30 with all ancillary procedures; and
- 2. authorises officers to confirm the Traffic Regulation Order within a reasonable period unless there are objections.

#### **Resource Implications**

The cost to formally promote this TRO will be approximately £2,000 which covers Roads & Transportation Services' and Legal Services' staff costs and advertising. This will be met from approved Service budgets. Delivery of the new infrastructure will be carried out by the respective developer in this area.

#### **Legal & Risk Implications**

There are no known legal or risk implications.

#### **Impact Assessment**

The general duties section of the impact assessment and the summary form has been completed. No negative impacts have been identified.

#### Consultation

Formal consultation required by the Roads Traffic Regulation Act 1984 for the TRO process will be carried out through the posting of legal notices in a local newspaper and on the affected length of roads. In addition, details of the proposed TRO will be made available on Fife Council's website.

## 1.0 Background

- 1.1 In March 2023 approval was granted for planning application 22/04316/RCC. This was for a residential development and associated infrastructure on the land west of Leslie cemetery.
- 1.2 The development comes off the A911 Kinross Road which is currently a 30mph road.
- 1.3 Adjacent residential streets have a 20mph speed limit in place.
- 1.4 The developer is also installing a toucan crossing on A911 Kinross Road as part of the development. A statutory notice will be issued in due course.

## 2.0 Issues and Options

- 2.1 Although the new residential roads are constructed to a design speed of 20 mph as part of their approved planning consent, we still require a Traffic Regulation Order (TRO) for the 20mph zone speed limit, which requires Area Committee approval.
- 2.2 New roads constructed (or soon to be constructed) on the land north of A911 Kinross Road Drawing No. TRO23\_30 (Appendix 1) require a TRO for the speed limit.
- 2.3 These new residential roads will be constructed to a design speed of 20 mph by means of road geometry and traffic calming features.

### 3.0 Conclusions

3.1 It is considered, in the interests of road safety, that this traffic restriction be promoted.



# **Supporting the Plan 4 Glenrothes Area: Community Recovery Fund**

Report by: Paul Vaughan, Head of Communities and Neighbourhoods Service

Wards Affected: 13,14,15

#### **Purpose**

To provide members with the necessary information to allocate funding for various projects from the Community Recovery Fund (CRF) for the Glenrothes Area.

#### Recommendation(s)

The Committee is asked to approve the following amounts from the Community Recovery Fund totalling £95,232.80:

- 1. Gingerbread Minis: £16,562.80
- 2. Cadham Neighbourhood Centre Access: £25,000
- 3. Milton of Balgonie Play Area: £20,000
- 4. Fife Big Hoose Hub Glenrothes Coordinator: £18,730
- 5. Glenrothes Against Poverty Partnership: LifeSkills Glenrothes: £14,940

#### **Resource Implications**

There are sufficient funds available in the Community Recovery Fund to support the submitted proposals.

This would leave a balance of £979,910 of the Community Recovery budget unallocated.

#### **Legal & Risk Implications**

There are no legal or risk implications based on this report.

#### Impact Assessment

An EqIA is not required because the report does not propose a change or revision to existing policies and practices.

There has been extensive consultation in the production of the Plan4Glenrothes Area.

Throughout 2022, a series of officer meetings reviewed the existing plan and established key priorities for Members consideration.

Monthly People and Place Leadership Group meetings were facilitated throughout the year up until November 2022 to support the review of the Plan for Glenrothes.

Elected Members attended a workshop in August 2022 focusing on one of the key priorities, 'Tackling Poverty in Glenrothes', that included briefings from key partners involved in the management and delivery of services aimed at tackling poverty related issues, such as welfare support and food and fuel crisis intervention.

A further Members workshop was facilitated in November on this theme, with the specific aim of discussing and seeking comment on potential projects that could be funded through the Community Recovery Fund.

Consultation with community groups and individuals throughout 2022 helped shape and gather support for the four key themes identified within the Plan.

Throughout 2023 consultation with partners across all sectors on the alignment with CRF and Plan4Glenrothes priorities has continued, facilitated by the People and Place Leadership group and the Glenrothes Against Poverty multi agency action group.

Elected members have taken part in three workshops to discuss CRF priorities, and the proposals presented in this report.

## 1.0 Background

- 1.1 On 25th August 2022, the Cabinet Committee agreed to allocate £10 million of revenue balances as a Community Recovery Fund. Further to this, the subsequent Cabinet Committee meeting on 22nd September approved the 'Help with Cost of Living: Extending Community Support' report which set out a general approach and criteria for the Fund, including the allocation of £9m across the seven Area Committees. Glenrothes Area has received an allocation of £1.303m as part of this allocation.
- 1.2 The specific criterion for the fund is as follows.
  - Projects should link to Local Community Plan priorities.
  - Projects should take account of Plan for Fife recovery priorities (Community Wealth Building, Tackling Poverty, Economic Recovery, Climate)
  - Projects should provide assessment of benefit to ensure no unintended consequences.
- 1.3 The Community Recovery Fund is available over a two-year period.

## 2.0 Project Summary Information

- 2.1 **Gingerbread Minis** seeks to deliver facilitator led play/learning sessions for young parents and their pre-school children, consisting of a variety of classes/activities across the week that they would ordinarily be unable to afford or have the confidence to attend. These activities will promote and seek to improve parenting skills, confidence and relationship building along with child development. This will help ensure that children who benefit from the project will enter nursery with a wide range of developmental opportunities equal to their peers.
- 2.2 **Cadham Neighbourhood Centre Access** will seek to upgrade the entry and exit to the centre, installing a wheelchair accessible door and entry point.
- 2.3 **Milton of Balgonie Play Area**: The main of the project is to improve current play facilities for the benefit of residents and visitors to the area. The play area is in the main open space within the village and nis the only play area there. The project was highlighted following a recent annual inspection as now nearing the end of its life and in need of refurbishment. The main unit within the play area has already been removed due to safety issues.
- 2.4 Fife Big Hoose Hub Glenrothes Coordinator: To oversee and coordinate the day-to-day activities of the dispatch hubs in NE Fife and Glenrothes, working closely with the statutory and voluntary sector to provide free essential household items to families in Northeast Fife and Glenrothes via an online referral system.
- 2.5 Glenrothes Against Poverty Partnership: LifeSkills Glenrothes: This project will enable participants to learn skills and gain confidence around everyday household tasks, such as cooking and home repairs & D.I.Y. Specifically, participation will encourage the development of skills and knowledge: cooking and food safety, minimising food waste and healthy eating within a budget; household skills such as re wiring a plug, hanging a shelf, hanging wallpaper, painting etc. Participants will be equipped with tools and devices required to carry out these tasks independently at home.

### 3.0 Conclusions

- 3.1 These proposals meet the broad criteria for the Community Recovery Fund. They also contribute to the 'Plan 4 Fife 2021-2024' and 'Glenrothes Area Local Community Plan' themes "Tackling Poverty" and "Supporting Positive Wellbeing".
- 3.2 The establishment of these projects will assist in developing a response to the cost-of-living crisis and post Covid recovery for individuals, families and communities across the Glenrothes Area. Learning gained from these projects will be used to influence and direct future service delivery across the area.
- 3.3 Approved proposal project leads will be required to submit robust evaluation on impact and outcomes within a timescale and framework agreed between Council Officers and Area Committee Members.
- 3.4 Approving these proposals will leave an allocation of £979,910 in the Community Recovery Fund to support other projects.
